**Introductions by Members, DSU Representatives and Guests**

Chairperson Carol Bergquist asked those attending the meeting to introduce themselves.

**Approval of Proposed Agenda of October 12, 2023 Meeting (Attachment 1)**

Todd Culver moved to approve the October 12, 2023, Proposed Agenda with suggested changes. Motion supported by Brent Mikulski. Motion was put to a voice vote with Chair Carol Bergquist calling for council members in favor to say aye and those opposed to state nay. There being a unanimous vote, motion carried. Proposed October 12, 2023, meeting agenda approved.

**Approval of August 10, 2023, Business Meeting Minutes (Attachment 2)**

The draft minutes of the August 10, 2023, meeting were provided to the council prior to the meeting. Chair Carol Bergquist called for any comments or suggested changes. The attendee list was corrected, and Karen Wang moved to approve the Minutes of the August 10, 2023, MCRS Meeting with suggested changes. Motion supported by Kathy Flagstadt. Motion was put to a voice vote with Chair Carol Bergquist calling for council members in favor to say aye and those opposed to state nay. There being a unanimous vote, motion carried. Minutes of the August 10, 2023, MCRS meeting are approved.

### **Resource Plan (Attachment 3)**

FY2023 Resource Plan report was presented by Steve Dalton, Fiscal Manager, Michigan Rehabilitation Services, and opened the floor for questions. No questions were raised regarding the FY2023 Resource Plan. However, a question was raised regarding the process for amending and reallocating resources to the FY2024. A discussion followed. Chairperson Carol Bergquist indicated that all proposals are required to be presented to the full council for consideration and require council approval.

Michigan Disability Rights Coalition – Kellie Blackwell reported information about the assistive technology program, including highlights about demonstrations and short-term loans of assistive technology equipment as well as trainings. The lending library now has more than 1,600 devices available for Michigan residents to use. The program is federally funded, and funding was

reauthorized in 2023. Representatives are available to schedule demonstrations.

### **DSU Updates**

Bureau of Services for Blind Persons (BSBP): Director Bill Robinson, Director, shared an update on BSBP activities, including the budget, migration to an e-case management system and employee hiring and onboarding activities, such as the creation of the BSBP Academy, a three-week intensive immersion for new hires, which includes training about the agency, culture, and objectives. Juan Ortiz highlighted FY23 accomplishments at the BSBP Training Center. Mike Pemble elaborated about the budget and explained about the agency's spending authority. Lisa Kisiel shared that the BSBP Excellence Awards will be November 15, 2023, at 10:00 a.m. This will be a virtual event. All are invited to attend. Further information will be sent to council members.

### **Public Comment**

Secretary Karen Schulz read the council guidelines for public comment. She called for public comment. There was no response. Public Comment concluded.

### **Continued Business Meeting:**

Bureau Michigan Rehabilitation Services (MRS) (Attachment 8 & 8a): Eric Bachmann, Division Director, reviewed the reports submitted by Michigan Rehabilitation Agency with the assistance of Steve Dalton, Finance Manager, reviewing the budget portion of the report. Further questions and discussion regarding pre-pandemic trends and how to reach those levels again, federal, and statewide goals (setting and tracking goals).

Eric also shared that the MRS Champion awards will be Thursday, October 19, 2023, at 2:00 p.m., at the Michigan Career and Technical Services. This will be an in-person event, no virtual option will be available. All are invited to attend. The Combined State Plan was also discussed. The council's role in Michigan's Combined State Plan will be to review the plan and provide recommendations. Further information regarding the plan such as the purpose, the process, timeline, etc., was also discussed.

A question was raised about the October 18, 2023, MRS Public Hearing regarding proposed changes to the Administrative Rules. MRS had shared this information at a previous orientation. This is a public hearing. Anyone interested in attending should contact Eric for further details of the meeting.

Carol reminded these members to submit their applications for reappointment if interested in continuing to serve.
