#### Welcome/Roll Call

Migrant Labor Housing Advisory Board Chairperson Hoganson opened the meeting at 1:00 p.m. with welcoming comments and a roll call of Board members in attendance.

#### Scope of Recommendations

MLH Advisory Board members discussed next steps the Board will take to continue its mission, objectives, and goals. Items to note:

- MLH Advisory Board members will use the model provided.
- The model will be distributed to MLH Advisory Board members for approval.
- Additional recommendations can be added, with MLH Advisory Board member approval.
- The MLH Advisory Board will convene to determine appropriate language use and clarify recommendations.
- All MLH Advisory Board members agreed to suspend meetings occurrences until after the current grow season.
- MDARD will take the lead and format formal recommendations.

# **Public Comment**

MDARD Deputy Director Rivet mentioned the potential to create a legislative/legal exemption (i.e., daycare centers) and/or special use permits for migrant labor housing exemptions.

Hector Arroyo mentioned H2A borders are increasingly within city limits that affects urban versus rural housing development regulations. The team discussed using the State Land Band and/or brownfield development properties for housing options.

Members discussed the REAL ID act impacting workers ability to obtain drivers licenses. Some H2A workers with valid driver licenses from their home residence working within other states may have reciprocity (e.g., Mexico and Michigan).
