2022/2023 Program Guidelines

The Michigan Department of Agriculture and Rural Development (MDARD) is offering a new grant opportunity to establish farm innovation projects. MDARD will accept proposals to develop and support innovative solutions to real, immediate, and future farm problems facing Michigan's food and agricultural industry. The grant funds are open to all in-state universities, colleges, community colleges, tech centers, technology incubators, and research centers.

Funding Areas:

The Farm Innovation Grant Program will develop and support innovative solutions to real, immediate, and future farm, agriculture processing, and supply chain problems facing Michigan's food and agricultural industry in the following priority areas:

- Climate Smart Practices
 - New innovative technologies that will work to mitigate the effects of climate change to Michigan commodities and lead to climate resiliency for the industry.

- Supply Chain Resiliency
 - Projects that strengthen and expand Michigan's food supply chain, including equipment, new technology, and research.
- Food Processing and Farm Production Automation
 - New innovative research and technology to assist with automation where finding labor to fill positions is a challenge.
- Rural Resiliency
 - Projects that strengthen the ability for rural communities to support farm and food processing.
- Other
 - Applicant will be asked to provide a description of the project funding area if it does not fit into a prior category.

Eligibility:

The grant funds are open to all in-state universities, colleges, community colleges, technology centers, technology incubators, and research centers.

Grant Criteria:

- All grant materials can be found at www.michigan.gov/mdardgrants.
- Grants will be awarded a **maximum amount of \$200,000**. Please submit applications in whole dollar amounts and round to the nearest \$100.
- Applicants must use the provided application form and all sections must be complete to be considered for review.
- All applicants must be registered as a vendor in the Vendor Self-Serve System with the State of Michigan prior to submitting an application. Registration can be completed here: <http://www.michigan.gov/SIGMAVSS>.
- This grant is a **cost-reimbursement** program. Grantees are responsible for costs until proper reports/invoices/receipts are received and reviewed.
- Grantees will be eligible for reimbursement up to three (3) times at specified dates, during the 24-month grant cycle, with the final reimbursement provided at the completion of the project.
- Each grantee will be required to submit written reports and appropriate financial documentation to MDARD for payment. Grantees may also be required to report on the outcomes and impact of their grant for a period of time (up to three years) after the grant period ends.
- Applications must be submitted via one email to mda-grants@michigan.gov by 3 p.m. (EST) on October 27, 2022. Include in the subject line the name of your organization. If you do not receive a confirmation of receipt from our office after 48 hours, please call 517-614-7065.

Grant funds **cannot** be used to pay for:

- Land acquisition
- Purchase of a building or facility
- Structural repair of building or facility
- Indirect costs are **not** allowed under this grant program. Indirect costs are defined as the expenses of doing business that are not readily identified within the project but are necessary for the general operation of the organization and the implementation of proposal related activities.
- Equipment installed outside of the State of Michigan.
- Acquisition costs of general-purpose equipment or lease agreements to own (i.e., lease-to-own or rent-to-own). *General Purpose Equipment* means equipment that is not limited to technical grant activities. Examples include office equipment and furnishings, modular offices, telephone networks, information technology equipment and systems, air conditioning equipment, reproduction and printing equipment, and motor vehicles.

Project Review:

Projects will be scored on a 100-point scale with a variety of factors, including, but not limited to:

- A well-defined and focused project purpose – 15 points
- Overall impact of the project on the food and agriculture industry in the state of Michigan – 25 points
- Meaningful, measurable, and realistic outcomes – 20 points
- Strong budget, expenditures correlate with the work plan and scope of the project – 10 points
- Comprehensive plan of work, containing appropriate activities for the project and strong partnerships – 15 points
- The long-term sustainability of the project and the near-term and long-term impact in solving innovation needs of the industry– 15 points

MDARD will convene a Joint Evaluation Committee comprised of individuals with an interest in, and knowledge about, Michigan agriculture, food systems, and farm innovation gap areas. The department will require some projects to prepare and present a project pitch on the proposed project. The committee will score proposals and make recommendations to the MDARD Director.

MDARD reserves the right, at its sole discretion, to reject an application if it:

- Does not meet the program requirements including scope, eligibility, and allowable grant dollar use.
- Is received after the deadline.
- Is incomplete or missing any of the required forms, narrative, and budget.
- Does not follow the outlined application requirements.
