**Product Information**

---

**Prowl H<sub>2</sub>O** is a selective herbicide for controlling most annual grass weeds and certain broadleaf weeds as they germinate. Refer to the **Prowl H<sub>2</sub>O** container label for a complete list of weeds controlled.

**Application Instructions**

---

**Prowl H<sub>2</sub>O** may be applied by ground or chemigation, or by air.

**Prowl H<sub>2</sub>O** may be applied to the following individual crops in the green onion crop subgroup: chive (fresh leaves), leek, onion (green), and shallot (fresh leaves).

**Use Methods and Timings**

For use only on green onions grown in muck soils, and mineral soils with greater than 5% organic matter.

Uniformly apply 3.0 to 4.0 pints per acre of **Prowl H<sub>2</sub>O** as a broadcast preemergence spray to the soil surface after seeding green onions.

Use lower rates on soils with less than 10% organic matter.

**Chemigation Application**

**Prowl H<sub>2</sub>O** may be applied through sprinkler irrigation systems. **DO NOT** irrigate in excess of 0.5 inch of water. Follow all directions, special instructions and precautions about chemigation in the **Spraying Instructions** section of the **Prowl H<sub>2</sub>O** container label.

**Restrictions and Limitations**

---

- **Green onion emergence may be slowed and stand reduced if cool or wet conditions occur after Prowl H<sub>2</sub>O application.**
- **DO NOT** apply if cold and wet conditions are expected to persist after green onion seeding.
- **DO NOT** apply more than 4.0 pints per acre per application.
- **DO NOT** apply more than 4.0 pints per acre per crop.
- **DO NOT** apply within 30 days before harvest.
- **DO NOT** feed forage or graze livestock in treated fields.
- **DO NOT** plant a second crop of green onions on the same acre in the same year if **Prowl H<sub>2</sub>O** was applied on the first green onion crop of the year.
- Tank mixes with **Prowl H<sub>2</sub>O** applied preemergence may increase risk of crop injury.
