 - Beginning with the Spring 2022 <u>General Collection</u>, a new characteristic (Additional Graduation Award) has been added to collect the additional award for on-track Early Middle College completers per <u>Public Act 47 of 2021</u>. When an EMC student is graduated with Exit Status code "40", the Additional Graduation Award is required.
 - o Details of this change are in the updated <u>MSDS Collection Details Manual</u>. Technical resources were shared in the <u>November 3 CEPI Announcements.</u>
 - o Mark all outcomes the student attained at the time of high school graduation
 - If a student attained more than one Associate Degree or attained a bachelor's degree at the end of the five-year program of study, please mark Associate degree and mark the 60 college credits.

Data Quality Reports – Dr. Stacey Stover, MDE

- Juniors coded after the fall certification date, should have a coding appeal submitted.
- It is not an option to code Seniors 3500 unless they are a transfer from another EMC.
- If an EMC student transfers to another EMC, do not remove the 3500 code from their record.
- If an out of state EMC student transfers to another EMC after the fall certification date of the Junior year, attain proof of participation in the out of state EMC and forward the documentation to MDE.
