Child Nutrition Programs (CNP) Bulletin No. 14 - Important Updates for Public Schools Participating in the Michigan School Meals (MSM) Program and National School Lunch Week (NSLW) - October 15, 2025

30d MSM State Aid Payment Schedule

The 30d MSM payment schedule has been changed to allow for additional processing time. Please see the revised schedule below. The September 2025 claims are due by October 24, 2025, for these claims to be in the November 20, 2025, payment.

MSM Coding for School Year 2025-2026

School Nutrition Program (SNP) accounting and coding for School Year 2025-2026 follows the traditional National School Lunch Program (NSLP) coding. However, as a reminder, with the addition of MSM (30d funding) there is also state grant coding needed for breakfast and lunch. Our coding chart is updated and available on our Fiscal and Administrative Services Team Fiscal Reporting webpage.

Reimbursement for Meals from October 1, 2025, through October 7, 2025

If your district charged reduced-price and paid eligible students for meals October 1, 2025, through October 7, 2025, you must have documentation on file for the following:

- That meal payments were credited to student accounts or refunded to families. The credits can be used for future a la carte purchases.
- Any student meal debt has been addressed appropriately. This is necessary for participation in the MSM program. More details can be found in the resource Student Meal Debt Write Off Information.

Community Eligibility Provision (CEP) Schools and Education Benefit Forms

^{**} Last date to submit monthly claim before considered late.

For the rest of the 2025-2026 school year, CEP schools must only use <u>Education</u> <u>Benefits Forms</u> for determining student income eligibility. <u>Education and Nutrition</u> <u>Benefits Applications</u> should only be used for non-CEP (traditional claim) schools.

However, in the case of a CEP school where preschool meals and snacks are claimed through the Child and Adult Care Food Program (CACFP) those must be claimed by free, reduced-price, and paid status. Therefore, sponsors must collect Education and Nutrition Benefits Applications for preschool students eating CACFP meals and snacks (not the CEP Education Benefit Forms).

Preschool Meals Claimed in the MSM

The Office of Nutrition Services (ONS) has updated the memo titled <u>Frequently</u> <u>Asked Questions Related to MSM for Preschool Programs</u>. The memo clarifies that 3- and 4-year-old age preschool children may have their meals reimbursed through the NSLP and MSM.

A new joint memo between MDE and the Michigan Department of Lifelong Education, Advancement, and Potential (MiLEAP) <u>clarifies family style meals</u>. The memo is for school food service staff and school business officials.

SNP has updated the <u>Michigan School Meals Comparison Chart</u> resource and it is available on our webpage.

Additional Language in the Fiscal Year 2026 State School Aid Budget Section 30d

The Office of Nutrition Services (ONS) values the inclusion of Michigan grown produce in all our Child Nutrition Programs. We thank those sponsors that have made it a priority to offer Michigan grown fruits, vegetables, and beans in your meals. The final signed Fiscal Year 2026 State School Aid Budget included the following new language in Section 30d Participating sponsors are encouraged to purchase food from Michigan growers when possible and practical. We appreciate the additional language and encourage all sponsors to make Michigan produce a priority.
