

MiLogin for Third Party

- All application users must have a MiLogin for Third Party account with MEIS Link and requested access to NexSys
- Just because you have the NexSys link in your MILogin, DOES NOT mean you have access to the NexSys system.





Level 5 Users

 MEGS+ Level 5 users were transferred to the NexSys system.

- Level 5 users must:
 - -Initiate and submit the application
- add other application users to NexSys.
- There are only two Level 5 users for each sponsor


- How to find your current MEGS+ user level:




