Michigan School Grades Reports Publicly Available

The Michigan Department of Education (MDE) will make 2020-21 Michigan School Grades reports publicly available on [MI School Data](http://www.mischooldata.org) (www.mischooldata.org) **Friday, November 19, 2021**. The Michigan School Grades System is an accountability system that was signed into law in late 2018. In this system, schools receive up to five letter grades and three ranking labels based on various school performance components. Schools do not receive an overall letter grade.

Results will be available this Friday on [MI School Data](http://www.mischooldata.org) (www.mischooldata.org). At that time, the embargo on sharing these results will be lifted.

Benchmark Assessments Reporting and Funding Application Reminder

Earlier this week districts were advised the [2021-2022 Benchmark Assessments Reporting and Funding Application form](#) is now available through the Grant Electronic Monitoring System/Michigan Administrative Review System (GEMS/MARS). Districts may also access this form from the Michigan Department of Education's [MDE Benchmark Assessments web page](#) in the What's New section.

This form will survey districts on assessments used, help with reporting requirements, and provide an avenue to apply for funding for eligible MDE-approved assessments (i-Ready, STAR, and NWEA).

The deadline for completing the form is **Friday, December 10, 2021 at 5:00 p.m.** All public districts and ISDs with enrolled students in grades K-8 must complete the form.

Districts that administered benchmark assessments from the MDE-approved provider list (Curriculum Associates i-Ready, NWEA Map, Renaissance Star, and/or the Smarter Balanced Interim Assessments in grades 3-8 and/or the MDE Early Literacy and Mathematics Assessments in grades K-2 offered through DRC) must report assessment data through the Michigan Data Hub (MiDataHub) by **December 10, 2021**. To meet this deadline, all integrations and permissions must be in place no later than **November 19, 2021**.

To verify the integrations and permissions are set up, districts may follow these three steps:

1. Ensure the [Return to Learn Aggregation](#) integration has been completed or is still active from the 2020-21 submission in the MiDataHub cockpit.
2. Verify one or more of the five MDE-approved assessments above have been configured in the MiDataHub cockpit
3. Ensure 2021-22 data has been published from the Student Information System (SIS). If your district uses a SIS not capable of integrating with MiDataHub, please contact support@midatahub.org for further assistance.

Pre-Identification for SAT, PSAT, WorkKeys, M-STEP, and MI-Access

The Office of Educational Assessment and Accountability (OEAA) will pre-identify public school students (grades 3-11) for testing in the OEAA Secure Site, using the Fall 2021 MSDS General Collection and Student Record Maintenance (SRM) files submitted through **5:00 p.m. on December 31, 2021**. SRMs are not required but will be used if they have been submitted. The Pre-ID Student Report will be available at **8:00 a.m. on January 5, 2022**.

The following students will be pre-identified:

- All students in grades 3-8 and 11 will be pre-identified for M-STEP.
 - » Students will be pre-identified as online testers unless they are enrolled in a school with an approved online waiver. Students in approved paper/pencil schools will be pre-identified for paper/pencil testing.
 - » Individual students in online schools who require a paper/pencil test may be reassigned for paper/pencil testing. Refer to the document Changing the Mode (online, Paper/Pencil) of Testing for Students, found in the **Pre-Identification of Students section** on the [Secure Site Training web page](http://www.michigan.gov/securesitetraining) (www.michigan.gov/securesitetraining).
 - » Since participation in the MI-Access assessments is based on a student's Individualized Education Program (IEP), schools are expected to move such students from the M-STEP to MI-Access Functional Independence (FI), Supported Independence (SI), or Participation (P) assessment, as appropriate. Refer to the article Pre-ID for MI-Access on the following page for more information.
- All students in grades 8, 9, and 10 in established PSAT schools will be pre-identified for PSAT 8, PSAT 9, or PSAT 10 test cycles.
 - » When the PSAT 8/9 and PSAT 10 is not appropriate for a student based on the student's IEP, the student is to be unassigned from the assessment by **5:00 p.m. on February 16, 2022** to prevent additional materials from being sent.
 - » There is no alternate assessment to the PSAT 8/9 for grade 9 or PSAT 10. Students in grades 9 and 10 whose IEP indicates the PSAT is not appropriate will be exempt from testing and are to be unassigned in the Secure Site. Grade 8 students are to take the PSAT 8/9 or one of the MI-Access assessments for English language arts and mathematics, based on their IEP.
 - » The PSAT 8/9 is one test that is administered to both grades 8 and 9. However, in the OEAA Secure Site, the test cycle is split into two, PSAT 8 and PSAT 9.
- All students in grade 11 in established SAT and ACT schools will be pre-identified for SAT and WorkKeys.
 - » The "Who Must/Can Take the MME?" guidance is currently being updated for Spring 2022. Once it is available, check for guidelines on MI-Access students' ability to take the SAT and WorkKeys. The guidance can be found on the [MME web page](http://www.michigan.gov/mme) (www.michigan.gov/mme) under General Information.
 - » Schools are to unassign students who will be taking a MI-Access assessment from the SAT test cycle by **5:00 p.m. on February 16, 2022**. This process also holds true if a student chooses not to take the ACT WorkKeys along with MI-Access. This will prevent additional materials being sent to the school.

There is a one-time pull from MSDS for pre-identification purposes for students taking the SAT, PSAT, WorkKeys, and M-STEP. Starting **January 5, 2022**, it is the responsibility of the district and/or school to update the Pre-ID Student Report directly on the OEAA Secure Site, by unassigning students who will not be testing and adding new students who will be testing.

All initial standard materials for SAT, PSAT, WorkKeys, M-STEP, and MI-Access, as well as barcode labels printed by the contractors, will be based on students who are pre-identified on the OEAA Secure Site by **5:00 p.m. on February 16, 2022**. To ensure schools get the appropriate number of assessment materials, it is important to make sure the pre-identification is accurate by **5:00 p.m. on February 16, 2022**. MME and PSAT 8/9 for Grade 8 – Important Information

When pre-identifying new students to the Michigan Merit Exam (MME), students must be pre-identified to each assessment (SAT, WorkKeys, and M-STEP science and social studies) separately. Grade 8 students must be pre-identified to the PSAT 8 and M-STEP or MI-Access for social studies and science.

Once a student is pre-identified to one of the assessments, the Mass Update Assessments page can be used to easily copy them over to the other assessment(s). OEAA will pre-identify students to the required assessments, so this only applies to students pre-identified by the school or district starting January 5, 2022. Instructions specific to this task for either MME or grade 8—in the document Copy Students from One MME Component to other MME Components for Pre-Identification—can be found on the [Secure Site Training web page](http://www.michigan.gov/securesitetraining) (www.michigan.gov/securesitetraining) under Mass Update Assessments in the Pre-Identification section.

Pre-Identification for MI-Access

MI-Access is Michigan's alternate assessment, and is designed for students who have, or function as if they have, significant cognitive impairments, and whose IEP team has determined that general assessments, even with accommodations, are not appropriate.

Since the Office of Educational Assessment and Accountability (OEAA) cannot determine which students will test using the MI-Access Functional Independence (FI), Supported Independence (SI), or Participation (P), all students will be pre-identified to M-STEP by the OEAA during the pre-identification pull from MSDS. Starting January 5, 2022, districts and/or schools can begin moving students from M-STEP to the appropriate MI-Access assessment and pre-identifying any additional MI-Access students in the OEAA Secure Site.

To ensure students are not inadvertently tested in both MI-Access and M-STEP, students must be unassigned from M-STEP. If a student is taking a mix of MI-Access and M-STEP, you can unassign contents from an assessment record. This can be done for a group of students at the same time using the Mass Update Assessments function on the OEAA Secure Site.

Pre-Identification for Winter 2021 M-STEP Online Passage-based Writing Field Test Grades 3–8

Schools that are participating in the M-STEP Online Winter 2023 Passage-based Writing Field Test (grades 3-8) can start to pre-identify students on the OEAA Secure Site now. Since this field test is optional, OEAA will not pre-identify any students. Schools will be responsible for pre-identifying all participating students directly on the OEAA Secure Site using any of the following methods:

- MSDS Copy Function
- Pre-ID File Upload
- Student Search – one student a time

Students will NOT be put into online test sessions on the OEAA Secure Site. Schools will have access to manage student data and create online test sessions in the DRC INSIGHT Portal starting December 10, 2021.

Students newly pre-identified on the OEAA Secure Site will be transferred to the DRC INSIGHT Portal three times a day through February 4, 2022. Winter Early Literacy and Mathematics Benchmark Assessments (K-2)

Just a reminder that OEAA has pre-identified students who took the Fall 2021 Early Literacy and Mathematics Benchmark Assessments for the Winter Early Literacy and Mathematics Benchmark Assessments on the OEAA Secure Site. 2021-22 Sending Scores Back Program for Shared Educational Entities (SEEs and S2E2s) Applications Available Now

Intermediate School Districts (ISDs), consortia, or other partnering districts may wish to apply to participate in the “Sending Scores Back” Program for school accountability reporting. Eligible schools and classroom programs provide: alternative education, early/middle college education, gifted and talented education, or special education services to neighboring or consortium districts.

The Sending Scores Back Program provides the ability to have non-resident student assessment results and non-resident student graduation statuses redirected in school accountability reporting to another school in a student’s own district of residency. **Note:** Public school academies (PSAs) are not eligible for this program as PSAs do not have resident district boundaries in the same way traditional districts do.

Applying for the Sending Scores Back Program will designate your school building or classroom program as a Shared Educational Entity (SEE) or Specialized Shared Educational Entity (S2E2). That status is then used during submissions in the Michigan Student Data System (MSDS) to identify students to be processed specially in school accountability reporting. Students identified in these schools/programs are then attributed back to a school building identified in their resident school district for the purposes of school accountability calculations.

Shared Educational Entities (SEEs) and Shared Specialized Educational Entities (S2E2s) that participated in the Sending Scores Back Program in a prior school year will need to reapply to reestablish their status as a SEE or S2E2 in the Sending Scores Back Program for 2021-2022 school accountability results expected in fall of 2022.

This building-wide paper/pencil testing option is available to school buildings that may never be able to test online, such as buildings with no internet access, juvenile justice facilities that do not allow students online, or some center-based special education programs.

2022 Michigan School Testing Conference

The 2022 Michigan School Testing Conference (MSTC) will be held virtually on February 22-24, 2022. In planning for the 2022 conference, the feasibility of an in-person conference was carefully considered. Given potential restrictions (or even bans) on large-group gatherings and the available space for "social

distancing" at the hotel (Sheraton Ann Arbor, where the conference was held in the past), in the end the decision was made to offer the 2022 MSTC in a virtual-only format, as was the case for the 2021 conference.

The annual Michigan School Testing Conference consists of a day for workshops and two days of plenary and clinic sessions:

- On **Tuesday, February 22, from 9:00 a.m. to 12:00 p.m. and 1:00 to 4:00 p.m.**, eight half-day and one full-day workshops will be offered. Login begins at 8:00 a.m.
 - » Eight half-day workshops
 - » One full-day workshop
- The conference itself takes place on **Wednesday, February 23, from 9:30 a.m. to 4:30 p.m.**, and continues through **Thursday, February 24, from 9:30 a.m. to 4:00 p.m.** There will be 37 clinics and three keynote presentations offered.
 - » Margaret Heritage (Educational Author/Consultant) and Andy Middlestead (Michigan Department of Education) will be the keynote speakers on Wednesday, February 23.
 - » Suzanne Lane (University of Pittsburgh) will be the keynote speaker on Thursday, February 24.

A daily registration fee to cover access to all presentations for each day is being offered again this year.

Student Self-Assessment: An Essential Component of the Formative Assessment Process

Self-assessment is an essential part of the formative assessment process, which is “a planned, ongoing process used by all students and teachers during learning and teaching to elicit and use evidence of student learning to improve student understanding of intended learning outcomes and support students to become self-directed learners” (CCSSO FAST SCASS, 2018).

When students and teachers engage in the formative assessment process, a feedback loop is created. The feedback loop provides actionable evidence of learning to the teacher so adjustments in instruction can be made, and provides information to the student so they can take active steps to move their own learning forward (Heritage, 2011).

Self-assessment, or the process through which students gather information and reflect on their progress in relation to a clearly defined learning target is the second part of the feedback loop (What is Self-Assessment?, 2020). The image below shows the Formative Assessment Feedback Loop.

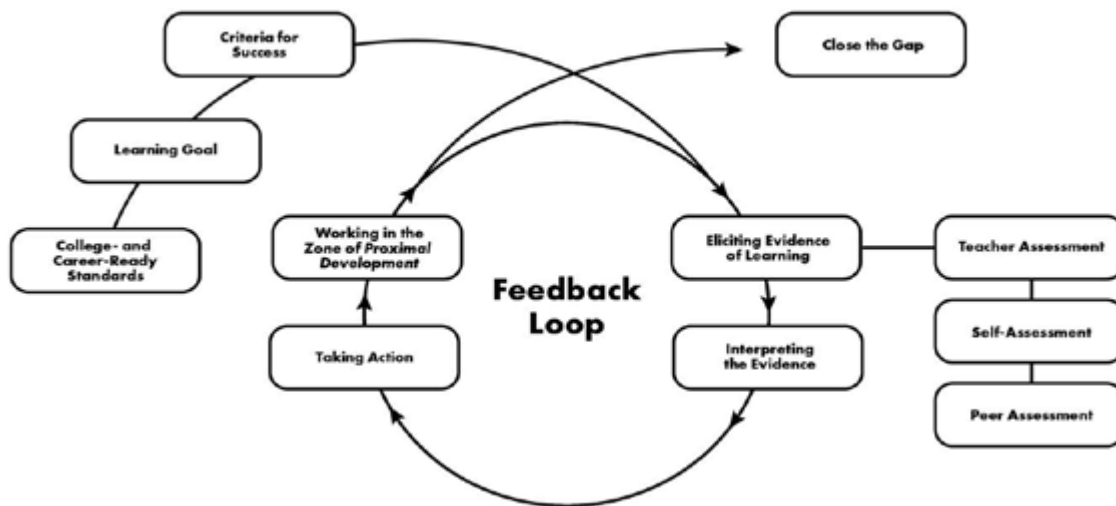


Figure 1: Formative Assessment Feedback Loop (Heritage, 2021)

Through the three-part process of self-assessment, students will:

- come to know and understand the learning target
- evaluate the quality of their thinking and performance to monitor their current position and progress toward the learning target,
- acquire the knowledge, strategies, and skills to close the gap between their current position and the desired performance

In order for students to successfully self-assess, their teachers have to provide explicit instruction and model self-assessment strategies. In addition, for students to become aware of and advance toward the learning targets, teachers must

- make clear the success criteria that will be used for evaluation of students' work
- model how the success criteria is to be used
- provide ample opportunities for students to practice using the criteria to assess their work
- allow students time to reflect and help them to take the steps necessary for improvement (What is Self-Assessment?, 2020)
- avoid using self-assessment to count towards a grade or points earned, which could create a negative effect over time (Andrade & Valtcheva, 2009).

Self-assessment can benefit students in the short term by helping them to improve performance on a particular assignment or task, and in the long term by helping them to develop powerful habits of self-regulated learning (Andrade & Valtcheva, 2009).

Fall 2021 Invoice Generation Process

Although the Michigan Department of Education (MDE) is providing the Fall 2021 SAT, PSAT/NMSQT, and PSAT 8/9 for Grade 9 administrations to eligible students and schools, it is important that schools complete the invoicing process in the College Board test ordering site (TOS) to avoid fees being billed to the school. Schools can use this process to change the grades that students indicated on their answer sheets, if needed. Remember: Invoices sent to schools that did not correct ineligible student grade levels in the TOS during the invoice generation process will not be waived. The school will be responsible for paying those invoices.

Completing Manage Participation

The ACT WorkKeys assessment is one of three required components of the Michigan Merit Exam (MME) for grade 11 and eligible grade 12 students. All public schools are required to administer the full MME, which consists of the ACT WorkKeys, SAT, and M-STEP science and social studies assessments.

If a nonpublic school chooses to administer any one of the three MME components to their students, they are expected to administer all three components.

Each school's WorkKeys Test Coordinator must indicate the school's participation status—either Participating or Not Participating—in the PearsonAccess^{next} website during the Manage Participation window, **by December 3, 2021, regardless of previous participation.** If your school will participate in the WorkKeys assessments in Spring 2022, you must also select your preferred test materials receipt week. This process will take approximately five minutes.

Note: Manage Participation must be completed at the individual school level, not at the district level, even if the school is not participating. Reminder emails will be sent periodically to all schools that have not completed the Manage Participation process.
