Per the guidance from the Michigan Department of Education, 10 of our students that would have taken the Mi-Access assessment opted out of testing during the Coronavirus Pandemic. The parent decision to opt out of assessments would have adjusted our rate of participation in both the total number of students assessed as well as the number of students being assessed with the alternate assessments.

Mt. Pleasant Public Schools runs the center based programs for the students in Isabella County in connection with Gratiot Isabella RESD. Based on the students cognitive levels, academic abilities and the determination of the IEP team these students meet the criteria to take the Mi-Assess assessment. The students in these programs are added to our total numbers which increases the percentage of students taking the alternate assessment in Mt. Pleasant Public Schools.
