The students are working toward MI Alternate Content Standards. Using the MDE Interactive Decision Tool, IEP teams determined the alternative assessment is the most appropriate for students taking an alternative assessment. The students have significant disabilities that affect their adaptive function. The students also require extensive individual instruction and support. Multiple measures have shown that the student cannot show learning using the general assessment.
