OEAA Secure Site Role and Assessment Descriptions

Below is a list of roles with descriptions of access available to users in the OEAA Secure Site. The roles that are used specifically to access DRC INSIGHT Portal and WIDA AMS can be found starting on page 4.

A list of the state assessments and descriptions that can be requested or assigned to a user starts on page 5.

Access to the OEAA Secure Stie is requested through the OEAA Secure Site using MiLogin for Business. Directions on how to request access, along with required forms to be submitted, can be found at How do I get access to OEAA Secure Site.

Administrator Level Roles

Administrator roles allow the district and schools to manage access on the OEAA Secure Site along with accessing all functions. Each district should have one or more administrator level users. There is no limit to how many administrator level roles can be granted within a district or school.

District and Nonpublic School Administrator level user request are submitted to OEAA and will be processed within one to two business days. Two forms are required to be submitted with the request on the OEAA Secure Site. Use the link above to access the required form and directions.

The Public School Administrator is submitted to the district administrator and time for processing will vary based on their process.

DRC INSIGHT Portal and WIDA AMS Access

Some functions for the online M-STEP, MI-Access and Early Literacy and Mathematics are completed in the DRC INSIGHT Portal which is a vendor's system. Some functions for the WIDA ACCESS and WIDA Alternate ACCESS are completed on the WIDA AMS, which is a vendor's system. Access to each of these systems is granted through a role on the OEAA Secure Site.

The roles listed below will only allow users access to the DRC INSIGHT and/or WIDA AMS systems and will not allow any access to the OEAA Secure Site. If access is needed to the OEAA Secure Site, an additional role as listed above would need to be added.

Selection of the assessments in the request and approval process will determine access to either DRC INSIGHT and/or WIDA AMS. If M-STEP, MI-Access, or Early Literacy and Mathematics is selected, access will be given to the DRC INSIGHT Portal. If WIDA Screener or WIDA ACCESS is selected, access will be given to the WIDA AMS.

As mentioned above, the District Administrator, Public School Administrator and Nonpublic School Administrators roles are automatically given access to WIDA AMS and DRC INSIGHT Portal and do not need one of the roles listed below.

| ACT | The ACT was used by the state up through Spring 2015 as the required college entrance exam. | |
| Early Literacy | Early Literacy is an optional benchmark assessment for grades K-2 given in the fall, winter, and spring. | |
| EL Screener | This is the parent assessment to WIDA Screener and W-APT. When selecting EL Screener, WIDA Screener and W-APT will both be selected. You can deselect one or the other if it's not appropriate for the user. | |
| ELPA | English Language Learner Proficiency Assessment was used to test the proficiency of English language learners up through Spring 2013 prior to the use of the WIDA. If a user needs access to past ELPA reports and scores, the user will need the ELPA assessment included in their access. | |
| ELPAS | English Language Learner Proficiency Assessment Screener was used to assess students for possible English language learner designation up through Spring 2013 prior to the use of the W-APT. If a user needs access to past ELPAS reports and scores, the user will need the ELPAS assessment included in their access. | |
| MEAP | Michigan Educational Assessment Program was the standardized test used to assess students in grades 3–9 through fall 2013 and grade 11 through Spring 2008. Even though the MEAP is no longer used, a user would need access to the MEAP to access any historic MEAP data. | |
| MEAP-Access | MEAP-Access was used to assess students with disabilities up through Fall 2013. Even though the MEAP-Access is no longer used, a user would need access to the MEAP-Access to access any historic MEAP-Access data. | |
| MI-Access | MI-Access is used to assess students with disabilities grades 3–8 and 11 and is the parent to MI-Access Functional Independence (FI), MI-Access Participation (P) and MI-Access Supported Independence (SI). If given only access to MI-Access without giving access to FI, P and SI, the user would only be able to order materials and not assign or unassign students for testing. It is best to give access to MI-Access along with FI, P and/or SI. | |
| MI-Access FI | MI-Access Functional Independence (FI) is used to assess students with disability in grades 3–8 and 11 and the parent assessment is MI-Access. If given only MI-Access FI, the user will not be able to access reporting or order materials. It is best to also give the user access to MI-Access. | |
| MI-Access P | MI-Access Participation (P) is used to assess students with disability in grades 3-8 and 11 and the parent assessment is MI-Access. If given only MI-Access P, the user will not be able to access reporting or order materials. It is best to also give the user access to MI-Access. | |
| MI-Access SI | MI-Access Participation (SI) is used to assess students with disability in grades 3–8 and 11 and the parent assessment is MI-Access. If given only MI-Access SI, the user will not be able to access reporting or order materials. It is best to also give the user access to MI-Access. | |

| MME | Michigan Merit Examination is the standardize assessment for grade 11 and eligible grade 12 assessment that was used through Spring 2014. Even though the high school assessment is still called the MME, it is no longer a single test selection on the OEAA Secure Site. Even though the term MME is no longer used on the OEAA Secure Site, a user would need access to the MME to access any historic MME data. |

| M-STEP | Michigan Student Test of Educational Progress replaced the MEAP for grades 3-8, 11 and eligible grade 12 as the standardized assessment in spring 2015. |
| PSAT 10 | The PSAT 10 is a College Board product that is given to grade 8 students as part of the state assessments. Users responsible for Secure Site activies for PSAT 10 will need access. |
| PSAT 9 | The PSAT 9 is a College Board product that is given to grade 8 students as part of the state assessments. Users responsible for Secure Site activies for PSAT 9 will need access. |
| PSAT 8 | The PSAT 8 is a College Board product that is given to grade 8 students as part of the state assessments. Users responsible for Secure Site activies for PSAT 8 will need access. |
| SAT | The SAT replaced the ACT in spring 2016 as the state's college entrance examination for grades 11 and eligible grade 12. |
| W-APT | The WIDA-Access Placement Test replaced the ELPAS after Spring 2013 and was used to assess students for possible English language learner designation in grades K-12. As of Fall 2017, W-APT is available for kindergarten and first semester 1 st graders only. EL Screener is the Parent test cycle for W-APT and WIDA Screener. |
| WIDA | The WIDA replaced the ELPA in Spring 2013 to test the proficiency of English language learners in grades K-12. This is the full English language test that is given in the spring. This is not a screener. |
| WIDA Screener | The WIDA Screener is given to students in grade 1-12 throughout the year as needed to assist in determining if a student is an English learner (EL). This was new for fall 2017. The EL Assessment test cycle is the parent test cycle for WIDA Screener and WAPT. |
| WorkKeys | The WorkKeys is the state's required work skills assessment test for grades 11 and eligible grade 12. |
