Overview of the ACT WorkKeys Assessments

Even though the Spring 2025 administration of the ACT WorkKeys assessment is many months away, you can begin preparing now through an understanding of what the WorkKeys assessments are and how to prepare your students to take them.

The ACT WorkKeys assessment consists of three tests that measure real-world skills employers consider critical to job success and that increase career opportunities for students who do well on the assessments. The tests are:

- Applied Math measures critical thinking, mathematical reasoning, and problem-solving techniques for actual situations in today's workplace
- Graphic Literacy measures skills needed to locate, synthesize, and use information from charts, graphs, diagrams, and other materials
- Workplace Documents measures skills needed to read and use written text such as memos, letters, directions, bulletins, and policies

How a student performs on the three WorkKeys tests determines their eligibility to earn an ACT[®] WorkKeys[®] National Career Readiness Certificate[®] (NCRC). To earn a certificate, students must receive a level score of at least 3 of 7 on each test. Certificates are awarded at four levels:

- Bronze requires a minimum level score of 3 of 7 on all three tests
- Silver requires a minimum level score of 4 of 7 on all three tests
- **Gold** requires a minimum level score of 5 of 7 on all three tests
- Platinum requires a minimum level score of 6 of 7 on all three tests

Students who complete the Spanish-language versions of the assessments are eligible for an NCRC en Español.

Students who earn an NCRC can activate and print the certificate at no charge at <u>http://www.mywork-</u> <u>keys.com</u> once they receive their paper scores.

Spring 2025 Test Dates

The spring 2025 test dates are:

- Test Window 1: Standard Time: March 27, 2025 Accommodations: March 27 – April 9, 2025
- Test Window 2: Standard Time: April 10, 2025 Accommodations: April 10 – 23, 2025
- **Test Window 3:** Standard Time: April 24, 2025 Accommodations: April 24 – 30, 2025

Schools may select either Test Window 1 or Test Window 2 for initial testing, then use Test Window 3 for all makeup testing. More information will be provided in future Spotlight newsletters.

Standard Time Testing

Students who require no special test forms or English learner (EL) supports will test using a standard time form. Each standard time English assessment is 55 minutes, and each standard time Spanish assessment is 70 minutes. REMINDERS

Accommodations Testing

Students with disabilities and/or those identified as ELs can test using accommodations and/or accessibility supports that are not intended to help the students academically during testing, but instead make interaction and communication possible and fair for every student.

The test coordinator should work with a student's Individualized Education Program or 504 team, as well as with the student's EL educators, to determine which students qualify for ACT-allowed accommodations and supports. Students who will use accommodations and/or accessibility supports during testing must have prior experience using these tools in their regular learning. The test coordinator must retain documentation verifying that the use of an accommodation/accessibility support matches an identified need and is effective for the individual.

The accommodations forms available in English are:

- extended time (time-and-a-half, double time, triple time, and multi-day testing)
- large type
- prerecorded audio (via a secure URL)
- UEB Braille
- reader script

The accommodations forms available in Spanish are:

- standard time
- extended time (time-and-a-half, double time, triple time, and multi-day testing)
- large type
- American Spanish Braille
- prerecorded audio (via a secure URL)
- reader script

For guidelines on identifying students who might benefit from taking the tests in Spanish, refer to the <u>MDE Supports and Accommodations Guidance Document</u> (https://www.michigan.gov/documents/mde/Michigan_Accommodations_Manual. final_480016_7.pdf).

A prerecorded audio form for Arabic-speaking students is available via a secure URL.

ACT also offers printed translated test directions in Arabic, Chinese Simplified, Chinese Traditional, French, German, Haitian Creole, Korean, Russian, Somali, Spanish, Tagalog, and Vietnamese languages. The <u>WorkKeys-Translated Test Directions for English Learners</u> (https://www.act.org/ stateanddistrict/michigan) is available on the ACT state testing website, on the **WorkKeys on Paper** page under **Step 3: Accommodation**.

The accommodations forms and the Arabic-language prerecorded audio must be ordered through the Office of Educational Assessment and Accountability's <u>OEAA Secure Site</u> (www.michigan.gov/oeaa-secure), from **January 6 through February 14, 2025**. Students may also benefit by testing with accessibility supports; these include:

- individual testing
- testing in small groups
- testing with interpreters, readers, or transcribers
- seating at the front of the room
- using a left-handed desk
- use of an ACT-approved word-to-word bilingual dictionary without definitions
- locally provided verbal translation of test directions

Examples of ineligible modifications – those that change what the tests measure and will result in non-reportable scores to schools and students – include:

- \cdot ~ use of dictionaries with word definitions
- use of any word-to-word dictionary not approved by ACT – refer to the <u>ACT-Autho-</u> <u>rized Bilingual Word-to-Word Dictionaries List</u> (https://www.act.org/content/dam/act/unsecured/documents/ACT-ApprovedBilingualDictionariesList.pdf)

Student Preparation – Go for Platinum!

Encourage your students to get an understanding of the types of questions they will see on WorkKeys assessment, since this assessment is different than other types of exams. Students and teachers can access <u>free practice questions</u> (https://www.act.org/ content/act/en/products-and-services/workkeysfor-job-seekers/preparation.html) from all three tests, ranging from easier content (Level 3) to the most difficult (Level 7). Teachers and students may use these practice questions in the classroom as "Questions of the Day" or as warm-up activities in the weeks leading up to test day.

Students can also create a WorkKeys user account and take <u>free full-length online practice tests</u> (https:// testregistration.org/rsp/Login.do?event=go&realm=20770563). This allows students to pace themselves in real-time test scenarios and receive scores indicating how they would perform on the WorkKeys tests.

WorkKeys Test Coordinators can share the brochure <u>How WorkKeys Assessments Can Work For You</u> (https://www.act.org/content/dam/act/unsecured/ documents/How-WorkKeys-Assessment-Can-Work-For-You-Brochure.pdf) with their students, to increase their understanding of how to achieve an NCRC and how to use it after graduation.
