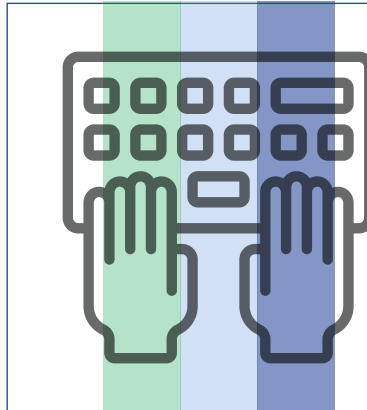

M-STEP Test Administration Manual Available Now

The 2023 M-STEP Test Administration Manual (TAM) is now available on the [M-STEP web page](http://www.michigan.gov/mstep) (www.michigan.gov/mstep) under the **What's New** and **Current Assessment Administration** sections. This manual is an essential resource for a successful test administration and contains the information you need to know about required test administration policies and procedures.

The M-STEP TAM includes several new appendices to help you prepare for and administer the M-STEP assessments:

- **M-STEP Calculator Policy** – provides information about allowable use of calculators
- **M-STEP Scratch Paper Policy** – provides information about allowable use of scratch paper
- **Electronic Device Policy** – this new policy document provides information about test administration requirements related to student and staff electronic devices; it is also available in the Assessment Integrity Guide and Test Administrator's Directions and Manual documents
- **Active Monitoring Best Practices** – a new appendix that includes best practices, acceptable practices, and prohibited practices for Test Administrators as they actively monitor test administration

- **Incident Reporting Guide** – provides information about potential test irregularities and how to respond if any occur in your school or district
- **How to Complete an Incident Report** – provides important information about details to be included when submitting an incident report and links to required documentation
- **Tests Requiring Headphones** – this flowchart clarifies which tests require headphones
- **DRC Test Monitoring Application** – this revised and updated appendix provides essential information about how to set up and use the Test Monitoring Application in the DRC INSIGHT Portal; includes screenshots along with detailed directions
- **M-STEP List of Important Dates** – the PDF version of the M-STEP list of important dates; use this to ensure you meet all required deadlines
- **DRC INSIGHT Portal User Guide** – a brief appendix with a link to the DRC INSIGHT Portal User Guide
- **M-STEP Test Administration Resources** – lists important resources for use throughout the test administration
- **Checklists – Before, During and After Testing** – checklists for Assessment Coordinators to use as they complete required tasks during each stage of testing: before, during, and after test administration
- **Test Administrator Test Session Checklist** – a new checklist for use by Test Administrators during a test session to verify all tasks are completed (based on a document originally created by educators in Godwin Heights Public Schools)
- **Assessment Integrity and Security for Test Administrators** – a new appendix provides important assessment security information; Test Administrators can read this appendix to fulfill the assessment security training requirement (also available in the Assessment Integrity Guide and in each Test Administrator’s Directions and Manual document for all grades and test modes)

Assessment Coordinators in schools with regularly scheduled instructional hours before 7:00 a.m. or after 4:00 p.m. who plan to use INSIGHT for testing purposes outside of the regular availability hours of 7:00 a.m. to 4:00 p.m. must fill out and submit the [Alternate INSIGHT Availability Request Form](https://forms.office.com/g/DitmNcLYxu) (https://forms.office.com/g/DitmNcLYxu) that is now available on the [M-STEP web page](http://www.michigan.gov/mstep) (www.michigan.gov/mstep) and the [MI-Access web page](http://www.michigan.gov/mi-access) (www.michigan.gov/mi-access), under the **What's New** and **Current Assessment Administration** sections.

MI-Access 1% Cap Justification Form Feedback

Feedback from the Michigan Department of Education (MDE) to Intermediate School District (ISD) Special Education Directors and Monitors has begun being sent in the Catamaran system. ISD Directors and Monitors should follow the instructions in the email notifications they receive from the Catamaran system.

- Recommendations to the ISD regarding the ISD and LEA participation rates and related activities will be found on the “Assurances” page of the ISD Summary Justification form.
 - » When the ISD receives notification that the ISD Summary Justification Form has been accepted, specific feedback can be found by logging into [Catamaran](https://catamaran.partners/Login.aspx) (https://catamaran.partners/Login.aspx) and navigating to the **Open Activities** link on the **Policy** tab. Users may have to download an attachment from the **Additional Actions** menu (instructions will be included in the feedback provided).
 - » If additional action and submission of information to the MDE is required (beyond the review of the overall comments found on the **Assurances** page of the Justification Form), users will find instructions about the additional action necessary on the **Additional Actions** menu, and the task will be added to the ISD Dashboard.

Early Literacy and Mathematics Benchmark Assessments Student-Level Reports Available

Early Literacy and Mathematics Benchmark Assessments Student Level Reports for the Winter 2023 administration are now available in the Dynamic Reporting System through the Office of Educational Assessment and Accountability (OEAA) [Secure Site](http://www.michigan.gov/oeaa-secure) (www.michigan.gov/oeaa-secure). Reports are available within 48 hours of students completing all portions of a content area test.

Performance levels are now available for the 2022-2023 academic year. Scale scores within each subject area can be described in ranges. The labels applied to these ranges, which are known as Performance Levels, are:

- **Needs Supports** – The student’s performance is not yet proficient and indicates a minimal or partial understanding and application of key academic content standards defined for Michigan students. The student needs intervention and support to improve achievement.
- **Demonstrates Proficiency** – The student’s performance indicates understanding and application of key academic content standards defined for Michigan students. The student needs continued support to maintain and improve proficiency.
- **Demonstrates Mastery** – The student’s performance exceeds academic content standards and indicates substantial understanding and application of key concepts defined for Michigan students. The student needs support to continue to excel.

Available reports include:

- **Domain Analysis Report** – Separated by content area, the domain report provides a list of selected students; the report displays a Content Area Scale Score Table and Domain Performance Tables.
- **Individual Student Report** – Separated by content area, the ISR provides detailed information on individual students in the Content Area Scale Score Summary and the Content Area Domain Summary. The Content Area Scale Score Summary gives scale score for the overall content area.
- **Student Roster Report** – Separated by content area, the student roster provides a list of students’ Overall Scale Score, Standard Error, Points Earned by assessment category, and domain subtotal.
- **Student Trend Report** – Separated by content area, the trend report provides up to three academic years of the percentage of points earned for each assessment that was administered.

English Learner (EL) Program Implementation Survey

On January 12, 2023, principals in selected districts will receive an email from Dr. Mark Hansen at the University of California Los Angeles (UCLA) asking them to participate in an English Learner (EL) Program Implementation Survey and to also identify a lead teacher for the survey project.

This implementation survey is part of a national grant project the Michigan Department of Education (MDE) is participating in, along with six other states and a group of national researchers. The survey responses will help MDE and others learn how components of program implementation impact the progress of ELs across systems. The survey will be open until January 26, 2022. Participation of Michigan educators is strongly encouraged.

What is the Purpose of Summative Assessment?

There are two types of assessments — assessment for learning and assessment of learning. Summative assessments are assessments of learning; their purpose is to describe how much a student has learned by the end of a period of instruction.

Summative assessment may be in the form of:

- extended cycle assessments, which include end-of-course exams, capstone projects or portfolios, performance assessments, and annual statewide summative assessments
- shorter cycle assessments, which include end-of-unit tests, reports and thesis papers, and mid-term exams

The M-STEP, PSAT™ 8/9 for Grade 8, SAT® with Essay, MI-Access, WIDAACCESS for ELLs, and WIDA Alternate ACCESS for ELLs are all examples of extended cycle statewide summative assessments. These assessments, which students take once each year, measure the student's progress toward achieving Michigan's academic and English language development standards. Annual assessment results can be used by school and district administrators, policymakers, and state officials to identify areas where aggregate student groups are, or are not, meeting the state standards; to determine whether local curricula are aligned to state standards; to evaluate program effectiveness; and to assure that schools and districts most in need of assistance are identified and getting the help they need. These assessments do not provide data that is to be used for day-to-day decisions.

Extended and shorter cycle summative assessments at the classroom-, school-, or district-level serve a different purpose than the statewide summative assessments identified above. At the local level, summative assessments are often used by school and district administrators to determine what an individual student has learned and to review whether groups of students in a school or district have learned the aligned curriculum over an identified course of study. They can also show if an instructional program needs modification to provide future groups of students with better learning experiences and outcomes.

Regardless of the type, summative assessments offer a snapshot of student learning at one point in time after instruction has concluded. For this reason, summative assessment results are to be used in combination with results from a variety of assessment tools, along with the formative assessment process; this process measures learning during instruction to provide a comprehensive overview of student performance in a balanced system of assessments.

WHAT'S NEW

State-Allowed Accommodations and English Learner Supports Window

Services for Students with Disabilities (SSD) Coordinators can now submit requests for state-allowed accommodations (SAAs) and English learner (EL) time and one-half (+50% extended time) support in SSD Online, through February 21, 2023.

If you have already requested extended time for your English learners for Fall 2022 testing, you do not need to re-enter those requests for Spring 2023 testing; the request is good for the academic year. However, if a student used an SAA for Spring 2022 testing, the SSD Coordinator must request the SAA again or request a College Board-approved accommodation for Spring 2023 testing.

All students taking the SAT with Essay, PSAT 10, and PSAT 8/9 must be pre-identified in the Office of Educational Assessment and Accountability (OEAA) [Secure Site](http://www.michigan.gov/oeaa-secure) (www.michigan.gov/oeaa-secure) by 5:00 p.m. on February 15, 2023. The Pre-ID process creates the initial order for pre-printed ID labels for each student identified by this deadline.

Completing ACT's Manage Participation Process

The window for completing Managing Participation is **past due**. If your school(s) has not yet completed Manage Participation using the [PearsonAccess^{next} website](https://testadmin.act.org) (<https://testadmin.act.org>), do so as soon as possible.

Pre-identify Students and Order WorkKeys Test Materials

The window to submit student data for pre-identification barcode labels and to order ACT WorkKeys standard-time and accommodations materials is **January 4 – February 15, 2023**, 5:00 p.m., using the [OEAA Secure Site](http://www.michigan.gov/oeaa-secure) (www.michigan.gov/oeaa-secure).

Instructions for these activities can be found at the [Secure Site Training web page](http://www.michigan.gov/securesitetraining) (www.michigan.gov/securesitetraining) under the **Pre-Identification of Students** and the **Material Ordering** sections.

Initial material orders for Standard Time, Regular Print WorkKeys materials will be based on the number of students pre-identified on the OEAA Secure Site **by 5:00 p.m. on February 15, 2023**. Accommodated materials and Spanish test booklets (if needed) must be ordered through the OEAA Secure Site on the **Initial Material Orders** page **by 5:00 p.m. on February 15, 2023**.

The projected number of Standard Time, Regular Print materials that will be sent based on the pre-identification can be viewed on the Initial Material Orders page on the OEAA Secure Site. The number of Standard Time, Regular Print materials can only be adjusted by pre-identifying additional students and by unassigning students from the testing. Accommodated and Spanish materials orders will automatically reduce the number of Standard Time booklets.
