

#### **College Entrance Exam Contract Awarded**

A contract has been awarded to the College Board and their SAT Suite of Assessments for testing in grades 8, 9, and 10, and in grade 11 for the College Entrance Exam portion of the Michigan Merit Exam (MME). This contract allows the College Board to continue its current efforts and will be in place for the Spring 2024 summative testing window, which includes the following:

- Grade 11 (and eligible 12th graders) SAT with Essay This assessment will provide test scores that count towards grade 11 English language arts (ELA) and mathematics accountability metrics.
- Grade 10 PSAT 10
- Grade 9 PSAT 8/9 for grade 9
- Grade 8 PSAT 8/9 for grade 8 This assessment will provide test scores that count towards grade 8 ELA and mathematics accountability metrics.

This new contract does **not** impact the Spring 2023 testing, which will begin on April 12, 2023. Important information regarding Spring 2023 is on the <u>MME web page</u> (www.michigan.gov/mme) and the <u>PSAT web page</u> (www.michigan.gov/psat). This information includes:

Beginning with the Spring 2024 test administrations, the SAT Suite of Assessments will transition to an online test administration. Over the summer,the Michigan Department of Education will share additional information and support regarding this transition. Keep a close watch on Spotlight for important information regarding Spring 2023 and Spring 2024 test administrations.

#### **WIDA Incident Reports**

If testing irregularities occur before, during, or after testing, the Building or District WIDA Coordinator must report the irregularities to the Office of Educational Assessment and Accountability (OEAA) as soon as possible. A <u>WIDA ACCESS for ELLs and Alternate</u> <u>ACCESS for ELLs Incident Reporting (IR) Reference</u> <u>Table (https://www.michigan.gov/-/media/Project/</u> Websites/mde/OEAA/Assessment-Coordinator-Training-Guide/WIDA\_Incident\_Report\_Table-jl. pdf) is available to help coordinators in this process. The guide identifies the incident categories and subcategories used in the Secure Site Incident Reporting tool and includes sample scenarios for each category or sub-category.

#### Screening Potential English Learners During the WIDA ACCESS Testing Window

Michigan schools are still federally required to screen newly enrolled students who have not been previously identified as English learners (ELs) using the WIDA Screener, even if the WIDA ACCESS for ELLs testing window is open.

If while the WIDA ACCESS for ELLs testing window is open a student is determined to be an EL – per the criteria outlined in <u>Michigan's Entrance and Exit</u> <u>Protocol (EEP)</u> (https://www.michigan.gov/mde/-/ media/Project/Websites/mde/OES/Programs/Title-III/ EL\_Entrance\_and\_Exit\_Protocol.pdf) – the summative WIDA ACCESS for ELLs or the WIDA Alternate ACCESS for ELLs assessment must be administered to that student.

The OEAA strongly recommends that students be allowed as much time as possible between the WIDA Screener and the summative test, to ensure students do not experience testing fatigue.

#### WIDA Additional School/District Labels

By now, most schools and districts should have received an adequate supply of School/District Labels. However, if any schools/districts need to order additional labels, the district MUST send an email to <u>mde-oeaa@michigan.gov</u> with the following information, so the OEAA can request a shipment of those materials from DRC (the testing vendor):

- District Name
- School Name
- Quantity of School/District Label Sheets (1 sheet = 10 labels)

# Writing Skills Field Test

### **Preparation for Passage-based Writing**

The Michigan Department of Education (MDE) is looking for schools to participate in an M-STEP online Passage-based Writing Field Test **January 3–February 10, 2023**.

#### Why have a stand-alone field test?

Field tests are used to check the adequacy of testing procedures and statistical characteristics of new test items by testing them in the field before they appear on an actual assessment. This test follows the same setup and security as the M-STEP. The field test helps to ensure that the items we are putting on the M-STEP are high quality. And, the more writing exposure your students receive, the more improvement you will see!

#### Who can participate?

Students in grades 3-8 can participate in field-testing items written by Michigan authors for Michigan's state assessments.

#### What is involved?

During the field test, students will read one passage, either literary or informational, from a variety of genres as prescribed by the standards. Students will then answer five multiple choice questions and respond to a writing prompt, which includes a checklist of components found in a well-written essay. They will not receive a score, but will have an opportunity to prepare for the M-STEP and use the checklist to improve their writing skills in the testing environment.

All students taking the SAT with Essay, PSAT 10, and PSAT 8/9 must be pre-identified in the Office of Educational Assessment and Accountability (OEAA) <u>Secure Site</u> (www.michigan.gov/oeaa-secure) **by 5:00 p.m. on February 15, 2023**. The Pre-ID process creates the initial order for pre-printed ID labels for each student identified by this deadline.
