#### TOMORROW: End of M-STEP Test Administration for Online Grade 3 ELA and All Paper/Pencil Testing

The test administration window for the M-STEP Online Grade 3 ELA (English language arts) test and all grades/content areas of the M-STEP paper/pencil test will close tomorrow, **May 5, 2023.** This applies to M-STEP only.

#### For M-STEP Paper/Pencil Testing:

- All materials must be shipped by May 10, 2023, to be scored.
  - » Barcode labels must be affixed to each answer document
    - Barcode labels for students who were pre-identified for paper/pencil testing by February 15, 2023, were shipped with Initial Material Orders.

Barcode labels for students who were pre-identified for paper/pencil testing after February 15 must be printed from the <u>OEAA Secure Site</u> (www.michigan.gov/oeaa-secure).

- » All materials must be packaged and shipped back to the scoring contractor exactly as instructed on pages 70-75 of the <u>M-STEP</u> <u>Test Administration Manual</u> (https://www. michigan.gov/mde/-/media/Project/Websites/ mde/OEAA/M-STEP/M-STEP\_Test\_ Administration\_Manual.pdf).
- » Be sure to keep the sender's copy of the FedEx Express Airbill for each package for your documentation.
- All M-STEP paper/pencil testing for all grades and content areas must be completed by the end of the school day on **May 5, 2023**.
  - » Any administration of a paper/pencil test after this time is a misadministration and must be reported using the Office of Educational Assessment and Accountability Secure Site Incident Reporting Tool.

#### For M-STEP Online Grade 3 ELA Testing:

- The INSIGHT testing engine is available every school day from 7:00 a.m. to 4:00 p.m. until tomorrow, Friday May 5, 2023, unless your building has previously received alternate INSIGHT availability.
- Students who are logged in and testing at 4:00 p.m. on May 5 will not be exited from the testing software, but they will not be able to log back in if they lose connectivity or log out.
- Any test that is started but not completed will be submitted and scored as administered.
- The Grade 3 ELA online testing window cannot be reopened after it closes at 4:00 p.m. tomorrow, May 5.

#### **MI-Access Reminder: Week 4 of Testing**

This is Week 4 of MI-Access testing, the midway point of the seven-week window for MI-Access assessments. As testing continues across the state, many schools/districts are beginning to plan for securely packing up and returning paper/ pencil materials at the end of the assessment administrations. Here are a few important reminders for the post-administration tasks.

- The MI-Access testing window closes on May 26, 2023, at 4:00 p.m. All paper/pencil and online testing must be completed by this time. This includes all online answer document score entries for Supported Independence and Participation assessments.
- All paper/pencil answer documents must have a student barcode label affixed to the front and must be properly filled out for each student. Missing barcode labels can result in test scores being invalidated if the testing student cannot be properly identified.
  - » Detailed information about printing barcode labels from the Office of Educational Assessment and Accountability (OEAA) Secure Site is available on the <u>Secure</u> <u>Site Training page</u> (www.michigan.gov/ securesitetraining) in the <u>Barcode Labels</u> <u>document</u> (https://www.michigan.gov/mde/-/ media/Project/Websites/mde/Year/2019/04/01/ barcode\_label\_directions.pdf)
- Note: The Functional Independence ELA: Expressing Ideas is a paper/pencil assessment only, for both online and paper/pencil testers. This answer document must be returned for scoring for students to receive a valid overall English language arts score.

- The Michigan Department of Education recommends that districts/schools that have completed testing inventory all assessment materials against the initial shipping list of materials, and then return all secure materials, including answer documents, to the vendor for scoring as soon as possible. The deadline to return materials is May 31, 2023.
- Any administration of a paper/pencil test after the close of the window is a misadministration and must be reported, using the OEAA Secure Site Incident Reporting Tool.

- All materials must be shipped by **May 31, 2023**, to be scored.
- Be sure to keep the sender's copy of the FedEx express air bill for each package for your documentation.

Participants in all this educator committee work are offered either a daily stipend or State Continuing Education Clock Hours with a substitute reimbursement option. Hotel stay for multiple day events (for those traveling more than 50 miles) and expense reimbursement is also provided.

## Preferred candidates for the Performance Assessment Cadre of Experts:

- have experience teaching to Michigan's mathematics and ELA academic content standards
- have interest in learning to develop standardized performance assessments
- wish to work with other educators on a stimulating collaborative endeavor

## Participating in this project, you will have opportunities to:

- learn about the Michigan model competencies for mathematics and ELA
- lean how to develop performance assessments and rubrics
- · collaborate with colleagues from across the state

- practice scoring of performance assessments with colleagues
- participate in a research agenda focused on measuring student competencies through performance assessments
- earn up to 50 SCECH credits
- stipends will also be available, based on time and completed products.

Participants are expected to attend and contribute approximately 50 hours of job-embedded facilitated professional learning and assessment development over the 2022-23 academic year.

Cohort IV will meet in-person three times for 5 days total, plus attend two 2-hour virtual sessions (after school) from August 2023 through June 2024. Participants will work in grade-range teams with colleagues. Team leads may host 2-3 additional virtual team meetings throughout the year to keep the item development momentum going and production flowing.

A stipend covering anticipated assessment development time, as well as travel expenses (and sub fees) for in-person meetings to be held in the Lansing area, are offered to all Cohort IV team members.

## Spring 2024 Testing Window: Correction of Information on Michigan Testing Dates

Last week, College Board distributed a counselor newsletter indicating that the school year 2023-2024 spring testing window for PSAT 10, PSAT 8/9, and SAT School Day will be March 4 – April 26, 2024.

However, those dates (March 4 – April 26) are **not applicable** to schools/districts that will administer these assessments for the Michigan Department of Education (MDE).

## All Spring 2024 testing for MDE schools and districts is to be administered between April 8 and April 26, 2024.

We apologize for any inconvenience this may have caused and encourage you to adjust your planning accordingly.

#### REMINDERS

#### Spring 2023 Scores Release

- Score release began May 3 for students who took the SAT with Essay on April 12.
- Scores will be released on May 18 for students who took the SAT with Essay on April 25
- Scores will be released on May 22 for students who took the PSAT 10 and PSAT 8/9.

Some scores may be released later due to a student's participation in the accommodated testing window or for investigation of a testing irregularity. Additional scores will be released on a rolling basis as they become available.

Assessment	Score Release Begins
SAT with Essay — April 12	May 3, 2023
SAT with Essay — April 25	May 18, 2023
PSAT 10 and PSAT 8/9 for grades 8 and 9	May 22, 2023

Scores will be released to educators in the College Board K-12 Reporting Portal in late June, once all answer document verification activities are completed.

**Reminder:** Scores available in the College Board Reporting Portal are not the official results used for Michigan Department of Education (MDE) reporting. #### **Helping Students Access Scores**

Students will need a College Board account to view their scores. If they do not already have an account, they can go to the College Board website (http://www.collegeboard.org/) and sign up for a free account.

As you and your students review scores, here are some common issues and potential courses of action you may need to take to resolve them.

Issue	Most Common Scenarios	Course of Action
Student has access to score, but educator does not	Educator scores have not yet been released in the K-12 reporting portal	Check again starting June 23 for access to scores
	College Board was not able to automatically link the score report to student's College Board account	See steps outlined below
Educator has access to score, but student does not	The student does not have a College Board account	Have the student create College Board account and follow the steps to link scores as outlined below
	The student has multiple College Board accounts	Students should call CB at 866-756- 7346 to merge their accounts. If the educator calls on the student's behalf, make sure the student is present to provide consent to the Customer Service team

	Used answer sheets were returned in the white accommodated testing envelope and the student was not approved for an accommodation or extended time as an English learner	ETS will reach out to the school to confirm if the student tested with accommodations. Respond to this outreach
Neither student nor educator	The score was invalidated due to a misadministration or other misconduct (use of cell phone during testing, for example)	No action is available in most cases. The school will receive a letter concerning the misadministration
has access to score	The student submitted a <i>Request to Cancel Scores</i> form for the SAT with Essay	No action is available. Scores will be available to MDE but will not be available to the student or school in the portal
	The student score is slightly delayed due to testing on the makeup date or during the accommodated window, late receipt of answer sheets, missing information on the answer sheet, other reason	Continue to monitor scores. Students should contact College Board at 866- 756-7346 if scores are not available by June 23

## Matching Student Scores to a College Board Account

If a student is signed into their College Board account but does not see their scores, it may be that CB was not able to link the student's College Board account and score report automatically. For security reasons, a student must verify additional information before scores can be displayed. Students will need either their SAT registration number (found in the Roster Report of the K-12 Reporting Portal) or the UIC (student ID number) with which they were pre-identified.

#### To establish a match, the student should:

- Login to their <u>College Board account</u> (https:// account.collegeboard.org/login/login)
- 2. Select Matching Tool
- 3. Follow the instructions on the screen
- 4. Select one of the following options:
  - a. I can supply my test information.
  - b. I can supply my student ID (using the UIC).

In some cases, students will still not be able to view their scores using the steps above. If the student has inconsistent information on file, multiple College Board accounts, or unreleased scores, the steps above may not resolve this discrepancy. #### **Returning ACT WorkKeys Test Materials**

If you still have secure materials from the initial and/ or makeup test dates, return them to ACT as soon as possible. The final ACT-scheduled FedEx pickup is scheduled for today, **Thursday, May 4, 2023**.

Use the cartons the test materials were shipped in and follow the packing instructions that begin on page 30 of the <u>ACT Test Coordinator Information</u> <u>Manual</u> (https://www.act.org/content/dam/act/ secured/documents/pdfs/state-district-testcoordinator-paper-test.pdf). Store the packed cartons in a secure location within the district or school building until they can either be picked up by FedEx or taken to a local FedEx office.

If you are unable to return your test materials today, the WorkKeys Test Coordinator can do one of the following:

  - » dates and times your school will be open

- 3. Take the materials to your local FedEx dropoff location and keep the receipt for your records
