#### M-STEP Online Test Administration Window Closes Tomorrow, May 17, 2024


Thank you for all your diligent work in preparing for and administering the Spring 2024 M-STEP assessments! The Office of Educational Assessment and Accountability (OEAA) appreciates the time and effort required for another successful test administration; we are confident your test results will help support your school and district staff and students!

**Important Reminder:** All online M-STEP testing must be completed by the end of the school day on **Friday, May 17, 2024**. Students who are logged in and actively testing at 4:00 p.m. on Friday will not be logged out of the test; however, if they lose connectivity or exit the test, they will not be able to log back in.

This will allow you to select your site, and then view student testing status:



You can view completion by all tests overall, by grade, by content area, and by grade/content area. Remember that this shows test completion according to students who were Pre-Identified in the <u>OEAA Secure Site</u> (www.michigan. gov/oeaa-secure) and pulled into the DRC INSIGHT Portal. This is not the same as the expected to test list used for accountability purposes.

Tests that are started, but not completed (these tests show as In Progress status in the DRC INSIGHT Portal) will be force-submitted after the testing window closes. In Progress tests that have met attempted requirements will be considered complete and scored.

### **MI-ACCESS DEADLINE**

The MI-Access test window closes Friday, May 24, 2024, at 4:00 p.m.

All MI-Access testing activities including SI/P score entry must be completed by 4:00 p.m. There are no exceptions to these deadlines.



#### Important Reminder: All MI-Access Testing Must Be Completed by Friday, May 24, 2024

If you have completed your Spring 2024 MI-Access testing and have returned the test materials for scoring, thank you and congratulations! If you still have students taking this assessment, make sure all MI-Access testing activities are completed by 4:00 p.m. on Friday, May 24, 2024, for all grades and content. This includes:

- all Functional Independence (FI) online and paper/pencil testing administrations
  - » Important reminder: the FI English language arts: Expressing Ideas (ELA:EI) is an exclusively paper/pencil assessment, for both online and paper/pencil testers. The ELA:EI answer document must be returned to receive a valid overall English language arts score. Students who are not administered both the ELA:EI (paper/pencil only) and the ELA: Accessing Print and Using Language (online or paper/pencil) assessments will not receive a valid English language arts score.
- all Supported Independence (SI) and Participation (P) testing activities
  - » It is best if these activities are completed well in advance of 4:00 p.m. on May 24, to allow ample time for student scores to be entered on the online answer document by the deadline.
  - » All online score entry for the MI-Access SI and P assessments must be submitted by May 24, at 4:00 p.m.

» Reminder: Social studies assessments for SI and P levels in grades 5, 8 and 11 are locally developed or off-the-shelf assessments. Also, districts and/or schools are required to report the student results of the locally administered social studies tests. Districts/schools will enter this student assessment information on the OEAA Secure Site (www.mi.gov/oeaa-secure) during the Answer Documents Received and Not Tested Students window, which will be open June 5-11, 2024.

#### Checking the status of students' online testing

To verify that students have completed the online tests, log into the <u>DRC INSIGHT Portal</u> (mi.drcedirect.com) and select the **My Applications** tab; then under **Post-Test Actions**, select **Student Management** and select the **Student Status Dashboard**. This page allows you to monitor test completion by showing students whose tests are **Not Started**, **In Progress** or **Complete**. Note: The SI/P status are also available in the dashboard display after score entries have been submitted. #### **Return of All Secure Assessment Materials**

- Schools and districts are required to inventory all secure assessment materials against the initial list of materials that were shipped, and then, after testing, return all secure materials, including answer documents, to the vendor for scoring as soon as possible. The last date to return materials for scoring is **May 29, 2024**.
- The MI-Access Test Administration Manuals (TAMs), which are on the MI-Access Web Page (www.michigan. gov/mi-access), each have a chapter called Material Return Instruction. This chapter includes directions and diagrams for returning test materials, along with the FedEx pickup return instructions.
- **Note:** Even if schools miss the shipping deadline, they must still return all secure materials to the scoring contractor as quickly as possible. If any secure materials are not returned, the school will be notified regarding the missing material later this summer.

#### Additional Flexibility for Administration of the ACT WorkKeys in Spring 2025

Based on feedback from the state's school districts, the Michigan Department of Education has partnered with ACT to provide additional flexibility for the administration of the ACT® WorkKeys® assessment in Spring 2025.

Depending on spring schedules, **schools will choose either Testing Window 1 or Testing Window 2** for the primary administration of the assessment. Schools may choose either window, but not a combination of both windows. The Makeup Window, Window 3, is reserved for testing students who were absent during the school's chosen testing window.

This table lists the Initial Test Dates and the associated A ccommodation Testing Windows that will be provided:

Schools will indicate their chosen testing window during the Manage Participation Process that occurs in November of each school year. Watch for communications from ACT and Spotlight in early fall.

Student score release will occur in two phases.

Students whose tests were submitted between April 8 and April 12 gained access to their scores on May 2.

For those whose tests were submitted between April 15 and April 26, scores will be available starting on May 16.

#### Reminders

#### **Returning All Test Materials to ACT**

The return of secure test materials, including answer documents and test booklets, is past due.

If your school still has secure materials from the initial and/or makeup test dates, return them to ACT as soon as possible. Use the carton(s) in which the test materials were shipped to return all the secure test forms (used and unused). Pack the carton(s) using the instructions and illustration on page 34 of the ACT Test Coordinator Information Manual (https://www.act.org/content/dam/act/secured/documents/pdfs/state-district-test-coordinator-paper-test.pdf). Any unused cartons may be recycled.

Store the packed cartons in a secure location within the district or school building until they can be either picked up by FedEx or taken to a local FedEx office.

If you have been unable to return your test materials, the WorkKeys Test Coordinator can do one of the following:

- Send an email to <u>workkeys@act.org</u> to request a new pickup and provide the following information:
  - » dates and times your school will be open
  - » location of the boxes
  - » number and approximate weight of boxes
  - » address, phone number, and contact name at the school
