Student Data Files Available Now for M-STEP, MI-Access, SAT, PSAT-related, and ACT WorkKeys

Downloadable student-level data files of the results of the Spring 2023 M-STEP, MI-Access, SAT with Essay, PSAT 10, PSAT 8/9 for Grades 8 and 9, and ACT WorkKeys assessments are now available in the Office of Educational Assessment and Accountability (OEAA) [Secure Site](https://www.michigan.gov/oeaa-secure) (www.michigan.gov/oeaa-secure).

Important Reminder: These data are **embargoed** until the public release of Spring 2023 assessment results later this summer. While individual student results may be shared with parents now, the sharing of any school-, district-, or state-level results with parents, the community, or other external parties is not allowed until the embargo is lifted. School board meetings are considered public meetings; therefore, the sharing of embargoed assessment results at these meetings is not permissible at this time.

To access the Student Data Files, log into the OEAA Secure Site. Select the **Reports** tab from the top of the screen, then select **Student Score Data Files** from the drop-down menu:

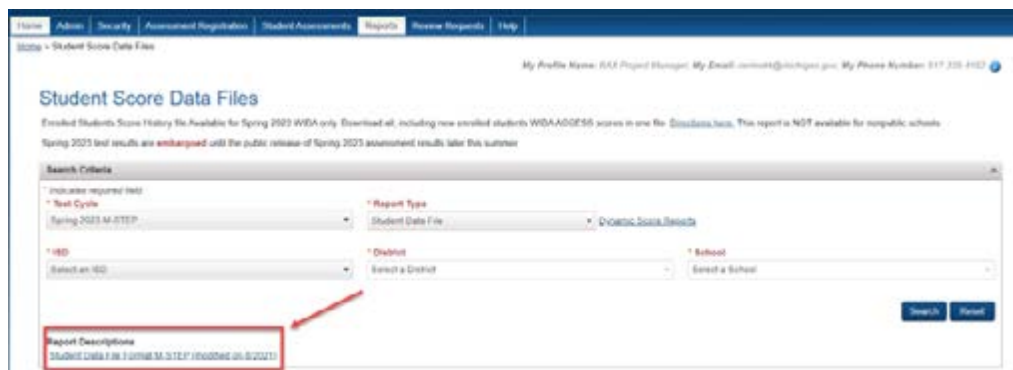

College Board K12 Reporting Portal May Differ from Student Data Files

Student data has been available in the College Board K12 Reporting Portal since June 23, 2023. The scores available in the College Board K12 Reporting Portal are not official results used in Michigan Department of Education reporting, so there may be some minor differences between the College Board K12 Reporting Portal and the downloadable student-level data files from the Secure Site; this is due to invalidation of scores for reasons such as out-of-level testing.

Since final student data is available now, Preliminary Reports are no longer available in the Dynamic Score Reporting Site. Watch the Spotlight for more information about final reports.

The Time is Now! Make Sure School and District Contacts are Up-to-Date in the EEM for the 2023-24 School Year

With the start of a new school year, now is the time to review your district and school information in the [Educational Entity Master \(EEM\)](https://www.michigan.gov/eem) (www.michigan.gov/eem) to verify that any needed changes or updates have been made. For assessment and accountability purposes, the Office of Educational Assessment and Accountability (OEAA) uses the information entered in the EEM for grade levels serviced, Admin/Contacts, and the address and email associated with the Admin/Contacts. It is important to keep this information accurate and up to date. While Spring 2024 testing may seem a long way off, assessment vendors will begin communicating directly to test coordinators and technology directors in early fall.

All needed updates should be completed no later than **September 8, 2023**, so you do not miss out on critical information. Names, telephone numbers, email addresses, and mailing addresses for each contact type must be verified. Test materials are sent to the address associated with the test coordinator. **You can expect communications starting in early fall for the College Board assessments (SAT and PSAT), ACT WorkKeys, WIDA, and the Early Literacy and Mathematics Benchmark Assessments.** If there are staff changes in your district or building, it is especially important to verify the following contact types and request all needed updates.

The fall Early Literacy and Mathematics Benchmark Assessment **window will be open August 21 – October 27, 2023.**

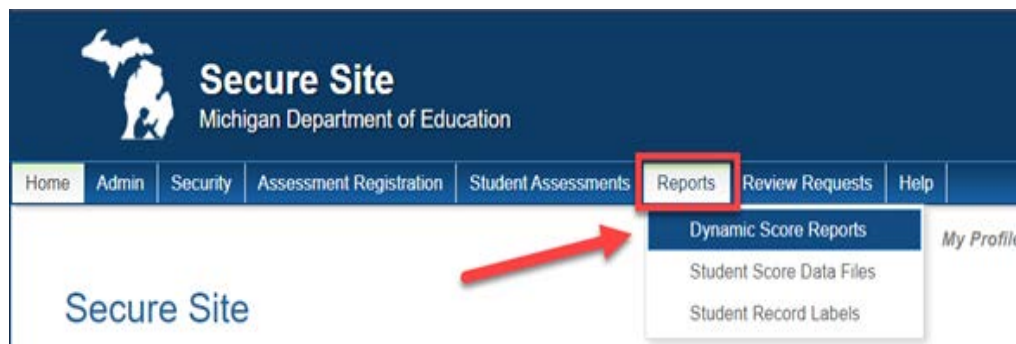

Call to Action: Completion of the Extended Benchmark API in the Michigan Data Hub is Past Due!

The team at the Michigan Data Hub (MiDataHub) continues to work to ensure districts have created the Extended Benchmark API (Application Programming Interface) in the MiDataHub cockpit. Configuring this API will ensure you satisfy the current legislation and data use needs of the 2023-24 benchmark assessment law, [Public Act 103 of 2023](http://legislature.mi.gov/doc.aspx?2023-SB-0173) (<http://legislature.mi.gov/doc.aspx?2023-SB-0173>), Section 104i.



As of August 1, 2023, there are 341 districts that need to complete this step. If your district is not on this list, congratulations, your district has completed the API work. If your district is on the list, please use one of these two options to configure this API:

Spring 2023 WIDA ACCESS for ELLs Student Data File Available

The Spring 2022 WIDA ACCESS for ELLs Student Data File is now available. To download your school's student data files, log into the [OEAA Secure Site](http://www.michigan.gov/oeaa-secure) (www.michigan.gov/oeaa-secure), go to the **Report** menu, and select **Student Test Scores**. These student data files contain only student-level data for students who tested in your district. WIDA Reports Available on WIDA AMS as of July 1

In WIDA AMS, district-level users may view both district-level and school-level reporting (school-level users may view school-level reporting only). Test Administrators do not have permission to view reports.



At [WIDA AMS](https://www.drcedirect.com/all/eca-portal-v2-ui/#/login) (<https://www.drcedirect.com/all/eca-portal-v2-ui/#/login>), select **Test Results** from the **Report Delivery** menu to display the Test Results page. You can use the Administration, District, School and Report drop-down menus to filter the display.

Individual Student Reports are also available in various languages in WIDA AMS **Report Delivery > On Demand Reports**. Select the Administration, District, School, and Language filters to generate reports. Click **Find Students** to populate the students tested at that school. On Demand Reports can be opened individually under the Action column, or you can check the select box for each student requiring the language and click either **Open Selected** or **Save Selected**.

WIDA Reports Arrive in Districts on August 22

“Hello – OEAA Calling ...”

The office of the Michigan Attorney General (AG) recently issued a notice regarding [Government Imposter Scams](https://www.michigan.gov/ag/consumer-protection/consumer-alerts/consumer-alerts/scams/government-imposter)

(<https://www.michigan.gov/ag/consumer-protection/consumer-alerts/consumer-alerts/scams/government-imposter>), warning against texts, phone calls, and emails from scammers who purport to be contacting the targeted person from a state agency.

The AG office routinely receives consumer complaints from Michiganders who have received such scam texts, phone calls, and emails. As part of its prescribed protection, the notice from the AG office states, “Government Agencies will not email, call, or text you unless you first reached out to them by email, phone, or text message.”

There are exceptions to this protocol. The Michigan Department of Education Office of Assessments and Accountability (OEAA) may initiate contact with educational entities and education organizations to facilitate our work related to the development, administration, and reporting of state assessments.

WHAT'S NEW

April 2024 Test Dates

Starting in Spring 2024, the Michigan Department of Education's (MDE) administrations of PSAT 8/9 for grades 8 and 9, PSAT 10, and SAT with Essay will be delivered digitally. The Spring 2024 testing window for the MDE-provided SAT with Essay, PSAT 10, and PSAT 8/9 is **April 8-26, 2024**.

Schools will have the flexibility to test on any day within the approved window, and they may use multiple days within the window for testing, if preferred. However, students must complete testing in one day unless they have accommodations that allow for two-day testing.

Note: All tests, including makeup tests, must be completed between April 8-26. **Students will not be able to complete assessments after April 26.**

School Establishment and the Educational Entity Master (EEM)

School establishment is the process through which Michigan schools are identified as participating in the state assessments and are set up for digital testing in College Board systems.

It is important for schools to update the information in the [Educational Entity Master \(EEM\)](http://www.michigan.gov/eem) (<http://www.michigan.gov/eem>), which serves as Michigan's repository of education systems and contact information.

College Board will use the data in EEM to identify contact information for testing staff and to establish schools for testing. In addition to test coordinators, backup test coordinators, and Services for Students with Disabilities (SSD) Coordinators, **building level technology directors must be assigned in EEM** in order for schools to be set up for testing.

For each College Board assessment (SAT with Essay, PSAT 10, & PSAT 8/9 for grades 8 and 9), the following information is required for school test coordinators, backup school test coordinators, SSD Coordinators, and technology directors:

- First Name
- Last Name
- Email
- Telephone Number
- Complete Entity Physical Address (Street Address, City, State, Zip Code)

ACT WorkKeys Spring 2023 Score Reports

School- and student-level paper reports will be mailed to test coordinators and are due to arrive the week of **August 7, 2023**. The shipment will include the following reports:

- **Individual Summary Score Report** — a student-level report containing Level and Scale scores with explanations of what the scores mean. The test coordinators will receive one paper report per student, to be given to the student.
- **Summary Score Report** — a student-level report containing the student's Level and Scale scores but without the explanations of what the scores mean. The test coordinator will receive one paper report per student, to be retained by the school.
- **Roster Score Report** — a roster of students showing test scores and when students took the assessment. The test coordinator will receive one paper report, to be retained by the school.

ACT® WorkKeys® National Career Readiness Certificate® (ACT WorkKeys NCRC)

Students who achieve a minimum score of 3 or higher on each of the three ACT WorkKeys subject tests will earn an ACT WorkKeys National Career Readiness Certificate® (or an ACT WorkKeys NCRC en Espanol if they took the tests in Spanish). The scores on these assessments determine the certification level.

- A minimum score of 3 out of 7 on all three assessments: **Bronze**
- A minimum score of 4 out of 7 on all three assessments: **Silver**
- A minimum score of 5 out of 7 on all three assessments: **Gold**
- A minimum score of 6 out of 7 on all three assessments: **Platinum**

The NCRC documents that the student possesses skills essential to workplace success. This documentation may improve career outcomes for students just entering the workforce, and enhance employers' hiring, training, and promotion decisions.
