# **Embargoed Aggregated Assessment Data Coming Wednesday, August 24**

In anticipation of the planned public release of Spring 2022 assessment results later this summer, the Michigan Department of Education (MDE) and the Center for Educational Performance and Information (CEPI) will provide embargoed aggregated assessment data for districts to use for planning purposes. Districts will have the following embargoed data available for district review by the close of business on Wednesday, August 24:

# M-STEP Parent Reports Arriving in Schools

Spring 2022 M-STEP Parent Reports will begin arriving in schools later this week and will continue to arrive through the end of August. These shipments will also include Student Record Labels. Parent Reports should be disseminated to parents and guardians as soon as possible.

M-STEP Parent Reports are provided for students who took the general summative assessment in grades 3-8, and grade 11. Grade 8 Parent Report includes information on student performance on the PSAT 8/9 in grade 8. The grade 11 Parent Report includes information for parents and students on the SAT with Essay and the ACT WorkKeys assessments.

If necessary, schools can also access and print Parent Reports from the Dynamic Score Reporting Site, starting on Wednesday, August 24, 2022. To access the Dynamic Score Reporting Site, log into the Office of Educational Assessment and Accountability (OEAA) Secure Site (www.michigan.gov/oeaa-secure), select the Reports tab, and then Dynamic Score Reports.

Student Record Labels can also be printed from the OEAA Secure Site. Access them in the same manner as the Parent Reports, except choose **Student Record Labels** from the **Reports** tab.

Embargo Reminder: Spring 2022 test results are embargoed until the public release of Spring 2022 assessment results later this summer. Districts and schools will be notified through the Spotlight when the embargo has been lifted. While individual student results may be shared with parents at this time, it is not permissible to share any school-, district-, or state-level results with parents, the community, or other external parties until the embargo is lifted by the Michigan Department of Education. School board meetings are considered open meetings; therefore, the sharing of embargoed assessment results at these meetings is not permissible until the embargo is lifted.

Translated Parent Reports will be available in Spanish and Arabic through the Dynamic Score Reporting site. Information on how to access these translated reports will be provided through Spotlight when they are available.

MI-Access Parent Reports will begin shipping in late August or early September.

# The Time is Now! Make Sure School and District Contacts Are Up to Date in the EEM for the 2022-23 School Year

With the start of a new school year, now is the time to review your district and school information in the Educational Entity Master (EEM) (www.michigan.gov/eem) to verify that any needed changes or updates have been made. For assessment and accountability purposes, the Office of Educational Assessment and Accountability (OEAA) uses the information entered in the EEM for grade levels serviced, Admin/Contacts, and the address and email associated with the Admin/Contacts. It is important to keep this information accurate and up to date. While Spring 2023 testing may seem a long way off, assessment vendors will begin communicating directly to school and district coordinators in early fall.

All needed updates should be completed no later than September 9, 2022, so you do not miss out on critical information. Names, telephone numbers, email addresses, and mailing addresses for each contact type must be verified. Test materials are sent to the address associated with the test coordinator. You can expect communications starting in early fall for the College Board assessments (SAT and PSAT), ACT WorkKeys, WIDA, and the Early Literacy and Mathematics Benchmark Assessments. If and when your district or building staff changes, it is especially important to verify the following contact types and request all needed updates (see table next page).

To verify the Admin/Contacts in the <u>EEM</u> (www.michigan.gov/eem), scroll to the bottom of the Entity page and complete these steps.

1. Make sure each relevant contact type from the table above is accounted for and the correct staff member is associated with the contact type.

**Note:** While the EEM will allow multiple contacts for a single role or contact type, the OEAA will only use the most current contact available. Consider requesting the deletion of duplicates.

2. Using the **Details tab**, verify the contact's email address, telephone number, and mailing address.

**Note:** The mailing address must be a physical district or school address. Test materials cannot be delivered to post office boxes or to personal addresses.



Each public school district has at least one authorized user who can make updates to the EEM for the district and schools within the district. Submit all changes and updates to your authorized district user as soon as possible. Nonpublic schools are to contact <a href="mailto:nonpublicschools@michigan.gov">nonpublicschools@michigan.gov</a> or call 517-241-5385 to request updates to the EEM.

If you do not know who your authorized EEM user is and you are a user of the <u>OEAA Secure Site</u> (www.michigan.gov/oeaa-secure), you can locate the name and contact information on the **District and School Contacts page** of the Secure Site. To access this page, log into the OEAA Secure Site, select the **Assessment Registration** tab at the top of the page and then choose **District and School Contacts** from the drop-down menu.

- makes appropriate decisions from accurate information

They serve as the foundation for understanding what assessment literacy means and the role and purpose of comprehensive, balanced, quality assessment systems.

#### Early Literacy and Mathematics Benchmark Assessments Student-Level Reports Available

The Fall 2022 Early Literacy and Mathematics
Benchmark Assessments testing window opens
on August 22 and will close on October 28, 2022.
Student Level Reports for the Fall 2022 administration
are available in the Dynamic Reporting System
through the Office of Educational Assessment and
Accountability (OEAA) Secure Site (https://www.
michigan.gov/oeaa-secure). Reports are available
within 48 hours of students completing all portions of a
content area test.

Available reports include:

Individual Student Report (ISR) – separated by content area, provides detailed information on individual student achievement, scale score and performance level

**Student Roster Report** – allows users to view student Overall Scale Score, Standard Error, Points Earned by assessment category, and domain subtotal by grade, content, domains, and categories

**Student Trend Report** – displays up to three years of historical Early Literacy and Benchmark Assessment score data

**Domain Analysis Report** – displays the Overall Content Scale Score and the number of Points Earned in each domain for each student



Working in grade-level teams, MiPAC participants are expected to attend and contribute approximately 50 hours of job-embedded facilitated professional learning and assessment development over the 2022-23 academic year.

# Preferred candidates for the Performance Assessment Cadre of Experts:

- have experience in teaching mathematics or ELA in at least one of these grade spans: grades 3-5, grades 6-8
- have experience in teaching to Michigan's mathematics and ELA academic content standards
- are interested in participating in the development of performance assessments

# By participating in this project, educators will have opportunities to:

- learn about the Michigan model competencies for mathematics and ELA
- develop performance assessments and rubrics
- · collaborate with colleagues from across the state
- practice calibrating the scoring of performance assessments
- participate in a research agenda that is focused on measuring student competencies through performance assessments
- earn up to 50 SCECH credits; stipends will also be available based on time and completed products

As noted, participants are expected to attend and contribute approximately 50 hours of job embedded facilitated professional learning and assessment development over the 2022-23 academic year.

Approximately eight or nine 2-hour virtual after-school sessions to support the design process are expected to be scheduled from September 2022 through June 2023. Participants will work in grade-level teams with colleagues. Team leads will host three or four virtual meetings throughout the year, to keep the item development momentum going and production flowing.

#### **April 2023 Test Dates**

Make sure that students, parents, and staff are aware of the testing dates for the Michigan-provided SAT with Essay, PSAT 10, and PSAT 8/9 in Spring 2023. Upcoming Spotlight newsletters will contain information on training, key deadlines, and how to prepare to administer the assessments.

#### **Important Notes**

- The SAT with Essay, PSAT 10, and PSAT 8/9 in April 2023 will continue to be administered in the paper/pencil mode.
- The Essay is required for all students taking the SAT.
- Schools must administer the PSAT 8/9 for Grade 8 on April 12, 2023. The primary testing window of April 13-18 is available for students absent on April 12 (unless students are approved with accommodations and will test in the accommodated testing window).
- Schools must administer the PSAT 8/9
  for Grade 9 and PSAT 10 on April 1218, 2023 (unless students are approved
  with accommodation and will test in the
  accommodated testing window). Schools must
  choose one of the dates within the window to
  serve as the primary test day. The remaining
  days of the window are available to students
  absent on the primary test day.

Information on SAT®, PSAT™ 8/9, and PSAT™10 provided by the College Board

 The makeup test dates are for students absent during the primary test date for SAT or the entire primary testing window for PSAT 10 or PSAT 8/9. Makeup test dates will also be used for students who experienced a test day issue and need to test again.

#### **Testing Students with Accommodations**

- The accommodated testing window is April 12-25, 2023, for the SAT with Essay, PSAT 10, and PSAT 8/9.
- All students testing with accommodations taking the PSAT 10 or PSAT 8/9 may test in the accommodated testing window.
- Only students designated on the Nonstandard Administration Report (NAR) in SSD Online may test in the accommodated testing window for SAT with Essay.
