#### Spring 2022 Parent Reports

##### MI-Access Parent Reports Arriving in Schools

Spring 2022 MI-Access Parent Reports have begun arriving in schools starting this week. MI-Access Parent Reports are provided for students who took the alternate assessment in grades 3-8 and 11. These shipments will include Student Record Labels. Parent Reports should be disseminated to parents and guardians as soon as possible.

If necessary, schools can access and print Parent Reports from the Dynamic Score Reporting Site. To access the Dynamic Score Reporting Site, log into the [Office of Educational Assessment and Accountability \(OEAA\) Secure Site](http://www.michigan.gov/oeaa-secure) ([www.michigan.gov/oeaa-secure](http://www.michigan.gov/oeaa-secure)), select the **Reports** tab, and then **Dynamic Score Reports**.

Student Record Labels can also be printed from the OEAA Secure Site. Access them in the same manner as the Parent Reports, except choose Student Record Labels from the Reports tab.

##### Translated Parent Reports Now Available

Translated versions of the M-STEP (grade 3-7), PSAT grade 8, and M-STEP, MME (grade 11), and the MI-Access (grades 3-9,11) Parent Reports are now available in Spanish and Arabic through the Dynamic Score Reporting Site and MiLearn.

##### Accessing Translated Parent Reports in the Dynamic Score Reporting Site

To access the translated versions of Parent Reports, log into the Dynamic Score Reporting Site. Under **Choose Report**, select Student level, then Parent Report. Select applicable filters, then select **View Report**. Under the **Take Action** menu, select English, Arabic, or Spanish translations of the reports.

## Accessing Translated Parent Reports in MiLearn

The translated Parent Reports are also available in MiLearn. Once the report has been generated, select the **Export>Export to PDF** in the upper portion of the report. Once the PDF option is selected, a window will allow the user to select a language and a PDF will be generated in the selected language.

## 2021-2022 Graduation Rate Appeals Window

The Center for Educational Performance and Information (CEPI) opened the 2021-2022 Graduation Rate Appeals Window on August 1, 2022 in the Michigan Student Data System (MSDS). CEPI sent communications to all schools and districts at that time. This follow-up to that communication is to stress the importance of ensuring graduation rate data are carefully reviewed and any necessary corrections are made now.

Graduation rates are an important part of accountability calculations, and once graduation rate data from the 2021-2022 school year is finalized on September 14, 2022, it cannot be changed. If you have not already done so, take advantage of this opportunity to review and potentially appeal your graduation rate data for the 2021-2022 school year. During the appeals window, you can report end-of-summer graduates, submit cohort year changes, update exit status, and request unique identification code (UIC) linking.

**Graduation rates can only be appealed during the graduation rate appeals window in the MSDS through September 14, 2022.**

It is imperative that graduation rate data is reviewed during the appeals window, as these data will impact 2022-2023 accountability results. While we are fully committed to ensuring accurate data in graduation rate reporting, we must also meet certain reporting deadlines that do not allow us to change data after the graduation rate appeals window has closed. You are urged to take time to review these data now to ensure your school and district graduation rates are accurate.

## Reminder: Report “Building Pupil Would Otherwise Attend” for Shared Educational Entities (SEEs) and Specialized Shared Educational Entities (S2E2) Students

As the deadline for the 2021-22 Student Record Maintenance (SRM) collection in the Michigan Student Data System approaches, remember the “Building Pupil Would Otherwise Attend” characteristic must be reported for students who participated in the Sending Scores Back Program for the 2021-22 school year. This reporting requirement applies to Shared Educational Entities (SEEs) and Specialized Shared Educational Entities (S2E2s) for reporting and accountability purposes.

Accountability reports (School Index and School Grades) for the 2022-2023 school year will use graduation rates from the 2021-2022 school year, since the graduation rates used in accountability reporting are lagged by one year due to the late availability of the data. This means that the graduation rates calculated for the 2021-22 school year will be used in 2022-2023 accountability reporting.

Reporting the “Building Pupil Would Otherwise Attend” characteristic is essential to the efficacy of the Sending Scores Back Program, as it indicates where students are to be included in accountability rate calculations. Make sure the pupil accountant for your district/your member districts has submitted and certified student records, including the “Building Pupil Would Otherwise Attend” characteristic, either by the June 30 End of Year collection certification deadline or during the **July 25 – September 14** SRM window for graduation rate appeals. **Note: The SRM deadline is next week – Wednesday, September 14 at 11:59 p.m.** Please share this message with your pupil accountant(s).

## Early Literacy and Mathematics Benchmark Assessments Student-Level Reports Available

Early Literacy and Mathematics Benchmark Assessments Student Level Reports for the Fall 2022 administration are now available in the Dynamic Reporting System through the [Office of Educational Assessment and Accountability \(OEAA\) Secure Site](https://www.michigan.gov/oeaa-secure), ([www.michigan.gov/oeaa-secure](https://www.michigan.gov/oeaa-secure)). Reports are available within 48 hours of students completing all portions of a content area test.

Performance levels are now available for the 2022-2023 academic year. Scale scores within each subject area can be described in ranges. The labels applied to these ranges are known as Performance Levels.

The performance levels are:

- **Needs Supports** — The student's performance is not yet proficient and indicates a minimal or partial understanding and application of key academic content standards defined for Michigan students. The student needs intervention and support to improve achievement.
- **Demonstrates Proficiency** — The student's performance indicates understanding and application of key academic content standards defined for Michigan students. The student needs continued support to maintain and improve proficiency.
- **Demonstrates Mastery** — The student's performance exceeds academic content standards and indicates substantial understanding and application of key concepts defined for Michigan students. The student needs support to continue to excel.

Available reports include:

- **Domain Analysis Report** — Separated by content area, the domain report provides a list of selected students and displays a Content Area Scale Score Table and Domain Performance Tables.
- **Individual Student Report** — Separated by content area, the ISR provides detailed information on individual students in the Content Area Scale Score Summary and the Content Area Domain Summary. The Content Area Scale Score Summary gives scale score for the overall content area.
- **Student Roster Report** — Separated by content area, the student roster provides a list of students' Overall Scale Score, Standard Error, Points Earned by assessment category, and domain subtotal.
- **Student Trend Report** — Separated by content area, the trend report provides up to three academic years of percent of points earned for each assessment that was administered.

## Entrance and Exit Protocol Updated for English Learners

The Michigan Department of Education [Entrance and Exit Protocol](https://www.michigan.gov/mde/-/media/Project/Websites/mde/OES/Programs/Title-III/EL_Entrance_and_Exit_Protocol.pdf) ([https://www.michigan.gov/mde/-/media/Project/Websites/mde/OES/Programs/Title-III/EL\\_Entrance\\_and\\_Exit\\_Protocol.pdf](https://www.michigan.gov/mde/-/media/Project/Websites/mde/OES/Programs/Title-III/EL_Entrance_and_Exit_Protocol.pdf)) has been updated to reflect entrance requirements connected to the new WIDA Screener for Kindergarten.

To be identified as eligible for English learner services, students enrolled in kindergarten before December 1 must score below 5.0 on the Listening or Speaking domains. These students should be coded as EL in the Michigan Student Data System (MSDS) and no further screening is necessary.

**Note:** A student who takes the Listening and Speaking domains in the fall and scores 5.0 or higher is identified as “potentially eligible” for services and must still take the Reading and Writing domains mid-year or in the winter. Students who fall in this category are not to be coded as EL in MSDS until after the final two domains have been screened and results are available. It is recommended that those domains for these “potentially eligible” students be administered prior to January 31. This ensures that the student is identified properly and still allows the student to take the required WIDA ACCESS for ELLs assessment if they are found to be eligible – that is, if they score below a 5.0 in any domain of the screener.

Students enrolled in kindergarten after December 1 must score below 5.0 on any domain of the WIDA Screener for Kindergarten to be identified as an EL.

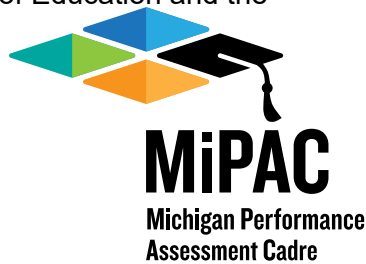

### Development Opportunity: Michigan Performance Assessment Cadre of Experts (MiPAC) – Cohort III

#### MiPAC Cohort III Starts September 15; Stipends and SCECHs Available

The Michigan Department of Education and the Michigan Assessment Consortium are looking for education professionals to serve on the Michigan Performance Assessment Cadre of Experts (MiPAC), Cohort III.



MiPAC develops performance assessments aligned to Michigan's model competencies in mathematics and English language arts (ELA) in grades 3-8.

#### Grades 3-5 English language arts teachers are particularly encouraged to apply.

Working in grade-level teams, MiPAC participants are expected to attend and contribute approximately 50 hours of job-embedded facilitated professional learning and assessment development over the 2022-23 academic year.

#### Preferred candidates for the Performance Assessment Cadre of Experts:

- have experience in teaching mathematics or ELA in at least one of these grade spans: grades 3-5, grades 6-8
- have experience in teaching to Michigan's mathematics and ELA academic content standards
- are interested in participating in the development of performance assessments

#### By participating in this project, educators will have opportunities to:

- learn about the Michigan model competencies for mathematics and ELA
- develop performance assessments and rubrics
- collaborate with colleagues from across the state
- practice calibrating the scoring of performance assessments
- participate in a research agenda that is focused on measuring student competencies through performance assessments
- earn up to 50 SCECH credits; stipends will also be available based on time and completed products

As noted, participants are expected to attend and contribute approximately 50 hours of job embedded facilitated professional learning and assessment development over the 2022-23 academic year. Approximately eight or nine 2-hour virtual after-school sessions to support the design process are expected to be scheduled from September 2022 through June 2023. Participants will work in grade-level teams with colleagues. Team leads will host three or four virtual meetings throughout the year, to keep the item development momentum going and production flowing.

### Updated 2022-23 OEAA Electronic Device Policy

Personal electronic devices that are not used for testing pose a large security risk to all state assessments. As accessibility to and the use of additional electronic devices has increased among both students and staff over the last few years, instances of cheating, plagiarism, and inappropriate use of devices have had a negative impact on the validity and reliability of the state's assessments. This has also caused invalidation of student tests, resulting in negative impacts to assessment participation and accountability.

Prior to test administration, District and Building Assessment Coordinators must create a specific policy for the use of electronic devices by students and staff during testing. These policies must include the state-required policies detailed in the Office of Educational Assessment and Accountability (OEAA) Electronic Device Use Policy, and must be communicated to staff, students, and families.

## What's New

### Updating EEM

An important first step in preparing for the Spring 2023 ACT WorkKeys assessments is to ensure that your building/school's WorkKeys Test Coordinator's correct contact name, email address, phone number, and mailing address (cannot be a post office box) is listed in the [Educational Entity Master \(EEM\)](http://www.michigan.gov/eem) ([www.michigan.gov/eem](http://www.michigan.gov/eem)).

**Note:** Ensuring that the WorkKeys Test Coordinator contact information is accurate must be done for each school in the district, not just for the district-level information.

ACT uses the information in the EEM to call and send emails to the Workkeys Test Coordinators, and to ship test materials to the appropriate locations. Inaccurate information will result in critical information not being received in a timely manner, resulting in key deadlines being overlooked and delays in the receipt of test materials.

If the information in the EEM for your building/school is inaccurate, contact your authorized district EEM user to update it no later than **Friday, September 9, 2022**, to ensure your school receives the necessary information to start the Manage Participation process in November.

**Note:** Updating EEM information can only be done by the district's authorized EEM user. If you are not sure who your authorized EEM user is, use the **District and School Contact page** on the [Office of Educational Accountability and Assessment \(OEAA\) Secure Site](http://www.michigan.gov/oeaa-secure) ([www.michigan.gov/oeaa-secure](http://www.michigan.gov/oeaa-secure)) to retrieve their name and contact information.
