## Online Testing Waiver Window Open October 16 – November 22, 2023

The Online Testing Waiver Window opens on October 16, 2023 in Office of Educational Assessment and Accountability (OEAA) <u>OEAA Secure Site</u> (www.michigan.gov/oeaa-secure) and runs through November 22, 2023.

All schools are expected to administer the Spring 2024 M-STEP, MI-Access Functional Independence (FI), SAT with Essay, PSAT 8/9, PSAT 10, and WIDA ACCESS for ELLs assessments online. **Note: With the move to digital testing, online waiver requests for the College Board Suite of SAT Assessments are new for Spring 2024.** 

However, a small number of school buildings may not be able to test online. These include buildings without internet access, juvenile justice facilities that do not allow students online, or some center-based special education programs where all students have Individualized Education Programs requiring a paper/pencil administration. These schools can submit online waiver request(s) requesting to administer the paper/pencil versions of these assessments.

To submit a waiver request, authorized users will log into the <u>OEAA Secure Site</u> (www.michigan.gov/oeaa-secure) and select the **Assessment Registration** drop-down, then select **Online Waiver Requests** from the menu.

### WHAT'S NEW

#### **Online Waiver Requests for SAT with Essay and PSAT-Related Assessments**

The Online Waiver form in the OEAA Secure Site has been updated to include SAT with Essay, PSAT 8, PSAT 9, and PSAT 10. Online waivers for the College Board Suite of Assessments can be submitted between Monday, October 16, and Wednesday, November 22, 2023.

When creating an online waiver request, educators may choose one of four options to categorize their request. The table below lists each category as well as the associated guidelines for obtaining an approved waiver in that category:

Online Waiver Category	Guidelines for Approved Waiver
	This category is intended for locations that operate a Special Education center-based program.
Center-based Program	Approval depends on whether <b>all</b> students designated for paper assessments have accommodations in their IEP requiring paper assessments.
	If not, approval will not be granted, and SSD Coordinators must request paper-based assessments in SSD Online for the individual students who require them.
Juvenile Justice Facility	This category is intended for locations that are juvenile detention centers and/or alternate education programs.
	Approval will be granted if there is a device- or internet-access policy which prohibits <b>all</b> students from testing online.
Not Tech Ready	"Not tech ready" is considered an invalid reason for an approved online waiver. If a school is concerned with the number of devices they have or lack of internet connectivity, the request will be escalated to College Board who will follow up with administrative recommendations/information to help the school test successfully between April 8 and April 26.
Other	This category covers other requests not covered in any of the earlier categories, including religious exemption requests.
	"Other" requests will be escalated to College Board for follow-up with the school to determine final disposition of approval.

# School Establishment and the Educational Entity Master (EEM)

School establishment is the process through which Michigan schools are identified as participating in the state assessments and are set up for digital testing in College Board systems.

It is important for schools to update their information in the <u>Educational Entity Master (EEM)</u> (http://www. michigan.gov/eem), which serves as Michigan's repository of education systems and contact information.

College Board will use the data in EEM to identify contact information for testing staff and to establish schools for testing. In addition to test coordinators, backup test coordinators, and Services for Students with Disabilities (SSD) Coordinators, building level technology coordinators must be assigned in EEM in order for schools to be set up for testing. For each College Board assessment (SAT with Essay, PSAT 10, and PSAT 8/9 for grades 8 and 9), the following information is required for school test coordinators, backup school test coordinators, SSD Coordinators, and technology coordinators:

- First Name
- Last Name
- Email
- Telephone Number
- Complete Entity Physical Address (Street Address, City, State, Zip Code)

**Note:** The mailing address must be the physical district or school address associated with the test coordinator record. Make sure each of the fields above is accurate and complete for all applicable roles. Any incorrect data in EEM could delay your school's establishment process.

## Reminder

#### **Update EEM**

An important first step in preparing for the Spring 2024 ACT WorkKeys assessments is to ensure that your building/school WorkKeys Test Coordinator's correct contact information – name, email address, phone number, and mailing address (cannot be a post office box) – are listed in the Educational Entity Master (EEM) (www.michigan.gov/eem).

ACT uses the information in the EEM to call and send emails to the Workkeys Test Coordinators, and to ship test materials to the appropriate locations. Inaccurate information will result in critical information not being received in a timely manner, resulting in key deadlines being overlooked and delays in the receipt of test materials.

If the information in the EEM for your building/school is inaccurate, contact your authorized district EEM user to update it **no later than Friday, October 20, 2023**, to ensure your school receives the necessary information to start the Manage Participation process in November.
