#### Updated FedEx Procedures to Return Secure Assessment Materials

As testing continues across the state, many schools/districts are beginning to plan for securely packing up and returning paper/pencil materials after administrations. Recently, FedEx made some minor changes to their call-in pickup procedures for returning materials. The updated instructions are as follows.

To schedule a pickup:

- call 1-800-GoFedEx (1-800-463-3339). After the voice prompt, say, "Schedule an Express Pickup" and follow the prompts.
- When transferred to a Customer Service Representative, specify that you need to schedule a "FedEx Express pickup".
  - » You will need to specify that the delivery location is a business and not a residence.
  - » Should it be needed, the vendor (Measurement Incorporated) account number is preprinted on the lower right side of the airbill included in the assessment materials the school/district received before testing.

#### New Kindergarten WIDA Screener Reminder

This year, Michigan educators will transition to using a new WIDA screening tool for kindergarten students who are potential English learners (ELs). Refer to the information and timeline below to determine the particular kindergarten screener students should be given as this transition is implemented:

Which Students	Timeframe	Which Screener
Students enrolling during Kindergarten Roundup (students who <b>will not</b> <b>be</b> enrolled or receiving educational services during the 2021/22 school year)	April 1, 2022 – July 30, 2022	Administer the new WIDA Screener for Kindergarten
Students enrolling in kindergarten who <b>will</b> <b>be</b> receiving educational services during the 2021/22 school year	Now – July 30, 2022	Administer the Kindergarten W-APT
Students enrolling in kindergarten who will be receiving educational services during the <b>2022/23</b> school year	August 1, 2022 – December 1, 2022	Administer the new WIDA Screener for Kindergarten – discontinue all usage of the Kindergarten W-APT

Materials for the new WIDA Screener for Kindergarten may be ordered using the WIDA Paper Screen Order Form found in the WIDA Screener and Kindergarten W-APT section of the MDE WIDA web page (https:// www.michigan.gov/mde/services/student-assessment/ wida-assessments).

Educators administering the new WIDA Screener for Kindergarten will have to complete the appropriate assessment training course in the WIDA Secure Portal (https://portal.wida.us/home) before administering the test.

#### Join the Achieving Balance in Classroom **Assessment Program**

Districts that implement high-quality, balanced assessment systems with fidelity in every classroom show improved student learning and increased student achievement. As districts move forward to address historic levels of learning loss following the COVID-19 pandemic, high-quality classroom assessment is more important than ever.

This is why the Michigan Department of Education (MDE) is collaborating with the Michigan Assessment Consortium (MAC) in offering a three-year professional learning and implementation program to support district teams as they plan for and implement balanced classroom assessment systems.

In the Achieving Balance in Classroom Assessment (ABCA) program, districts will learn how balanced assessment — assessment for learning and of learning — can:

- substantially improve student instruction and learning
- close gaps in student performance
- increase equity in student learning and achievement

#### WHAT'S NEW

#### Have Materials Been Returned?

All used answer sheets and test books from the SAT with Essay primary test date and PSAT-related primary testing windows are to have been returned by school/district Test Coordinators by now. If these materials have not yet been returned, coordinators must do so immediately.

Assessment	Test Date/Window	Important Notes
SAT with Essay	Primary Test Day: April 13	All <b>purple</b> test books and used answer sheets for students who tested on April 13 are to have been returned. There should be no purple test books in your school at this time.
SAT with Essay	Accommodated Testing Window: April 13- 26	Continue using <b>blue</b> or <b>lime</b> test books until April 26. Return all test books and used answer sheets as soon as all eligible students have completed testing.
PSAT 10 and PSAT 8/9	Primary Testing Window: April 13-19	All test books and used answer sheets for students who tested April 13-19 are to have been returned.
PSAT 10 and PSAT 8/9	Accommodated Testing Window: April 13- 26	Continue testing eligible students until April 26. Return all test books and used answer sheets as soon as all eligible students have completed testing.

Note: Any answer sheets returned after April 29 may not be scored or included in accountability calculations.

#### Test Window 2 (Makeup) Test Administration

Test materials ordered during the April 14-15, 2022 ordering window are scheduled for delivery by **April 27, 2022**.

The standard time makeup test date is **Thursday, April 28, 2022** and the accommodations makeup test window is **April 28 – May 4, 2022**.

All makeup administrations must follow the test day policies and procedures that are detailed in the <u>ACT WorkKeys Administration - Standard</u> <u>Time Paper</u> and the <u>ACT WorkKeys Administration</u> <u>Manual for Accommodations and English</u> <u>Learner Supports</u> manuals. Both manuals are posted on the <u>ACT-hosted website</u> (www.act.org/ stateanddistrict/michigan) on the **WorkKeys on Paper** page in the **Administration** stage.

FedEx pickups have been scheduled for Friday, April 29, 2022 for standard time materials and Thursday, May 5, 2022 for accommodations materials.
