M-STEP and MI-Access Preliminary Reports are available now in the <u>OEAA Secure Site</u> (www.michigan.gov/oeaa-secure). Select **Reports**, then **Dynamic Score Reports**.

M-STEP and MI-Access Student Data files and Aggregate Data files will be available in late July, also in the OEAA Secure Site. When the reports are available, go to the site, select **Reports**, and then **Student Test Scores**.

End of Testing for Early Literacy and **Mathematics Benchmark Assessments**

The testing window for the Early Literacy and Mathematics Benchmark Assessments will close at 4:00 p.m., Friday, June 3, 2022. Testing will not be available for students after the testing window closes.

Student Level Reports for the Spring 2022 administration are available in the Dynamic Reporting System through the Office of Educational Assessment and Accountability (OEAA) Secure Site (http://www. michigan.gov/oeaa-secure). Reports are available within 48 hours of students completing all portions of a content area test.

To view your school or district reports, go to the OEAA Secure Site (www.michigan.gov/oeaa-secure) and select Reports, then Dynamic Score Reports in the drop-down menu.

Now Available — M-STEP Test **Administration Training 3: After Testing**

An Update on National Assessment of Educational Progress (NAEP) and International Assessments

The state of Michigan participates in the National Assessment of Educational Progress (NAEP), the largest continuing nationally representative assessment of what our nation's students know and can do in subjects such as mathematics, reading, social studies, and science. NAEP is not administered to all Michigan schools: it is instead administered to a representative sample of schools across Michigan and the nation. A number of Michigan schools completed NAEP during the January to March 2022 administration window. We thank all the schools across Michigan who participated in this important assessment!

Michigan schools will be selected for two national assessments and three international assessments during the 2022-2023 school year (click on the links to see more details about the assessments):

No schools in Michigan have been initially selected to participate in more than one of the assessments listed above. A relatively small set of Michigan schools (less than five percent) will be selected for NAEP, PISA, TIMSS, or ICILS assessments during the 2022-2023 school year.

District and school notification emails will be sent to superintendents, district assessment coordinators, and principals of selected schools, in May, June, and July. If a school/district does not receive an email about one of these assessments during these months, it is likely that no school in the district has been selected for these assessments.

It is important for the selected Michigan schools to participate in these assessments, as they provide an accurate indication of what students know and can do in various subjects.

Urgent Need for Western and Northern Michigan Special Educators for July MI-Access Standard Setting

The Michigan Department of Education (MDE) is seeking special education professionals who are actively teaching alternate content expectations in science to participate in a standard setting event in July (<u>see Spotlight newsletter - May 12 issue</u> [https:// www.michigan.gov/mde/-/media/Project/Websites/ mde/OEAA/Spotlight-Newsletter/Spotlight-5-12-22. pdf]).

This MDE-sponsored standard setting event for the MI-Access science assessment will take place July 12-14, 2022, in East Lansing. It will be hosted by the MDE assessment vendor Data Recognition Corporation (DRC). During the standard setting, Michigan educators and stakeholders will recommend cut scores for the nine science tests in the three levels of MI-Access in each of the three tested grades (that is, Functional Independence, Supported Independence, and Participation in grades 5, 8, and 11).

We especially need special education panelists from western and northern Lower Michigan and from the Upper Peninsula who teach students who typically take the MI-Access Functional Independence assessment or the MI-Access Participation assessment.

All panelists will receive a stipend of \$250 per day (\$750 for all three days), plus travel expenses and overnight accommodations for those traveling more than 60 miles to East Lansing.

 - » Not Tested reason submissions: June 7 – June 21, 2022

During these review periods, schools will be able to review the online and paper/pencil tests received by the scoring vendor and submit answer document issues (such as missing tests and reasons a student did not test in one or more content areas).


