DRC INSIGHT Issues for Online WIDA ACCESS for ELLs

Earlier this week, multiple broadcast emails were sent to District Technology Coordinators and District English Learner Assessment Coordinators regarding issues impacting online WIDA ACCESS for ELLs testing. The various issues ranged from districts that need to implement certain COS-SD configuration options to DRC server failures. Issues may be continuing for some districts. DRC is investigating the causes and potential solutions.

The following directions were sent to districts impacted by the Central Office Services (COS) configuration issue to fix the issue. However, it is not expected that these issues will persist and impact the online summative assessments later this spring.

Fix for Content Files Missing in COS-SD

There are two options to update the content files if a content error message appears:

Option 1: Restart the COS Service Device. This will automatically validate and check content once the device is rebooted.

Option 2: Retrieve content directly from DRC.

- Log into WIDA AMS and navigate to Central Office Services.
- Turn off Content Hosting within the COS Configuration.
- Click Update Configuration.
 - » This will bypass the COS-Service Device and pull content directly from DRC while the new content is downloaded.
- (Optional) Turn content hosting back on once the service device has been updated and is fully functional.

Important Note: If these steps are taken while students are testing, they will be removed from testing with a COS-Service Device Connection error. If Content Hosting is turned off, the next login attempt will connect the student directly to DRC for access to the content.

Technology Readiness Checklist for WIDA Online Assessments

Districts that have not yet started online WIDA ACCESS for ELLs testing should review the [Technology Readiness Checklist for WIDA Online Assessments](https://www.wida-ams.us/Documents/Unsecure/Doc.aspx?id=ab98685f-49d5-4299-bdfc-db824c583c85) (<https://www.wida-ams.us/Documents/Unsecure/Doc.aspx?id=ab98685f-49d5-4299-bdfc-db824c583c85>). It is necessary for a district's Technology Director or others in the district who are responsible for setting up and configuring technology for the WIDA ACCESS for ELLs assessments to conduct a yearly review of the items outlined in this document, to prevent testing problems for staff and students.

WIDA Incident Reports

If testing irregularities occur before, during, or after testing, the Building or District WIDA Coordinator must report the irregularities to the Office of Educational Assessment and Accountability (OEAA) as soon as possible. A [WIDA ACCESS for ELLs and Alternate ACCESS for ELLs Incident Reporting \(IR\) Guide](https://www.michigan.gov/documents/mde/WIDA_Incident_Report_Table-jl_550383_7.pdf) (https://www.michigan.gov/documents/mde/WIDA_Incident_Report_Table-jl_550383_7.pdf) is available to help coordinators in this process. The guide identifies the incident categories and sub-categories used in the Secure Site Incident Reporting tool and includes sample scenarios for each category or sub-category.

Screening Potential English Learners During the WIDA ACCESS Testing Window

Michigan schools are still federally required to screen newly enrolled students who have not been previously identified as English learners (ELs) using the Kindergarten W-APT or the WIDA Screener in grades 1-12, even if the WIDA ACCESS for ELLs testing window is open.

If while the WIDA ACCESS for ELLs testing window is open, a student is determined to be an EL – per the criteria outlined in [Michigan's Entrance and Exit Protocol \(EEP\)](https://www.michigan.gov/mde/0,4615,7-140-81376_51051-252886--,00.html) (https://www.michigan.gov/mde/0,4615,7-140-81376_51051-252886--,00.html) – the summative WIDA ACCESS for ELLs or the WIDA Alternate ACCESS for ELLs assessment must be administered to that student.

The OEAA strongly recommends that students are allowed as much time as possible between the Kindergarten W-APT/WIDA Screener and the summative test, to ensure students do not experience testing fatigue.

WIDA Additional School/District Labels

By now, most schools and districts should have received an adequate supply of School/District Labels. However, if any schools/districts need to order additional labels, the district MUST send an email to mde-oeaa@michigan.gov with the following information, so the OEAA can request a shipment of those materials from DRC (the testing vendor):

- District Name
- School Name
- Quantity of School/District Label Sheets (1 sheet = 10 labels)

WIDA Testing Must Be Completed in Person

With the opening of the WIDAACCESS for ELLs and WIDA Alternate ACCESS for ELLs assessments window, it is important for educators to understand that the assessments must be administered to students in person. A virtual administration is not currently available.

Pre-Identification for Spring 2022 Early Literacy and Mathematics Benchmark Assessment (K-2)

Pre-identification of students for the Early Literacy and Mathematics Benchmark Assessment (grades K-2) **opened on February 7, 2022**. Students who took the Early Literacy and Mathematics Benchmark Assessment in the fall and/or winter of the 2021/22 academic year were automatically pre-identified to the Spring 2022 assessment by the Office of Educational Assessment and Accountability (OEAA).

If students tested in the fall or winter and will not be testing in Spring 2022, no action is needed from schools, even if the students are automatically pre-identified by the OEAA. Schools that choose to participate in Spring 2022 testing must pre-identify additional students for testing directly on the OEAA Secure Site, using any of the following methods:

- Michigan Student Data System (MSDS) Copy Function
- Pre-ID File Upload
- Student Search – one student at a time

Schools can also put students into online test sessions on the OEAA Secure Site through **February 21, 2022**. After February 21, students must be pre-identified on the OEAA Secure Site and then put into online test sessions in the DRC INSIGHT Portal.

Schools will have access in the DRC INSIGHT Portal to manage student data and test sessions starting **March 4, 2022**. Students newly pre-identified on the OEAA Secure Site will be transferred to the DRC INSIGHT Portal three times a day through **June 3, 2022**.

Pre-Identification and Material Orders for Spring 2022 SAT, PSAT, WorkKeys, MI-Access, and M-STEP

For the upcoming Spring 2022 administrations of the SAT, PSAT, WorkKeys, MI-Access, and M-STEP, schools are advised to complete these processes on the OEAA Secure Site.

Pre-identify students by 5:00 p.m. on February 16, 2022

- Update the Pre-ID Student Report by unassigning students who have exited the school from the Spring 2022 assessments.
- Pre-identify additional students who are/will be enrolled during the testing window.
- Pre-identify students for the MI-Access Functional Independence (FI), Supported Independence (SI), and Participation (P), based on the student's Individualized Education Program.

- Unassign students from the SAT, PSAT, WorkKeys, and M-STEP if they are taking a MI-Access assessment.
- Ensure the paper/pencil mode of testing is set for students who will take the M-STEP and MI-Access FI in the paper/pencil format.
- Continue to pre-identify new students in the OEAA Secure Site through the end of testing to ensure:
 - » a barcode label can be printed for paper/pencil test
 - » test tickets can be printed for online tests

Verify Initial Material Orders by 5:00 p.m. on February 16, 2022

- Verify the number of paper/pencil tests is accurate based on the pre-identification of students.
- Verify the shipping destination and the shipping address.
 - » The assessment coordinator's address from the Educational Entity Master (EEM) is used and NOT the school address.
 - » Changes must be made in the EEM by February 16, 2022, if needed.
- Order accommodated versions of the assessments for WorkKeys, M-STEP, and MI-Access as needed.
- Ensure the number of test administrators is entered correctly for the MI-Access SI and P, to ensure each administrator has sufficient materials (don't forget the shadow administrators).

Verify Online Sessions for M-STEP and MI-Access by 5:00 p.m. on February 21, 2022

- Enter students into online sessions on the OEAA Secure Site.
 - » Students not put into an online session on the Secure Site will still transfer to the DRC INSIGHT Portal; schools will then need to put them into an online session to print test tickets.
 - » Starting on March 4, students pre-identified after February 21 will be transferred to the DRC INSIGHT Portal; schools will then need to put them into online sessions in the DRC INSIGHT Portal.

It's Almost Time for the Michigan School Testing Conference — Register Now

Time is running out to register for the Michigan School Testing Conference (MSTC). This year's virtual conference, "Learn, Share and Discover," offers valuable workshops and clinics over three days, February 22-24, 2022. This conference is an essential resource to support your testing program.

The MSTC will offer a series of up to seven clinics every morning and afternoon. Testing and assessment topics include accountability, testing security and protocols, assessment strategies and best practices, test-specific updates, and more. The presenters include the Michigan Department of Education (MDE) staff, the Michigan Assessment Consortium (MAC), and educators from schools, districts, and ISDs. These presenters are eager to support your testing program with their knowledge and expertise.

The main conference registration fee is \$200, and attendees can earn SCECHs for an additional \$25 fee. MI-Access Grade Level and Alignment Changes for Science

The MI-Access science assessment is changing in 2022. These changes in MI-Access science grade level and content alignments have been under consideration in past years and are now a reality for Spring 2022.

Starting this spring, MI-Access Functional Independence, Supported Independence, and Participation science assessments will be given in grades 5, 8, and 11 (formerly given in grades 4, 7, and 11).

This change aligns the grade levels at which both Michigan's general assessment (M-STEP) and the alternate assessment (MI-Access) are given.

All MI-Access science assessments are aligned to the alternate content expectations (essential elements) that were finalized in the spring of 2020. Each assessment measures the corresponding essential elements' level of complexity (range):

- MI Access Functional Independence = High Range
- MI Access Supported Independence = Medium Range
- MI-Access Participation = Low Range

MI-Access science is no longer aligned to the 2007 extended benchmarks.

At the main MI-Access page, click the red "Michigan's alternate content expectations" link (top of the page). Then click on the "science and social studies" link and follow the individual grade level alternate content expectations links.

Note: Individualized Education Program (IEP) teams should consider making amendments to IEPs to reflect these changes for 2022.

WHAT'S NEW

Pre-ID Deadline is February 16

All students being tested in a school must be pre-identified in the Office of Educational Assessment and Accountability (OEAA) Secure Site. This includes any homeschool students who test at the school.

The pre-ID deadline for schools to receive standard assessment materials and pre-printed barcode labels for students answer documents is February 16, 2022. For any students pre-IDed in the Secure Site after the February 16 deadline, schools will have to print labels locally. If student answer sheets are returned for scoring without the affixed pre-ID label, the student's test will not be scored.

Accommodation Request Deadline is February 22

The deadline to request College Board accommodations, state allowed accommodations, and English learner (EL) extended time support in the College Board SSD Online system is February 22, 2022. Accommodated testing materials will be sent to schools based on the students in the pending and approved status in SSD Online as of February 22. Accommodated materials can only be used if the student has an approval in SSD Online.

English Learner Supports

There are three EL supports available to eligible students for the Michigan-provided assessments: time and one-half (+50 extended time), translated test directions, and use of a word-to-word bilingual dictionary. (EL supports are not currently available for Advanced Placement tests, weekend SAT, or the PSAT/NMSQT). The use of EL supports may not be appropriate for all EL students. To determine if providing EL supports is appropriate, refer to the [Supports & Accommodations Guidance Document](https://www.michigan.gov/documents/mde/Michigan_Accommodations_Manual.final_480016_7.pdf) (https://www.michigan.gov/documents/mde/Michigan_Accommodations_Manual.final_480016_7.pdf).

The use of translated test directions and bilingual dictionaries does not require College Board approval. Time and one-half must be requested in SSD Online by February 22; these requests will be automatically approved and will require no documentation to be submitted.

Translated test directions will be available in PDF format for schools to download and print for test day. Printed translated test directions will not be shipped to schools. These PDFs should be available by February 14, 2022 on the [Michigan Merit Examination web page](http://www.michigan.gov/mme) (www.michigan.gov/mme) and the [PSAT web page](http://www.michigan.gov/psat) (www.michigan.gov/psat).

Note: The translated test directions are not Michigan-specific; however, they will provide all relevant directions for students. The provided directions use only the standard timing script, so test coordinators and proctors are to make sure students who are also using the time and one-half (+50%) support pay attention to the timing instructions provided verbally and written on the board.
