GENERAL QUESTION

What is WIDA?

WIDA is a consortium of states dedicated to the design and implementation of high standards and equitable educational opportunities for English learners. As of 2023, the WIDA consortium consists of over 40 states and territories including Washington, D.C.

What is the WIDA Screener?

The WIDA Screener is an assessment screening tool used by educators to measure the English language proficiency of students who have recently arrived in the U.S. or in a particular district. It determines whether or not a child is in need of English language instructional services.

Is Michigan using a new screener?

Yes. The Kindergarten W-APT was discontinued on June 30, 2022. Educators should now be using the Kindergarten WIDA Screener. Be sure to continue to utilize the appropriate grade level/semester cluster as noted on page 9 of this document.

How much does the WIDA Screener cost?

Michigan school districts do not pay to administer these screening assessments.

Can Title III money be used for screeners?

No. Title III money cannot be used for any activities related to the administration or scoring of the WIDA Screener. This includes attending training for the assessment or hiring substitute teachers to free up educators to administer the assessment. If you have further questions regarding how districts can use Title III money, contact the Office of Educational Supports at 517-241-6974.

Are these screeners secure tests?

Yes. Test administrators must be trained in their administration and agree to maintain the security of test questions. Test administrators must also complete the OEAA Assessment Security Compliance Form before handling testing material, and additionally, districts must keep all completed [Assessment Security Compliance forms](#) on file at their district for a period of one year.



Who takes the WIDA Screener?

Upon new enrollment, all students or parent/guardians must answer the Questions on the state-required Home Language Survey (HLS). This is for the purpose of identifying those students in need of English learner (EL) services.

Students needing to take the WIDA Screener are identified through the questions on the HLS. Once the WIDA Screener is administered, students' scores must be entered into the [OEAA Secure Site](#) regardless if they are identified as an EL or not. Entering scores into the OEAA Secure Site does not identify a student as EL. Identification of a student as EL only occurs in the [Michigan Student Data System \(MSDS\)](#).

Does the HLS need to be completed every year?

No. Once the HLS has been completed during enrollment and if the student remains within the same school/district, there is no need to complete it every year. **However, the scores from the screening and the HLS must be kept in the student's CA60 or permanent record folder for future reference.** **Keep in mind that if a student moves to another district, it is important to notify the receiving district of the student's EL status.*

What do I do if I can't find or don't have access to a transfer student's HLS?

Our recommendation is to attempt to contact the student's sending district. If this approach doesn't provide you with the HLS, you can request that the parents/guardians complete the HLS again. However, the absence or duplicate request of this information from the parent/guardian **does not** change a student's EL status in MSDS. This means that if the sending school district has already identified the student as needing EL services in MSDS, the receiving district must as well. For more information on how to identify EL students in MSDS, talk to your pupil accounting staff.

What do I do if I accidentally label a student as EL in MSDS and then submit a Student Record Maintenance to correct the error? Does this student still need to test?

Yes. All students who have been identified in MSDS as needing EL services **must** take the WIDA ACCESS for ELLs or Alternate ACCESS for ELLs in the Spring.

Can districts screen students using the WIDA Screener during kindergarten roundup?

Yes, districts have the option to screen students using the WIDA Screener for Kindergarten during kindergarten roundup in the spring instead of waiting until the beginning of the following school year. This cycle is called the Pre-K cycle and students only need to be administered the Speaking and Listening domains.



Who can administer the WIDA Screener and what are the training requirements?

There are three sets of criteria that administrators of the WIDA Screener must meet:

1. Educators must fall into one of the following categories in order to administer the WIDA Screener:

- Educators who are district employees must hold current State of Michigan teaching certificate, or
- Educators who are not district employees (retired teachers) must hold current State of Michigan teaching certificate, or
- Paraprofessionals must not be funded by Title III funds
- Substitutes

All of the above personnel must be trained and/or monitored in order to administer the assessment.

2. Training

Educators who will be administering the WIDA Screener must have an understanding of content in the following areas:

- Complete the appropriate WIDA Screener online courses through the WIDA Secure Portal.

WIDA Screener Online: Administration	Required for all test administrators administering the online WIDA Screener (grades 1-12)
WIDA Screener Paper: Administration	Required for all test administrators administering the paper WIDA Screener (grades 1-12)
Writing for Grades 1-5: Scoring WIDA Screener	Required for test administrators scoring the online or paper/pencil WIDA Screener in grades 1-5
Writing for Grades 6-12: Scoring WIDA Screener	Required for test administrators scoring the online or paper/pencil WIDA Screener in grades 6-12
Speaking for Grades 1-5: Scoring ACCESS Paper and WIDA Screener	Required for test administrators scoring the online or paper/pencil WIDA Screener in grades 1-5
Speaking for Grades 6-12: Scoring ACCESS Paper and WIDA Screener	Required for test administrators scoring the online or paper/pencil WIDA Screener in grades 6-12
WIDA Screener for Kindergarten: Administration and Scoring	Required for all test administrators administering the K WIDA Screener

These courses can be found by logging onto the [WIDA website](https://wida.wisc.edu) (<https://wida.wisc.edu>/login). Once on the My Account & Secure Portal page, select the appropriate assessment under Screener Test Materials & Training: WIDA Screener Online or WIDA Screener Paper.



If you do not yet have access to a WIDA Secure Portal account, contact your District EL Assessment Coordinator. If you do not have a District EL Assessment Coordinator, your district should identify someone for this role. This person must then send an e-mail to mde-oeaa@michigan.gov to have a WIDA Secure Portal account created for him or her.

- Complete the OEAA Assessment Security Modules through Michigan Virtual and/or read the Assessment Integrity Guide.

3. Monitoring

If districts choose to include paraprofessionals and substitutes in the administration of the WIDA Screener, districts must make sure that these educators are monitored during the actual assessment. Monitoring is defined as intermittent observations of the test administration by a certified teacher.

Do I need to be retrained on administering the WIDA Screener?

Yes. Anyone who will be administering the WIDA Screener must complete the online training modules located on the [WIDA website](https://wida.wisc.edu/login) (<https://wida.wisc.edu/login>) by selecting WIDA Secure Portal from the Login dropdown. Additionally, educators should re-certify yearly for the WIDA Screener for Kindergarten, as well as the take the Speaking and Writing quizzes, to ensure the reliability and validity of scoring and test administration practices of such an important assessment.

Test administrators must also complete the OEAA Assessment Security Training Modules and/or read the Assessment Integrity Guide each year. Who should enter the screener scores into the OEAA Secure Site?

It is recommended that one person at the district level or in each building be identified as the sole person responsible for entering scores into the OEAA Secure Site. This helps keep district processes efficient. This person must have access to the [OEAA Secure Site](https://baa.state.mi.us/BAASecure/Login.aspx) (<https://baa.state.mi.us/BAASecure/Login.aspx>). Contact the OEAA at 1-877-560-8378, Option 1, with questions about gaining proper access. How many times will a student be screened?

Ideally, a student will only be screened one time. There are a few circumstances where a student may be screened again, such as when being screened to possibly re-enter EL services. If you have questions about whether or not to rescreen a student, please contact OEAA at 1-877-560-8378, Option 1 or send an e-mail to mde-oeaa@michigan.gov.



For students who have left and returned to the country, it is possible that a district may want to re-screen the students to help them reassess the level of English proficiency. However, if a student had previously been entered into the [Michigan Student Data System \(MSDS\)](https://www.michigan.gov/cepi/pk-12/msds) (https://www.michigan.gov/cepi/pk-12/msds) as receiving EL services and was never exited because they achieved proficiency, then the student is still considered an EL.

Where are the Test Administrator Manuals for the WIDA Screener?

The Test Administrator manuals can be accessed once logged into your WIDA Secure Portal account.

Who scores the screeners?

The WIDA Screener (online and paper/pencil) is scored by the test administrator once the assessment has been completed. Note: No part of the WIDA Screener is sent away for scoring. Educators will score a student's recorded responses for both the Speaking and Writing test whether the student takes the test online or via paper/pencil. Students testing online will have their Reading and Listening tests scored automatically by the testing engine. However, students testing paper/pencil will need to have those domains scored by the test administrator. Educators should reference the Test Administrator Manuals available upon login at the [WIDA website](https://wida.wisc.edu/login) (https://wida.wisc.edu/login) for more information on scoring and administration.

Can private schools screen students?

How do I get the screeners and administration materials?

Many of the materials can be downloaded from your WIDA Secure Portal account, but some may need to be ordered. You must have a WIDA Secure Portal Login to access the materials available for download. Contact your District EL Assessment Coordinator first. This person should have access to establish an account for educators in their district. If your District EL Assessment Coordinator has left your district or is no longer serving in that role, ensure that the contact information in the Educational Entity Master (EEM) is updated to reflect who is currently in that role.

The online WIDA Screener will require access to the testing engine as well as other software and hardware resources. View the [WIDA AMS User Guide](#) by logging into your WIDA AMS account. Ensure your technology coordinator has reviewed the [Technology User Guide](#) that is also available through [WIDA AMS](http://www.wida-ams.us) (www.wida-ams.us)



Some materials will need to be ordered through the WIDA Store. An order form can be found on the [WIDA web page](https://wida.wisc.edu) (https://wida.wisc.edu). Take an inventory of your district's currently available materials before placing an order through the OEAA.

How do I decide who should take the WIDA Screener Paper test instead of the Online test for students in grades 1-12?

Students who should take the WIDA Screener Paper test may include students who are considered recent arrivals. These are students who have been attending U.S. schools for 12 months or less. Other eligible students should include those students with disabilities whose disability requires use of the paper/pencil form of the assessment. It is not the case that all students with disabilities or students with Section 504 plans are unable to take the WIDA Screener Online. Nor is it the case that all students who are considered recent arrivals do not have the ability to take the WIDA Screener Online. However, for students who have exceptionally limited English abilities, the WIDA Screener Online may not be the best option.

NEW STUDENTS

How much time do I have to screen possible EL students?

Possible EL students must be screened in the first 30 days (school days) of the school year. Any possible EL student who enrolls after the first 30 days must be screened within two weeks of enrollment.

How do I make a decision about which students should be considered ELs and which students are not considered ELs?

Educators should refer to the [Michigan Department of Education Entrance and Exit Protocol](https://www.michigan.gov/mde/-/media/Project/Websites/mde/OES/Programs/Title-III/EL_Entrance_and_Exit_Protocol.pdf) (https://www.michigan.gov/mde/-/media/Project/Websites/mde/OES/Programs/Title-III/EL_Entrance_and_Exit_Protocol.pdf). Do I need to screen exchange students?

Yes. Any student that a district enrolls and receives state and federal funding for is held to all statewide assessment and accountability processes. Exchange students are **required** to be assessed by any assessments for which they qualify. Districts should enroll these students using the same enrollment processes (HLS, screener administration, etc.) that are used with all other students.

Can students with disabilities be screened and qualify for EL services?

Yes. All students, including students with disabilities, are required to be screened if their Home Language Survey indicates they should be screened. These students are also potentially eligible, based on the scores of the screener, for EL services in addition to the special education services they may also be receiving.

• **How do I know if the student has been screened already?**
•

• Once a student’s Primary Educational Providing Entity (PEPE) has been set
• to a particular district in the [Michigan Student Data System \(MSDS\)](#), that
• student’s previous assessment history is viewable in the [OEAA Secure Site](#).
• Coordinators should work with their pupil accounting staff to ensure this
• step is completed. This is done by submitting an enrollment record in MSDS
• either on a general collection or a student record maintenance (SRM) file.

• **If a student moves in from another district but already has screener
• scores, does that student need to be screened again?**

• No. If a student has moved in from another district in Michigan and already
• has screener scores, that student does not need to be re-screened.

• **Should I screen students who are recently arrived from a country outside
• of the United States?**

• Yes. Any student may qualify to take the WIDA Screener if a ‘yes’ has been
• indicated on the HLS. However, MDE recommends screening these students
• using the paper WIDA Screener option, if it is clear that these students
• have significantly limited formal education experiences, as well as limited
• experience with computers.

• **If a student moves from another non-WIDA state, do they need to be
• screened here?**

• Yes. All new enrolling students without prior K-12 experience in Michigan
• schools must be screened, unless they have proof of a proficient WIDA
• score from another state.

• **If a student moves from another state that uses WIDA, do they need to be
• screened here?**

• If the student has been screened using the WIDA Screener in another state
• within 30 calendar days of enrollment, the district may honor the scores IF
• they have a record of the student’s scores. Please note that neither WIDA
• nor DRC can provide these scores to educators. The sending district must
• provide them. Once a copy of these scores has been obtained, educators
• should review the Entrance and Exit Protocol to determine if the student
• meets Michigan’s entrance criteria. If it is determined that this student
• qualifies in Michigan as an English Learner, the scores must be entered into
• the OEAA Secure Site and the student must be identified as receiving EL
• services in MSDS.

IDENTIFICATION

Which grade level cluster of the WIDA Screener do I use?

Use the following tables to determine which grade level cluster should be used. For first semester students, students should not be screened at a grade level where they have yet to receive sufficient instruction.

Cycle I – August 1 – December 1*													
Grade Level	K	1	2	3	4	5	6	7	8	9	10	11	12

For the purposes of screening, there are three groups of students to consider:

- 1st semester Kindergarten students
- 2nd semester Kindergarten students/1st semester 1st graders
- 2nd semester 1st graders through 12th graders

1st semester Kindergarten students

Because most 1st semester Kindergarten students cannot read or write, you will screen them on the Listening and Speaking sections only using the WIDA Screener for Kindergarten.

2nd semester Kindergarten students/1st semester 1st graders

Kindergartners who enroll on or after December 1 should be administered all domains of the WIDA Screener for Kindergarten (Listening, Reading, Writing, and Speaking).

2nd semester 1st graders through 12th graders

Use the on-grade level WIDA Screener form for students.

My district has identified at least one student as being an EL. How do we go about giving services and instructional programs?

SCORES & REPORTS

3. Do I need to enter screener scores into the OEAA Secure Site?

Yes. Upon the completion of assessing a student, scores should be entered into the [OEAA Secure Site](https://baa.state.mi.us/BAASecure/Login.aspx) (<https://baa.state.mi.us/BAASecure/Login.aspx>). Please note that the OEAA Secure Site will only calculate proficiency levels for students in Kindergarten. Educators do not need to use the WIDA calculator on the WIDA website. Below is a table showing what type of scores must be entered on the OEAA Secure Site:

Online WIDA Screener (Grades 1-12)

Enter proficiency levels for each domain from the WIDA AMS report on the OEAA Secure Site.

Paper/Pencil WIDA Screener (Grades 1-12)

Enter raw scores into the [WIDA Screener Paper Score Calculator](https://wida.wisc.edu/assess/screener/paper/calculator) at <https://wida.wisc.edu/assess/screener/paper/calculator>. Then enter the proficiency levels for each domain on the OEAA Secure Site.

Kindergarten WIDA Screener

Enter raw scores into OEAA Secure Site (do not use the WIDA Calculator). The OEAA Secure Site will calculate the proficiency levels. Reports can then be accessed through the OEAA Secure Site. Districts must also keep results in the student's cumulative folder. MDE recommends printing the report that can be generated from WIDA AMS for online testers, the scoring sheet from the last page of the Student Response Booklet, or using the WIDA Screener for Kindergarten Summary Scoring Sheet.

Additionally, districts are required to notify parents and guardians within 30 days after the beginning of the school year or 10 days during the school year after their student enrolls regarding participation in EL services if the student is eligible. This notification includes providing parents or guardians with the student's level of English language proficiency, how the student was assessed, and the status of achievement. The WIDA Screener reports can be used for this purpose. Screener results should also be kept for monitoring purposes.

Can I download results for the Online Screener from WIDA AMS?

A downloadable file (Excel, .csv, etc.) is currently not available from WIDA AMS. PDF reports are the only report options at this time.

Will I be able to download screener results and reports from the OEAA Secure Site?

Yes. Reports are available on the [OEAA Secure Site](#) for students whose screener scores have been entered into the OEAA Secure Site. WIDA SECURE PORTAL ACCOUNTS

I am a new district test administrator/test coordinator and I need a login for the WIDA website. What do I do?

If you are a new test administrator, talk to your District EL Assessment Coordinator so that he or she can create an account for you. If you are a new District Coordinator, review the [WIDA Secure Portal](#) chapter of the [Assessment Coordinator Training Guide](#).

I am a district test administrator/test coordinator. What does my WIDA Secure Portal account give me access to?

Your WIDA Secure Portal account gives you access to many of the screener materials, training modules for the screener, and the summative ACCESS for ELLs and Alternate ACCESS for ELLs assessments. You can download and print many materials from the [WIDA website](#) (<https://wida.wisc.edu/>).

I have my username and password, but the system still does not allow me to log in. What do I do?

Make sure you are logging into the correct [WIDA website](#) (<https://wida.wisc.edu/>). If it does not work, contact WIDA Help by sending an email to help@wida.us or call 1-866-276-7735 to request assistance.

OEAA SECURE SITE ACCOUNTS

WIDA AMS

Do I need to Pre-ID students in the OEAA Secure Site first in order for them to show up in WIDA AMS?

No. The WIDA Screener is the only assessment for which educators do not need to Pre-ID students in advance of testing them. Educators should follow the directions for adding students exactly as they are noted in the WIDA AMS Guide for the WIDA Screener only. Please note that this does not hold true for the summative WIDA ACCESS for ELLs.

What student number should I enter into WIDA AMS in order to setup an online testing session?

Educators should enter the student's UIC.

How do I get access to WIDA AMS in order to administer the Online WIDA Screener?

Educators will need access to the OEAA Secure Site in order to access WIDA AMS. Review the [WIDA AMS Basics](#) chapter of the [Assessment Coordinator Training Guide](#).

I need to score the Writing and Speaking domains of the WIDA Screener. How do I add the WIDA Screener scoring permission to my WIDA AMS account?

Michigan District Test Coordinators are responsible for having their educators' scoring permissions assigned in AMS. The following process should be used for Michigan:

1. Identify all educators who will be responsible for scoring the WIDA Screener Online writing and/or speaking tests.
2. Verify that all educators have completed the necessary training to obtain certification to score the WIDA Screener writing and/or speaking tests. District Coordinators can review scoring certifications in their [Secure Portal account](https://wida.wisc.edu/login) (https://wida.wisc.edu/login).
3. Contact DRC Customer Service at **1-877-560-8378, Option 3** or email wida@datarecognitioncorp.com and request assignment of user scoring domains.
4. Provide Customer Service with the following information for all users that need to be assigned in order to score:
 - a. User Name
 - b. User Email
 - c. Domain to be assigned (Writing, Speaking or both)
5. Customer Service will assign the users as indicated which will allow them to begin scoring tests within the Educator Scoring application in WIDA AMS.

TRAINING

Do I need to attend a live training?

No. However, districts and educators need to ensure that they have reviewed the online training modules and passed all associated quizzes.

Also be sure to have a comprehensive grasp of the following topics:

- General screener structures (domains, adaptivity, grade level clusters, scoring, etc.)
- Writing rubrics and practice scoring writing
- Speaking rubrics and practice scoring speaking responses using the samples available on WIDA’s website.
