Detroit City Public Schools (DPS) had an ATtB in the bottom 10 percent for all schools. Additionally, DPS had the following oversight issues: one or more public school academy contracts with more than two deficiencies; one or more PSAs which submitted the 2013 audit late or had findings in the submitted 2013 audit; and one or more PSAs did not meet the transparency requirements.

Eastern Michigan University (EMU) had an ATtB in the bottom 10 percent for all schools. Additionally, EMU had the following oversight issues: one or more PSAs had audit findings in the submitted 2013 audit; and one or more PSAs with a budget deficit.

Education Achievement Academy (EAA) had an ATtB in the bottom 10 percent for all schools. Additionally, EAA had the following oversight issues: one or more PSAs had audit findings in the submitted 2013 audit; and one or more PSAs did not meet the transparency requirements.

Ferris State University (FSU) had an ATtB in the bottom 10 percent for all schools. Additionally, FSU had the following oversight issues: one or more PSAs which submitted the 2013 audit late or had findings in the submitted 2013 audit; and one or more PSAs with a budget deficit.

Grand Valley State University (GVSU) had an ATtB in the bottom 10 percent for all schools. Additionally, GVSU had the following oversight issues: one or more PSAs submitted the 2013 audit late or had findings in the submitted 2013 audit; one or more PSAs with a budget deficit; and one or more PSAs did not meet the transparency requirements.

Highland Park Public Schools (HPPS) had an ATtB in the bottom 10 percent for all schools. Additionally, HPPS had the following oversight issues: one or more PSAs had findings in the submitted 2013 audit; and one or more PSAs with a budget deficit.

Kellogg Community College (KCC) had an ATtB in the bottom 10 percent for all schools. Additionally, KCC had the following oversight issue: the PSA contract had more than two deficiencies.

Lake Superior State University (LSSU) had an ATtB in the bottom 10 percent for all schools. Additionally, LSSU had the following oversight issues: one or more public school academy contracts with more than two deficiencies; one or more PSAs which submitted the 2013 audit late or had findings in the submitted 2013 audit; and one or more PSAs did not meet the transparency requirements.

Muskegon Heights School District (MSHD) had an ATtB in the bottom 10 percent for all schools. Additionally, MSHD had the following oversight issues: one or more PSAs had findings in the submitted 2013 audit; one or more PSAs did not meet the transparency requirements; and one or more PSAs with a budget deficit.

Northern Michigan University (NMU) had an ATtB in the bottom 10 percent for all schools. Additionally, NMU had the following oversight issues: one or more public school academy contracts with more than two deficiencies and one or more PSAs had findings in the submitted 2013 audit.

Macomb Intermediate School District had an ATtB in the bottom 10 percent for all schools.
