### MDE Releases Second Round of Surveys to Gather ESSA Feedback

The Michigan Department of Education (MDE) has opened a second round of surveys for individuals interested in providing feedback on the development of the state's plan for the federal Every Student Succeeds Act (ESSA). This set of surveys seeks comments on the draft recommendations of the Action Teams that the MDE has convened to review specific focus areas within the state plan and the federal law.

Now through January 16, 2017, education stakeholders can choose from four feedback options on the <u>ESSA web page</u> (www.michigan. gov/essa) under the **Get Involved** tab.

### **Option 1** – Detailed surveys for Feedback Forum attendees/viewers

Individuals who have attended or viewed a recent Feedback Forum hosted by the MDE are invited to respond to a set of detailed surveys that ask questions related to the information presented at those events. A recorded Feedback Forum is available on <u>MI Streamnet</u> (http://mistreamnet.org/). Individuals who DID NOT attend or view a forum can still choose to complete this version. However, before completing this detailed survey, we recommend participants watch the related video presentations that provide background information for each question.

### Feedback Forums Engage Educators, Other Stakeholders

The Michigan Department of Education (MDE) wrapped up its series of ESSA Feedback Forums on December 19, 2016, with a two-hour event at the Jackson Intermediate School District. The Forums offered educators, parents, and the public the opportunity to learn about specific components being considered for Michigan's ESSA Plan. The Forums featured presentations and dialogue around federally-funded programs for students, equitable access to high quality teachers and leaders, assessments, and accountability.

More than 500 individuals attended forums held in seven intermediate school districts (ISDs) around the state. Others tuned into a live-streamed event at Wayne RESA or have viewed the recording available on <u>MI Streamnet</u> (http://mistreamnet.org/). Participants represented various stakeholder groups, including parents, policy-makers, community members, arts advocates, teachers, principals, central office administrators, and others interested in improving Michigan's education system.

The feedback gathered during the Forums will inform the final ESSA plan, which will guide how Michigan leverages federal funding to make Michigan a top 10 education state

within the next 10 years. Forum participants, as well as the general public, can also provide additional feedback through a set of newly released surveys (see article on <u>page 1</u>). Additional input will come from focus groups held with a variety of targeted stakeholder groups during early 2017.

#### FEEDBACK

Feedback is categorized and routed to appropriate Action Teams at MDE

MDE officials will incorporate all feedback submitted into the final draft ESSA Plan, which is expected to be released for a third round of public comment in early 2017. Michigan's final plan is expected to be submitted to US Department of Education in April 2017.

### New Federal Resources to Help States and School Districts Improve Testing

The White House and the US Department of Education (ED) have announced new efforts designed to help states and school districts improve their assessments and help them evaluate the totality of their assessments in order to eliminate unnecessary or low-quality tests. The announcement was made during a December 7, 2016 event that gathered together state and district leaders, educators, parents, technologists, developers, and philanthropic leaders to discuss the impact of President Barack Obama's Testing Action Plan and what more can be done to ensure that tests are better, fairer, and fewer.

New resources include:

- \$8 Million in grants to make tests better: The ED announced nearly \$8 million in funding to the Maryland State Department of Education and the Nebraska Department of Education through its Enhanced Assessment Instruments Competitive Grant Program (EAG). The two projects funded this year support the work of two consortia that represent eight states to develop high-quality science assessments.
- Regulations to create better, fairer, and fewer assessments under the Every Student Succeeds Act (ESSA): The ED released two
  <u>final regulations</u> designed to give states and school districts clarity and flexibility as they implement the assessment provisions under Title I of the ESSA. These regulations seek to clarify the statutory requirement that states administer high-quality, annual assessments to all students by ensuring that these assessments are worth taking and provide meaningful data about student success and equity for all students. The regulations also encourage states and districts to continue to push the field of assessment forward through innovation.
- Guidance to states on how to use federal resources to create better, fairer, and fewer tests: The ED also released non-regulatory guidance for states and school districts that highlights flexibility in ESSA for how states and districts can use federal funds to support the President's Testing Action Plan. This ESSA guidance applies starting in the 2017–2018 school year and updates previous guidance ED released earlier this year.

- Profiles of districts that are taking action to improve assessments: The ED released profiles highlighting the steps taken by two districts, <u>Eminence Independent Schools (KY)</u> and <u>Vancouver</u> <u>Public Schools (WA)</u>, to reduce and improve assessments. These profiles build on <u>a report</u> the Department released in April, highlighting the work of leading states and districts to improve assessment and ensure class time is preserved.
- Information on technology-delivered assessments supported by the Institute of Education Sciences: The Institute for Education Sciences (IES) released a <u>blog that highlights some</u> of the technology-delivered assessments funded through IES. Later this month, IES will release a more detailed report highlighting the technology-delivered assessments and innovations in the assessment field funded through three research programs.

# Questions from the Field.....

Am I right in my understanding that the proposed accountability system will allow schools to earn a range of points (0-100) for each criteria versus the all-or-none model being used currently?

Yes, under the state's current proposal for accountability, a school would get partial credit for getting close to a target and will get proportional credit for what is achieved.

### ESSA often uses the acronym "LEA." What does "LEA" mean?

"LEA" stands for Local Education Agency. In Michigan, this typically can describe a local public school district, an intermediate school district, or public school academy. An "SEA" is a State Education Agency such as Michigan Department of Education.
