What is a Focus School?

- Focus Schools are identified as the ten percent (10%) of Michigan schools having the widest gap in student achievement between their lowest and highest performing students

How was our school identified as a Focus School?

- The Top-to-Bottom Ranking uses 3 metrics:
 - ✓ Achievement
 - ✓ Improvement in Achievement
 - ✓ Gaps in Achievement

All Focus Schools

- Focus Schools are in a four-year cohort beginning with their first year of identification (2013 cohort this year)
- This designation will appear on the school's Scorecard. If a 2013 cohort school is no longer identified in 2017-18, the school is no longer listed as a Focus School and leaves its cohort.
- Any year between now and 2017-18 in which a school is not identified as a Focus School, the requirements and supports are conditionally suspended.
- If a school is not identified and then re-identified between now and 2017-18, the requirements and supports match its cohort year.

What do we do now?

1. Participate in the **Superintendent's Dropout Challenge**: Identify 10 – 15 students who are at risk due to:
 - Attendance
 - Behavior Problems
 - Course/Class Proficiency

What do we do now?

2. All districts with Focus Schools are expected to:

- Conduct Data Dialogues with their Focus Schools to identify teaching and learning priorities that are likely to close the achievement gap
- Ensure that the school post the identified teaching and learning priorities in ASSIST by November 25th and includes these in the spring revision of the SIP

What do we do now?

3. All districts with Focus Schools are expected to:

- Participate in district-level Data Dialogues on systems-level changes needed to support the rapid change needed in Focus Schools
- Implement necessary actions to facilitate change in support to Focus Schools
- Revise the District Improvement Plans to reflect these system improvements

What do we do now?

4. All Districts with Focus Schools are expected to:

- Monitor and evaluate the Focus School's School Improvement Plan to ensure that teaching and learning priorities to close the gap are included
- Report to the School Board quarterly on the progress in the Focus Schools

Title I Additional Requirements

5. Notify parents in the Focus School's attendance area of this identification by August 23. This is described in another presentation.
6. There are Title I set-aside requirements that begin in the second year of identification for Title I schools and in the third year of identification for Title I districts. These are described in another presentation.

Title I Additional Support

- All Title I District with Focus Schools will be assigned a District Improvement Facilitator who will work with central office staff for approximately 40 hours during the school year to provide assistance in completing the requirements.

Next Steps

- Develop a plan to address internal and community communications regarding the Focus school designation
- If your school is a Title I school, determine who from central office will be working with the MSU-assigned District Improvement Facilitator
- Begin to implement the requirements as outlined here
