United States Department of Agriculture (USDA) Farm to School Census

We are excited to announce that Michigan is currently in **third place** for USDA's 2019 Farm to School Census responses! But we need your help to get to **first place** and show everyone how much Michigan schools value their local agriculture!

If you have not yet completed the Census, you still have time! The deadline date is December 3, 2019. Remember, your School Food Authority's (SFA's) *personalized* Census link was sent to your food service director by email from Abt Associates. If you lost your unique link or have any questions about completing the Census, please contact the Abt study team toll-free at 855-452-5794 or e-mail farmtoschool@abtassoc.com.

On-site Monitoring

Every school year, each National School Lunch Program (NSLP) sponsor with more than one school building must perform at least one on-site review of the lunch counting and claiming system in operation at each building. The on-site review must take place prior to **February 1** of each school year. If the review discloses problems with a school's meal counting and claiming procedures, the sponsor must ensure that the school completes corrective action, and within 45 days of the review, conducts a follow-up on-site review to determine that the corrective action resolved the problem(s).

Sponsors must review 50 percent of buildings operating school breakfast programs by **February 1**. The following year, the other 50 percent of buildings operating school breakfast programs must be reviewed.

As a best practice, the Michigan Department of Education (MDE) School Nutrition Programs encourages sponsors with only one building to conduct an on-site review each year, although not required.

If the SFA participates in the NSLP Afterschool Snack Program, reviews must be completed two times per year. The first review must be during the first four weeks that the snack program is in operation. The second review must be conducted during the second half of the school year.

Each on-site review must ensure the school's claim is based on the counting system, as implemented, and yields the actual number of reimbursable free, reduced-price, and paid lunches served for each day of operation.

New forms will take effect School Year (SY) 2019-2020. During SY 2019-2020, sponsors may use the new forms or continue using previous forms from SY 2017-2018 if you have already started the monitoring process. For the self-monitoring forms, visit the School Nutrition Programs website at SNP Website. The forms are located under What's New.

Procurement Updates

As a reminder, on June 20, 2018, Office of Management and Budget (OMB) released a memo that changed the **micro purchase** threshold to \$10,000 and the simplified acquisitions (small purchase) threshold to \$250,000. See the revised USDA memo SP 20-2019-Revisedⁱⁱⁱ for further details on the threshold updates. This memo also indicates some simplification of procurement and creates more uniform procurement requirements for all Child Nutrition Programs.

The State of Michigan follows the new federal thresholds for **services** of \$250,000 and **micro purchase** of \$10,000. However, Michigan maintains a more restrictive threshold for **food** purchases of \$100,000 for public school districts, academies, and ISDs. The threshold for **supplies and equipment** for public school districts, academies, and ISDs in Michigan was recently updated to \$24,924 on September 26, 2019.

The Office of Health and Nutrition Services is currently working on updating our instructions, guidance, and tools to reflect these changes. Local Wellness Policy

This is a friendly reminder that sponsors are required to complete their **first** Local Wellness Policy (LWP) triennial assessments by June 30, 2020, per 7 CFR 210.31(e)(2). These are monitored through the Administrative Review. MDE resources regarding LWP and the triennial assessment, including the MDE Triennial Assessment template, can be found here at LWP Resources. ix

In addition, USDA, Food and Nutrition Services (FNS) recommends the <u>WellSat Tool</u>^x as a resource to conduct the LWP triennial assessment. There are also a <u>variety of other</u> <u>assessment tools</u>^{xi} that can be used to assess all or part of the LWP requirements. Additional resources schools can use to improve and update their policies include the <u>Alliance for a Healthier Generation Model Wellness Policies Resource</u>^{xii} (reviewed by USDA) and the <u>FNS LWP Outreach Toolkit</u>.^{xiii}

Questions of the Week

Hot Chocolate Milk

Question: How should hot chocolate milk be offered as a menu item?

Answer: First and foremost, as part of a reimbursable meal as an additional milk choice. It can also be offered as an a la carte option.

.....

Question: What type of milk can I use?

Answer: The USDA now allows all schools to serve fat free or low fat (1%) flavored milk with a reimbursable meal. Many processors offer low fat (1%) chocolate milk in half-gallon or gallon containers. Check with your processor for availability.

Question: How do I heat chocolate milk?

Answer: Chocolate milk can be heated on a stovetop, in a tilt skillet, steam jacketed kettle or steam cabinet. It is not recommended to use a traditional coffee percolator urn, because they get too hot and will burn the milk. Heat to 145° F. Critical Control Point: hold at 145° F or higher.

Lattes

Question: Are lattes allowed in high schools?

Answer: Yes. According to USDA Smart Snack rules, milk and coffee drinks are allowed in high schools only.

Question: Why serve lattes in schools?

Answer: Lattes are a popular beverage among students and adults. According to the National Coffee Association, 37 percent of 13-18 year olds drink coffee products and the number is growing. Fifty percent of 25-39 year olds drink espresso products. Many students and staff purchase coffee drinks on their way to school. Take advantage of this trend and sell lattes at school.

Lattes contain more milk than coffee. Students receive the nutritional benefits of 9 essential nutrients in milk, but in a form that is on trend.

Question: Can a latte be part of a reimbursable meal?

Answer: Technically, no, it is an a la carte item. However, a student could purchase a meal and then take their milk to the latte station. That milk could be made into a latte and they would have a discounted price. For example, a student that used their meal milk would pay \$2 and a student who only purchased a latte would pay \$3. Another example would be "for \$1 more, make your milk a latte."

The United Dairy Industry of Michigan (UDIM) has free promotional kits for lattes and hot chocolate milk. They can be ordered by visiting <u>UDIM</u>.xix
