SNAP PEBT

- Total amount issued: \$142,565,504.00
- Children: 739,428
- The number of children may be duplicative, as this total reflects what has been issued for both payments (March/April and May/June)

Non-SNAP PEBT

- Total amount issued: \$100,504,873.80
- Children: 518,601
- These payments are still in process, so this is the total as of this point in time.

Important Reminders

- Meals can be provided at all sites through USC SFSP until June 30, 2020
- A Sponsor cannot provide meals through USC SFSP and SFSP at the same time
 - check your MEGS+ application to ensure dates do NOT overlap
- Traditional SFSP MEGS+ application deadline has been extended to June 3 for sponsors with eligible sites
- Traditional SFSP can provide meals on weekends and Holidays
- Traditional SFSP can run until school starts, it cannot run alongside the National School Lunch and Breakfast Program
- Sponsors will be responsible to monitor all SFSP sites per application agreement



Which program is better for the summer (starting July 1, 2020)?

Extended NSLP

- Non-congregate meals
- Closed sites for Students Enrolled in Virtual Summer/Year-Round School Programs
- Does not require site eligibility
 If delivered, not every house is a site
- SBP/NSLP Meal Pattern
- Requires F/R/P traditional counting and claiming with roster or electronic point of sale
 - If CEP can use count sheets
- SBP/NSLP reimbursement rates

Traditional SFSP

- Non-congregate meals
- Open sites
- Requires site eligibility
 - If delivered, every house is a site
- SFSP Meal Pattern
- Claim all meals as free
- SFSP reimbursement rates



Cash Management System (CMS) Overpayment Notifications

- Payments simply moved from one grant number to another
- Overpayment corresponds to an equal positive payment
- The net of these transactions is zero

Required for COVID19 CARES Act reporting



USC SFSP ACCOUNTING UPDATE

For all revenues and expenditures:

- SFSP Grant Code 858 in Food Service Fund (Fund 25)
- Track separately from regular SFSP if possible, as "other"
- Operating cost records will help if emergency funds are offered
