MDE extended the 2020 SFSP MEGS+ Application due date until June 3, 2020. Please complete the application as soon as you can.

USDA Extended Waivers

Waiver #22: Nationwide waiver to allow non-congregate feeding in the Child Nutrition Programs - EXTENSION to August 31, 2020.

- Program operators may provide non-congregate meals during COVID-19. Allows for meal service using grab-and-go and meal delivery options.
- Applies to NSLP, SBP, CACFP, and SFSP.

Waiver #23: Nationwide waiver to allow meal service time flexibility in the National School Lunch Program, School Breakfast Program, and Child and Adult Care Food Program - EXTENSION to August 31, 2020.

- Along with the approved Michigan Summer Food Service Program meal service time flexibility waiver, all sponsors can provide multiple meals at one distribution with no time of day restrictions. Sponsors may establish meal service times that support streamlined access to nutritious meals.
- Applies to NSLP, SBP, CACFP, and SFSP.

Waiver #24: Nationwide waiver to allow meal pattern flexibility in the child nutrition programs - EXTENSION to June 30, 2020.

- Allows state agencies to approve meal pattern flexibility in the event of supply chain disruptions that are supported by local operator documentation and pre-approval by the state agency.
- Applies to NSLP, SBP, CACFP, and SFSP.

Waiver #25: Nationwide waiver to allow parents and guardians to pick up meals for children - EXTENSION to August 31, 2020.

- Program operators may distribute meals to a parent or guardian to take home to children. Program operators must maintain program accountability and integrity. This waiver also applies to adults picking up meals for adults in the adult portion of the Child and Adult Care Food Program.
- Applies to NSLP, SBP, CACFP, and SFSP.

Sponsors **do not** need to apply for waivers 22, 23, and 25 through MDE. Participation in these waivers remains a local decision but pre-approval to participate is not required by the State Agency. Waiver 24 requires pre-approval by MDE.

What does this mean for sponsors?

- The Unanticipated School Closure SFSP meals must end by June 30, 2020.
- Sponsors approved to participate in the traditional Summer Food Service Program (SFSP) will “flip” to SFSP on July 1. All meals served between July 1 through August 31:
 - Can be served at approved SFSP locations. This includes mobile routes and meal distribution/pick up locations.
 - Can be picked up by parents or guardians without children present.

- Can include multiple meals per distribution. Under the SFSP, two meals or one meal plus one snack are allowable per child per day. The only combination **not** allowable is Lunch and Supper. More guidance to come.
- No meals served prior to an approved SFSP application in place can be reimbursed! Please submit your SFSP application in MEGS+ as soon as possible but no later than June 3, 2020.
- Area eligibility (allowing meals to be served anywhere in the state) has **NOT** been approved through a nationwide waiver. MDE will be applying for that waiver next week, but unless or until it is approved by USDA, MDE cannot allow local sponsors to serve meals at locations that are under 50% free/reduced or are not eligible with census map data.
- Sponsors that experience a documented supply chain issue may request approval from MDE in order to claim meals that do not meet meal pattern requirements. Sponsors must make every effort to provide complete, nutritious meals to children therefore pre-approval is required prior to using the meal pattern waiver.
