New Equipment and Capital Expenditure Prior Approval Process

The OHNS Fiscal Monitoring unit is pleased to announce the release of a new equipment and capital expenditure approval process. We are excited about the overhaul and believe it will improve the equipment approval process, along with clarifying the policy and guidance requirements. This will also reduce the number of equipment requests that Sponsors must submit. The new process is more streamlined and automated which will benefit both Sponsors and MDE. The online [Equipment and Capital Outlay Request Form](#) can be found on our [website](#) as well. The new equipment process and policy goes into effect immediately.

Benefits

- The [Pre-approved Food Service Equipment List](#) includes most ordinary food service equipment. Requests will now only be for unique items or large projects.
- Eliminated the \$25,000 Rule – We eliminated the rule that required Sponsors to get approval when equipment purchases exceed \$25,000 cumulative per building per year.
- Automated Process- The [Equipment and Capital Outlay Request Form](#) is now entered online directly in GEMS MARS. No more filling out the form and emailing it to us.

- The step-by-step online process will guide Sponsors through the online form. When an approval is not required, the system will let users know.

Professional Standards Training Tracker Tool (PSTTT)

Team Nutrition just released updates to the [Professional Standards Training Tracker Tool](#) (PSTTT) based on user feedback. Users logging in training for themselves will now see “My Training History” and “Print My Certificate” under the Welcome menu to easier access to these features. Additionally, school directors will have the ability to add a new district if their district is not currently listed in the PSTTT, as well as the ability to edit information (i.e., district name, county, zip) using “Manage School Districts” found under the Employees menu.

31k Funding for Student Meal Negative Balance Forgiveness School Year 2020-2021 – Second-Round Communication

Exciting news! We have additional funding left for the 31k grant! For School Year 2020/2021 only, we were awarded \$1 million in new state school aid fund money appropriated (Section 31k) for reimbursement payments to public school districts,

charter schools and public-school academies who forgive all outstanding current student-meal negative balances.

After the first round of applications last fall, we have \$709,076.35 left in available 31k funding. We are opening a second and final round of applications soon.

Reimbursement payments can be awarded to eligible districts that apply. The second-round application will go live March 1st with a firm deadline to apply no later than April 30, 2021. *Please note: If you have received a reimbursement payment in the first round, you are ineligible to apply in this second round.*

Submissions will be evaluated and reimbursement payments for selected districts will be made within 60 days of the final deadline. The funds may be prorated if there is not enough to cover all eligible submissions.

To be eligible districts must:

- Write off current/active/enrolled student meal negative balances with a transfer from the General Fund.
 - Student Meal Negative Balances paid off from private donations or angel funds are not eligible for Forgiveness Reimbursement.
 - Previously written off negative balances are not eligible.
 - Bad debt written off for inactive students in prior school years is not eligible for this grant.
- Adopt a meal charge policy that prevents public identification and all forms of lunch shaming as outlined in State Aid Section 31k (see below)

The application will require submission of the following:

1. The transactions used to write off outstanding current student meal negative balances in the Food Service Fund with a transfer from the General Fund within the 2020/2021 school year.
2. Total amount of forgiven negative balances for current/active/enrolled students by eligibility status
3. A copy of the student roster by eligibility of negative balances for current/active/enrolled students
4. Meal charge policy that prevents lunch shaming with the specifics outlined in State Aid Section 31k as follows:
 - prohibits the requiring of students who cannot pay for a school meal or who owe a negative balance to wear a wristband or handstamp.
 - prohibits the requiring of students who cannot pay for a school meal or who owe a negative balance to perform chores or other work to pay for school meals.

- prohibits the requiring of students to dispose of a meal after it has been served because the student is unable to pay for the meal or has a negative balance.
- prohibits the direct communication with a student about a negative balance unless your district has unsuccessfully attempted to contact the student's parent or legal guardian first through telephone, mail, and electronic mail.
- prohibits discussing a negative balance with a student in the presence of other students.

Questions and Answers:

Q: How far back can we go for negative balance write offs?

A: To be eligible the negative balances must be outstanding from current students, and it must be written off from the general fund within the 2020/2021 school year. Negative balances from inactive students (bad debt) are not eligible and previously written off negative balances from prior school years are not eligible.

Q: Can I just wipe/forgive the negative balances from the Food Service Fund without a transfer from the General Fund?

A: No. It is not allowable to absorb negative balances in the Food Service Fund. They must be paid for from a non-federal funding source like the General Fund (excluding donations or Angel Funds).

Q: Does the meal charge policy have to be Board approved?

A: No, this is not a requirement. However, it is a best practice.

Q: How will I be notified if my district is chosen to receive the Forgiveness funding?

A: You will receive a notification from GEMS/MARS once the awardees have been chosen.

Q: What if I am not selected for a grant payment? Can we reverse the write off entries in the Food Service Fund?

A: No, once the negative balances are written off the Food Service Fund they cannot be reversed. The district can choose to try to collect on those negative balances within the General Fund, however.

Q: If I was denied in the first round of applications, can I apply for the second round?

A: Yes, if they are for current outstanding balances within the 2020/2021 school year.

Child Nutrition Emergency Operating Costs Reimbursement Program

The USDA Food and Nutrition Service (FNS) is offering two temporary reimbursement programs.

Purpose: To provide additional funding to sponsors whose revenues were impacted due to the pandemic

Who is Eligible: Sponsors in the School Nutrition Programs and/or Child and Adult Care Food Program

- If a sponsor had a lower reimbursement during the Spring of 2020 compared to the Spring of 2019, they will be eligible for this additional reimbursement.
- If a sponsor is eligible, they will be notified in the coming months.

Our office is working to apply to participate in these programs along with developing our implementation plan. More information will be provided when our plan is approved by USDA.

Grant Opportunities

10-Cents a Meal

The 10-Cents a Meal [grant application](#) has re-opened. Please see the Application Tips section for assistance with the application.

What is 10-Cents a Meal?

This is a competitive, matching grant for all school districts (public, PSA, or private), RCCIs, and child care centers who participate in the USDA child nutrition programs of Extended Summer Food Service Program (SFSP) during the school year, National School Lunch Program (NSLP) or the Child and Adult Care Food Program (CACFP) to receive reimbursement for buying and serving Michigan-grown fruits, vegetables, and legumes. It is open to all participants state-wide.

How does it Work?

1. Purchase local produce. You will need to purchase at least twice the amount of your grant award in local produce.
2. Serve it in your USDA reimbursable meals.
3. Make sure to promote the Michigan produce and provide some educational components about local agriculture and products.
4. Submit your receipts and invoices on a monthly basis.
5. Complete 3-4 surveys.
6. Receive reimbursement.

Application Tips

- You may access the application by using your MEIS login and password. This will allow you to save the application and return to it. If you login as Guest, you will have to complete the application at one time.
- The application has FOUR sections that you need to complete – Contact Information, Budget Detail, Assurances and Program Information. These may be found on the drop down menu on the left hand side (Under Select).
- The Program Information section includes current local, minimally processed produce purchasing and how it's used in your program(s), current farm-to-school partnerships, marketing plans for local purchasing initiatives, and project goals including educational efforts.
- The more thorough your application response is, the better chance you will have to be granted funds.
