Food Service funds may be used to buy supplies or equipment for the school garden or school farm if they are used within the context of the school meal programs and serve the purpose of operating and improving the school meal program only. Note: The items above are not allowable if they are permanent, immovable structures.

Permanent structures are considered capital infrastructure costs, which are not allowed with Non-profit Food Service Account (NFSA) funds.

- Air Conditioning
- Security Cameras/Systems
- Public Announcement Systems
- Contingency Fees
- Infrastructure Costs
- Additional square footage for kitchen or cafeteria expansions
- Fans (Comfort Items)
