INTRODUCTION

The National Association of School Nurses defines school nursing as a "a specialized practice of nursing, protects and promotes student health, facilitates optimal development, and advances academic success. School nurses, grounded in ethical and evidence-based practice, are the leaders who bridge health care and education, provide care coordination, advocate for quality student-centered care, and collaborate to design systems that allow individuals and communities to develop their full potential". (National Association of School Nurses (NASN), 2017).

The practice of the 21st Century school nurse is based on leadership, community health/public health, care coordination, quality improvement and standards of care. (NASN, 2016) The care is student-centered and occurs within the student's family and school community. (NASN, 2018)

The school nurse may be the only healthcare provider in the school setting. The school nurse serves as a liaison between school personnel, family, community, and healthcare providers to advocate for health care and a healthy school environment. "The role of the school nurse has expanded to include critical components, such as surveillance, chronic disease management, emergency preparedness, behavioral health assessment, ongoing health education, extensive case management, and much more." (AAP, 2016).

Role of the School Nurse

The MDE School Nurse Certification Rules outlines the role of the school nurse in Michigan:

Care Coordination

- Assess and evaluate the health and development status of students through nursing diagnosis and the use of appropriate evaluative techniques.
- Interpret nursing assessments of medical evaluations to the students, their parents, and school
 personnel and provide an understanding of implications for the educational performance of
 students, while recognizing and maintaining the confidential nature of the information.
- Recommend to parents and appropriate school personnel modifications in the educational program as indicated by the health and developmental status of students.
- o Interpret health information when serving as a member of a special education placement committee or other programs in which health information is desirable.
- Identify and recommend students for placement in special programs, initiate referrals for supplemental testing when health information or developmental history indicates, and refer students to appropriate personnel when necessary.

Community Health/Public Health

- Serve as intermediary between the school and the home, licensed health care provider and health and social agencies regarding the health status of students and their needs for consideration in future community health planning.
- Assist students and their families to obtain optimum health and well-being by stimulating behavior change through the educative process, including individual or group counseling.

Leadership

- Assume leadership in the development and revision of written health related policies.
- Stimulate incorporation of health education in the school curriculum by serving on curriculum committees, serving as a consultant and resource person or participating in teacher-parent education programs.
- Recommend and implement school policies to comply with established health laws, and make specific recommendations to students and school personnel regarding immunizations, communicable diseases, and emergency preparedness.
- Plan a course of action and assist students, their parents, and school personnel in assuming proper roles for eliminating, minimizing, preventing, or understanding the health problems that interfere with effective learning by the student. This may include the provision or related nursing services as required by law.

Quality Improvement

o Participate in data collection at both the state and national level.
