Would you like to submit your August claim?


- If you haven't submitted your SNP application and had it approved – you may miss the deadline (Monday!!)
- Also, if you haven't created a MILOGIN account AND linked it to your MEIS account, you will not be able to claim!
 - This is a requirement to submit claims and for when we transition to our new system, NexSys.
 - If you haven't done this already, please do so as soon as possible. [Instructions](#) on how to complete this are available.
 - By getting this step done now, it will save time and added stress on Friday!

How to Claim SSO Meals

- Seamless Summer Option (SSO) meals must be claimed under the School Nutrition Program claim, not the Summer Food Service Program claim.
- Even if you only had a few school days in August, these meals must be claimed under the School Nutrition Program Claim. Do not combine these claims with your August SFSP claim.
- [Instructions](#) on how to enter a School Nutrition Program claim in MIND 2.0 are available.
- Submit your School Nutrition Program claim by **November 1, 2021**, to avoid a late claim.

Low-Fat (1%) Flavored Milk

- Consolidated Appropriations Act allows low-fat (1%) flavored milk in NSLP and SBP through December 3, 2021.
- You may already be approved through the Meal Pattern Flexibility Waiver (#90) for School Year 2021-2022 .
- Note: the 1% flavored milk flexibility from the Consolidated Appropriations Act and the Meal Pattern Flexibility Waiver (#90) do not apply to competitive foods (Smart Snacks).
 - The sale of 1% flavored milk is not allowed outside of the reimbursable meal.
 - MDE is going to submit a waiver request to USDA

Supply Chain Disruptions & Emergency Procurement

Menu Planning and Substitutions

- Plan menus according to meal pattern requirements.
- When shortages happen, do the best you can to meet the meal pattern with what is available.
- Show that you did your due diligence in meeting the meal requirements.
- Use Meal Pattern Flexibility Waivers as needed.

Emergency Procurement

- Non-competitive procurement is allowed when sponsors are experiencing supply chain disruptions.



Required Documentation



Emergency procurement, supply chain issues, and menu substitutions must be documented.

Documentation may include:

- Distributor receipts showing out of stock items and substitutes
 - Vendor invoices
 - Vended meal delivery tickets with specific items delivered
 - Email communication (or phone calls)
 - Production records and/or menus showing menu changes/substitutions
 - Other written or typed notes detailing the situation

Supply Chain and Special Diets



- One safe meal is required. It does not have to be the same as the regular menu.
 - Meals offered can be repetitive, even if it means they have the same breakfast each day or the same lunch entrée or side, as long as it is safe for the child to eat.
 - With items in short supply, it may be a good idea to keep a stock of verified “safe” foods for the student.
 - Collaborate with and keep the guardian(s) informed of supply chain issues that may affect their child’s meals to ensure equal access and participation.
 - Work with your vendor to ensure you have safe foods for the child.
 - If your vendor is out of stock, you may use emergency procurement to obtain what you need locally or from another vendor to ensure the child’s safety.

Verification for School Year 21-22

- The USDA has confirmed that school districts do need to conduct verification this school year.
- The Verification sample should be based on approved current school year applications as of October 1, 2021.
- Whether you are currently participating in Seamless Summer Option (SSO) or the National School Lunch Program (NSLP), all schools and districts that collected free and reduced-price applications are required to conduct verification.
 - CEP Schools do not collect F/R applications, so they do not complete verification.
 - Districts that are partial CEP must conduct verification for the non-CEP schools.
- The USDA determined that verification is still necessary and required because school meal applications are used to establish eligibility for Pandemic-EBT.

P-EBT Update

- Summer P-EBT benefits were dispersed recently on all pre-existing accounts.
- P-EBT 3.0 (SY 21-22) for Michigan is currently being applied for by MDHHS.

10 Cents a Meal Update

- Updates to invoice and meal counts submission.
 - FarmLogix system will be ready in a few weeks.
- First required survey this week.
 - MSU is our evaluation partner.
 - Plans, barriers, educational activities, Michigan-grown produce served.
- Additional application window later this winter.

SY 2021-2022 SSO Adult Pricing Guidance

- SSO impact on Adult meal pricing has been determined by the USDA.
 - Because SSO uses SFSP Reimbursement Rates the minimum adult price requirement is higher than normal NSLP.

SSO Adult Meal Pricing Requirements







- **SSO Breakfast Pricing**

SFSP Breakfast Reimbursement Rate (2021)	\$2.4625
Subtotal	\$2.46
Sales tax	\$0.15
Total minimum Adult price	\$2.61

- **SSO Lunch Pricing**

SFSP Lunch Reimbursement Rate (2021)	\$4.3175
Lunch Commodity Entitlement Rate (SY 2021-2022)	\$0.260
Subtotal	\$4.58
Sales tax	\$0.27
Total minimum Adult price	\$4.85

- Ensure equal or greater revenue is received for adult meals compared to student meals
 - For the equivalent student Type-A meal
 - No additional food items can be added to adult meals without also raising the selling price
- Effective until December 31, 2021
 - New SFSP rates become effective January 1, 2022
- Current Revenue for Student Meals is \$4.58

- The Financial Information Database (FID) School Meals Report closes November 1st

CACFP Application is Now Open!

- All institutions and sponsors participating in the Child and Adult Care Food Program (CACFP) are required to complete and certify their application for FY 2022 to participate.
- The application is found at Michigan Electronic Grants System Plus (MEGS+) [Michigan Education Information System \(MEIS\)](https://www.michigan.gov/meis) (www.michigan.gov/meis)
- Schools who operated a successful SFSP in school year 2020/2021 are not required to complete CACFP budget worksheets and the full management plan for FY 2022 to participate!
- These schools must initiate their CACFP application, make any changes/updates, and certify their application to participate in FY 2022.

CACFP Meal Pattern Flexibility Waiver




- For CACFP Sponsors only– do not complete if do not participate in CACFP.
 - **Request waiver for the following CACFP requirements:**
 - Serve WGR item once per day across claimed meal services
 - Full implementation of grain ounce equivalencies on October 1, 2021
 - Low fat milk (1%) must be unflavored for participants age 6 and over
 - Provide specific reasons why flexibility is needed when completing waiver request.
 - CACFP Waiver Request Form is found under Resources at www.Michigan.gov/cacfp
 - **All other CACFP meal pattern requirements remain in effect.**

What is Unanticipated School Closure (USC) SFSP?

- In the event of unanticipated school closures (extreme cold day, snow day, water main break, frozen pipes, electrical issues, flooding, natural disasters, etc.) sponsors may participate in USC SFSP. Sponsors that have participated in the SFSP within the past 2 years are eligible to participate in USC SFSP. Nationwide waivers for school year 2021/2022 allow any location to be a site in USC SFSP.

Required Annual Training for Food Service Directors & Staff


Annual training is still required.

Flexibility for training to be completed over 2 consecutive years.


- Some training hours must be completed each school year (July 1 – June 30).

Required annual training includes:




- Civil Rights
- Food Safety refresher for staff
- Offer vs Serve, if applicable

- USDA has specific hiring and training standards for a school nutrition program director.
 - Non-compliance may result in findings during an administrative review.
 - Potentially including unallowable costs for the salary and benefits of a director hired that does not meet the required standards.
 - With a food service management company (FSMC) or a vended meal contract, the SFA maintains oversight of the school meal programs.
 - This means business managers or others at the LEA level who oversee the FSMC or vended meal contract must meet the required standards.
 - In addition, the employee placed on-site by the FSMC to manage the day-to-day operations is considered the FSD and must meet education and experience requirements, based on the student enrollment size.
