

Office of Health and Nutrition Services Fiscal and Administrative Services Monitoring Team Completing the Excess Fund Balance Spend Down Plan of Action Form

This document provides instructions to assist Sponsors with completing the Spend Down Plan Action process for an Excess Fund Balance.

Introduction

Because Child Nutrition Programs must operate a Non-profit Food Service Account (NFSA), Sponsors are required to limit their fund balance and invest the proceeds back into the food service program to benefit children. Three-months average expenditures are allowed in what is called the Net Cash Resources or a Sponsor's Allowable Fund Balance. An Excess Fund Balance (EFB) occurs when the NFSA Fund Balance exceeds three months average expenditures (Allowable Fund Balance) at year end.

Spend Down Plan of Actions (POA) are required by the Michigan Department of Education (MDE) for all Sponsors with an EFB at year end. Sponsors must take steps to reduce its Net Cash Resources through an acceptable Spend Down POA for at least the entire amount in excess funds. Since program funds must be used only for food service program purposes, excess funds must be reduced by investing in the program through improving the quality of food served, purchasing needed supplies, services, or equipment, or by adding staffing. Feel free to inquire about additional ways to reinvest back into your program.

This help guide is intended to assist Sponsors as they complete the Spend Down POA form in the Grant Electronic Monitoring System / Michigan Administrative Review System (GEMS/MARS). This guide will cover:

I. Timeline for the Excess Fund Balance Notification

MDE assesses Net Cash Resources (Fund Balance) through the Financial Information Database (FID) School Meals Report or the Child Nutrition Program Year End Report (CNP-YER) each fall to determine the amount of excess funds a Sponsor has.

EFB notices are typically sent out in January/February each year from the GEMS/MARS system. The email notices are sent to the Sponsor's Superintendent, Business Manager, Food Service Director, and Partnership Agreement Liaison (PAL) (if applicable). For Public School Academies, notices are also sent to School Board Presidents and Chartering Authorizers.

The Spend Down POA must be completed and submitted by March 14, 2023.

II. Completing EFB Spend Down POA form in GEMS/MARS

- 1. Log into GEMS/MARS
 - <u>MILogin Login (michigan.gov)ⁱ</u>
- 2. Completing the EFB Spend Down (POA) form along with a Carryover Extension if necessary.
 - A carryover extension request can be submitted the same time as the Spend Down POA form by following the steps outlined.
 - All sponsors who received an EFB notice are required to complete a Spend Down POA form per regulation.
- 3. Spend Down POA form
 - A. District Name: This field is prepopulated
 - B. District Agreement Number: This field is prepopulated



C. How many items are you purchasing? - Use the drop down to select the number of items the sponsor is purchasing.



- i. Do not select more lines than needed. A description and amount are required for each open line item.
- ii. The number of lines you select will open in the "Items to be purchased" section.
- D. Will all items be purchased and paid for by June 30, 2023? If not, you will need approval to carryover all or a portion of the Spend Down POA Use the drop down to select Yes or No to request a carryover extension.
 - i. Select <u>Yes</u> if items will be purchased and paid for by June 30, 2023.
 - a. If Sponsor answers "Yes" you do not need to check the "Carryover Boxes" in the next section.



- b. Select <u>No</u> if items will <u>not</u> be purchased by June 30, 2023.
- c. If Sponsor answers "No" you will need to select the "Carryover Boxes" in the next section for each item that needs to be carried over into the next school year.
- d. If Sponsor answers "No" enter the date you plan to resolve the excess fund balance. **Enter a date no later than June 30, 2024.**

- E. Enter Item descriptions and amounts. In the line(s) provided, identify the areas in which excess funds will be spent for Child Nutrition Programs during the school year 2022-2023.
 - i. Enter the description of items to be purchased. Multiple like items can be combined on the same line with the quantity indicated. Use separate lines to differentiate between unlike items. For example: two steam kettles or three convection ovens can be placed on the same line.

- ii. Enter the estimated cost of the items to be purchased.
- iii. Check the box if the item will be used exclusively by food service.
 - a. Exclusive to food service items are items used only by food service and are not shared with other programs.
 - b. If items are shared with another program or will benefit another program other than food service do not check the exclusive box.
 - c. Enter the amount of the purchase which applies to Food Service (FS) and the amount that applies to the General Fund (GF) if the items are shared.
 FS cannot pay for the portion of items that benefit other programs. The Total of the FS Amount plus the GF Amount should equal the Estimated Cost.
- F. The Total Cost of items must be equal to or greater than the excess fund balance.

Only enter new items on the POA. Items carried over from prior school year are included in the MDE Approved Carryover from prior school year amount, therefore they don't need to be entered on the plan or carried over again.



See the example of a shared cost below:

In this example, the Cafeteria Tables and Chairs are shared with other programs. The cost of the furniture is covered by both FS and the GF (FS amount \$32,000 and GF amount \$3,000).

III. Carryover Extension

- 1. Check the box if the items will <u>not</u> be expended by June 30, 2023. By checking this box, you are requesting a carryover extension which allows Sponsors to purchase items up to one additional year. Check the carryover extension box:
 - A. If you know right away that the items will not be purchased or paid for by June 30, 2023.
 - B. If you answered "No" to "Will all items, be purchased and paid for by June 30, 2023?"
 - C. If multiple like items are listed on the same line but carryover is only needed for some of the items, they should be separated on different lines to properly capture the exact item and amount needed for carryover purposes.
 - D. The amount in the FS Amount field will automatically populate in the Carryover Amount field if the box is checked.



- 3. To upload documents, drag and drop files in the space provided or select the "Upload" link to browse and attach supporting documents.

VI. Requesting a Carryover Extension after the Spend Down POA has been Approved

If you determine that items on the plan will not be purchased by June 30, 2023, after the Spend Down Plan is already approved, Sponsors can return to the form later to request a carryover extension. Carryover Extensions must be submitted by June 15, 2023, to be reviewed and approved by MDE prior to the spend down deadline of June 30, 2023.
