The process used to get input from LEAs regarding the distribution of amounts among the activities described in the spreadsheet is done through bimonthly meetings with our state's Educational Service Agencies (ESAs). These discussions have led to the restructuring of some of these activities as Michigan focuses on the general supervision requirements of the ESAs over their member districts.
