# Special Education Advisory Committee (SEAC)

The *Individuals with Disabilities Education Act* (IDEA) requires each state to maintain a <u>state advisory panel</u> for the purpose of providing policy guidance related to special education and related services for children with disabilities. This panel is referred to as the Special Education Advisory Committee (SEAC) and advises the <u>State Board of Education</u> and the <u>Michigan Department of</u> <u>Education</u> on policies affecting students eligible for special education services in Michigan.

#### SEAC's Mission

The mission of the SEAC is to promote positive outcomes for all Michigan students with disabilities.

### SEAC Membership

SEAC accepts nominations for membership made by the State Board of Education, organizations, and individuals.

Members serve a three-year term and come from diverse backgrounds representing all categories of students with disabilities, parents, stakeholder groups, organizations, and agencies with an interest in students with disabilities from all over Michigan.

<u>SEAC membership</u> rotates to allow any interested person to apply for an opening. Openings for SEAC are posted on the <u>SEAC website</u> as they occur.

## **SEAC Functions**

SEAC maintains six functions to fulfill each year:

- Identify unmet needs within special education and bring them to the attention of the State Board of Education (SBE) and the Michigan Department of Education (MDE).
- Comment publicly on proposed rules.
- Advise the MDE Office of Special Education (OSE) on the setting of State Performance Plan (SPP) targets.
- Advise the OSE regarding federal monitoring corrective action plans (if issued).
- Advise the OSE regarding the coordination of efforts across MDE offices as well as the unmet needs priority areas and related targets as submitted to the U.S. Department of Education (USED) through the State Systemic Improvement Plan (SSIP).
- Receive and review findings and decisions of all completed due process hearings related to special education.
