Brief description of policy:

Effective May 12, 2023, the Michigan Department of Health and Human Services (MDHHS) will end temporary Children's Special Health Care Services (CSHCS)-related COVID-19 policies MSA 20-24, MSA 21-07 (in part), and MSA 21-12.

Reason for policy (problem being addressed):

These policies were essential during the public health emergency (PHE), given the provider shortages and barriers to receiving medical care and support. Due to the end of the PHE, it is important that children are again being seen and treated by approved pediatric physician subspecialists, and that CSHCS ensure families are obtaining Medicaid when possible and correctly reporting their income.

Subject: Reversal of Temporary COVID-19 Children's Special Health Care Services (CSHCS) Policies

Effective: May 12, 2023

Programs Affected: CSHCS

The purpose of this policy is to notify all providers of the partial termination of temporary COVID-19 policies related to CSHCS.

MSA 20-24 - CSHCS Eligibility and Renewal Requirements

Issued May 6, 2020, MSA 20-24 allowed medical reports from nurse practitioners and physician assistants to be used for CSHCS eligibility and renewal in the absence of a report from a physician subspecialist. It also temporarily suspended the application of temporary eligibility periods (TEPs) during which families are issued temporary eligibility based on income level and required to apply for Medicaid. Both temporary practices are being terminated. Effective May 12, 2023, all medical reports for the purposes of eligibility/renewal of CSHCS coverage are required to be submitted by physician subspecialists. Further, CSHCS will again issue TEPs, 90-day periods of eligibility, for families whose income reported on the MSA-0738, Income Review/Payment Agreement (IRPA), indicates they may be eligible for Medicaid/MiChild/Healthy Michigan Plan. During a TEP, families will again be required to apply for Medicaid/MiChild/Healthy Michigan Plan.

MSA 21-07 - CSHCS Coverage of COVID-19 Vaccine Services and U.S. Food and Drug Administration (FDA) Emergency Use Authorization (EUA) Drugs, Devices, and Biological Products for COVID-19 Prevention and Treatment

Issued May 3, 2021, MSA 21-07 allowed for CSHCS coverage for COVID-19 vaccine services and U.S. Food and Drug Administration (FDA) Emergency Use Authorization (EUA) drugs, devices, and biological products for the prevention and treatment of COVID-19 when beneficiaries were otherwise uninsured. This policy is being terminated in part. Effective May 12, 2023, CSHCS will no longer cover FDA EUA drugs, devices, and biological products unless ordered by a beneficiary's CSHCS-authorized physician subspecialist and related to their CSHCS qualifying diagnosis. CSHCS will continue to cover COVID-19 vaccine services for all CSHCS beneficiaries, regardless of qualifying diagnosis.

MSA 21-12, Suspending Periodic Income Reviews for CSHCS Beneficiaries

Issued August 30, 2021, MSA 21-12 suspended the internal CSHCS practice of periodic and random income reviews of self-declared income at initial enrollment/renewal. Effective May 12, 2023, CSHCS will again identify families randomly for income review/verification when they submit the MSA-0738 - Income Review/Payment Agreement (IRPA), during initial enrollment and renewal. Periodic and random income reviews apply to all families/individuals who are not eligible for Medicaid, are wards of the county or state, are living in a foster home or private placement agency, are in a court-appointed guardianship, or are deceased (retroactive coverage).


