Dear Tribal Chair and Health Director:

RE: Implementation of the Legislatively Mandated Behavioral Health Treatment (BHT)-Applied Behavior Analysis (ABA) Rate Increase

This letter, in compliance with Section 1902(a)(73) and Section 2107(e)(1)(C) of the Social Security Act, serves as notice to all Tribal Chairs and Health Directors of the intent by the Michigan Department of Health and Human Services (MDHHS) to submit a State Plan Amendment (SPA) request to the Centers for Medicare & Medicaid Services (CMS).

The proposed SPA establishes a BHT-ABA service reimbursement rate for Current Procedural Terminology (CPT) code 97153 of not less than \$16.50/unit or \$66.00/hour within the Prepaid Inpatient Health Plan (PIHP) service array. The increase is a Michigan State Legislative mandate. The rate increase is intended to maintain and potentially increase access to BHT-ABA services. This increase is expected to have a positive impact on Native American beneficiaries, Tribal Health Clinics and Urban Indian Organizations. The anticipated effective date of this SPA is November 1, 2024.

There is no public hearing scheduled for this SPA. Due to the requirements within Public Act 121 of 2024, for an effective date of November 1, 2024, it is not possible to adhere to the sixty (60) days of notification. Therefore, the notification is being provided as soon as possible. Input regarding this SPA is highly encouraged, and comments regarding this notice of intent may be submitted to Lorna Elliott-Egan, MDHHS Liaison to the Michigan tribes. In addition, MDHHS is offering to set up group or individual consultation meetings to discuss this SPA, according to the tribe's preference. Consultation meetings allow tribes the opportunity to address any concerns and voice any suggestions, revisions, or objections to be relayed to the author of the proposal.
