RE: MI Health Link 1915(b) Waiver Amendment-Revision of Cost Effectiveness

This letter, in compliance with Section 1902(a)(73) and Section 2107(e)(1)(C) of the Social Security Act, serves as notice to all Tribal Chairs and Health Directors of the intent by the Michigan Department of Health and Human Services (MDHHS) to submit a waiver amendment request to the Centers for Medicare & Medicaid Services (CMS).

The purpose of this waiver amendment is an anticipated revision to the cost effectiveness benchmark for calendar year 2025.

MDHHS expects these changes to have little or no impact on Native American beneficiaries. The anticipated effective date of this waiver amendment is January 1, 2025.

There is no public hearing scheduled for this waiver amendment. Input regarding this waiver amendment is highly encouraged, and comments regarding this notice of intent may be submitted to Lorna Elliott-Egan, MDHHS Liaison to the Michigan tribes. In addition, MDHHS is offering to set up group or individual consultation meetings to discuss the waiver amendment, according to the tribe's preference. Consultation meetings allow tribes the opportunity to address any concerns and voice any suggestions, revisions, or objections to be relayed to the author of the proposal.
