Dear Tribal Chair and Health Director:

RE: Removal of Copayment for Drugs Used to Prevent HIV (Pre-Exposure Prophylaxis [PrEP] & Post-Exposure Prophylaxis [PEP])

This letter, in compliance with Section 1902(a)(73) and Section 2107(e)(1)(C) of the Social Security Act, serves as notice to all Tribal Chairs and Health Directors of the intent by the Michigan Department of Health and Human Services (MDHHS) to submit a State Plan Amendment (SPA) request to the Centers for Medicare & Medicaid Services (CMS).

The purpose of this SPA is to remove the pharmacy benefit copayment on outpatient prescription drugs used to prevent HIV, including HIV PrEP and HIV PEP drug products. This change positively impacts Tribal Health Centers by removing financial barriers to obtaining these drugs, resulting in increased access for beneficiaries not already exempt from copays. The anticipated effective date of this SPA is October 1, 2025.

There is no public hearing scheduled for this SPA. Input regarding this SPA is highly encouraged, and comments regarding this notice of intent may be submitted to Lorna Elliott-Egan, MDHHS Liaison to the Michigan tribes. In addition, MDHHS is offering to set up group or individual consultation meetings to discuss the SPA, according to the tribe's preference. Consultation meetings allow tribes the opportunity to address any concerns and voice any suggestions, revisions, or objections to be relayed to the author of the proposal.
