Dear Tribal Chair and Health Director:

RE: Reimbursement Methodology for Speech and Oral Function Therapy – Language Correction State Plan Amendment (SPA)

This letter, in compliance with Section 1902(a)(73) and Section 2107(e)(1)(C) of the Social Security Act, serves as notice to all Tribal Chairs and Health Directors of the intent by the Michigan Department of Health and Human Services (MDHHS) to submit a SPA request to the Centers for Medicare & Medicaid Services (CMS).

The purpose of the SPA is to correct language within the Medicaid State Plan page related to reimbursement rates for speech and oral function therapy to reflect the payment methodology as originally noticed and intended under SPA 24-0018.

The effective date of this SPA is on or after October 1 2025. Due to the technical nature of this SPA, MDHHS expects this change to have no impact on Native American beneficiaries.

There is no public hearing scheduled for this SPA. Due to the corrective nature of the SPA, timely submission is required, and it is not possible to adhere to the sixty (60) days notification. Therefore, the notification is being provided as soon as possible. Input regarding the SPA is highly encouraged, and comments regarding this notice of intent may be submitted to Lorna Elliott-Egan, MDHHS Liaison to the Michigan tribes. In addition, MDHHS is offering to set up group or individual consultation meetings to discuss the SPA, according to the tribe's preference. Consultation meetings allow tribes the opportunity to address any concerns and voice any suggestions, revisions, or objections to be relayed to the author of the proposal.
