Spring 2020 Packaging and Shipping Class Schedule

New Virtual Training Courses Offered

In accordance with Governor Gretchen Whitmer's executive order for social distancing to prevent the spread of COVID-19 disease, the Michigan Department of Health and Human Services, Bureau of Laboratories (MDHHS BOL) is offering online virtual Packaging and Shipping Classes through the end of May. Classes scheduled in June currently remain in-person at this time, but are subject to a change in format.

This intermediate level training course provides the participant with a comprehensive overview of Federal (DOT & USPS) and International (IATA) regulations applicable to packaging and shipping of clinical laboratory specimens in addition to an understanding of terminology, packaging, marking, labeling, and documentation requirements.

When registering for a class on the MITRAIN website, a host facility is listed for virtual classes, the class will be solely online, and **open to anyone** regardless of facility location. Registered participants will receive an email communication prior to the class with instructions on how to access the online course.

Laboratory Kit Order Tracking System (LKOTS)

In an effort to improve efficiency and overall customer satisfaction, the Bureau of Laboratories (BOL) introduced an online application for ordering and tracking of clinical and environmental testing and shipping supplies. The application is called Laboratory Kit Order Tracking System or LKOTS. This application gives the consumer the ability to track an order throughout all aspects of the ordering process. LKOTS directly communicates with the customer's email address and automatically sends notifications about status changes in the order. Additionally, LKOTS allows the user to view the BOL's entire inventory of kit supplies and components.

COVID-19 supplies are extremely limited and are only available for distribution to local county health departments. Please rely on your facility purchasing department and established vendors for specimen collection supplies. The Food and Drug Administration (FDA) website offers a list of acceptable patient collection supplies at <https://www.fda.gov/medical-devices/emergency-situations-medical-devices/faqs-diagnostic-testing-sars-cov-2>.
