## What is Crime Victim Compensation?

This program may help pay outof-pocket medical expenses, lost earnings, funeral bills, counseling or other expenses for people who have been harmed as the direct result of a crime. If you or someone you know is a victim of crime, certain expenses may qualify for Crime Victim Compensation coverage.

Crime Victim Compensation is the payer of last resort. This means that your private insurance or other public funds, if available, must be utilized first in order for you to be eligible for compensation.

Anyone can become a victim of crime. The physical, emotional and financial impact of trauma can last far beyond the crime itself. You are not alone.

Contact the Michigan Crime Victim Compensation program to learn more and to request an application.

#### Can I get help?

#### Yes! If you are:

- A person who was physically, emotionally, psychologically or mentally injured as the direct result of a crime in Michigan.
- A sexual assault victim.
- A person who was injured while trying to help a crime victim.
- An eligible person with out-ofpocket expenses as the direct result of a crime\*.
- A Michigan resident injured in another state that doesn't pay compensation for a nonresident.

#### Available benefits include:

- Medical and dental expenses.
- Loss of wages.
- Counseling for the injured person and family members.
- Nontraditional counseling and nonmedical remedial treatment.
- Residential security expenses.
- Transportation.
- Accessibility and rehabilitative equipment.
- Replacement services needed because of the person's injury.
- Temporary or permanent relocation.
- Funeral and burial expenses.
- Crime scene cleanup.
- Loss of support for dependents of the person who died.
- Grief counseling for family members.
- Bereavement for lost wages.

#### What costs are **not covered**?

- Fraud or financial crimes.
- Pain and suffering.
- Costs of participating in a trial.
- Expenses paid by other sources
   (public or private health insurance,
   life insurance, disability insurance,
   workers compensation, auto
   insurance, etc.).
