### Meeting Minutes

#### **I. Call to Order – Brian Ahmedani**

The meeting was called to order at 10:00 AM. The roll was taken, and a quorum of members were present.

#### **II. Public Comment**

There was no public present to comment.

#### **III. Review and adopt May 2020 Meeting Minutes**

A motion and a second were made to approve the May 2020 Suicide Prevention Commission meeting minutes. The minutes were unanimously approved.

#### **IV. MDHHS Updates**

##### **a. Legislative – Emily Schwarzkopf**

Emily Schwarzkopf (DHHS) introduced herself to the Commission. The Legislature has been working on the different Oversight Committees in response to COVID-19. There was a bill that passed last week in the House Education committee, is up in the House Ways and Means Committee – [HB 5482](#) will require the suicide hotline number be placed on student IDs. The bill will be for K-12 students.

##### **b. Behavioral Health – Debra Pinals**

The Behavioral Health and Disabilities Administration (BHDDA) is issuing an RFP to have establish the MI-CAL (Crisis Access Line). Creating activities to support the emotional health and wellbeing for MDHHS staff and communities to discuss issue related to structural racism, racism as a public health issue and seeking strategies and solutions.

BHDDA is reviewing data from other states for increases in domestic violence calls, suicide related to COVID and what responses need to look like. Standing up expanded crisis services from FEMA and SAMHSA.

BHDDA continues to update the [Michigan.gov/staywell](https://www.michigan.gov/staywell) website with guidance and resources related to COVID and mental/emotional health.

BHDDA has had listening sessions working with the psychiatric hospitals and there is a desire for conversation and training related to COVID-19 and suicide prevention. BHDDA is working with the Michigan Health and Hospital Association (MHA) to introduce a webinar series.

The Public Health Administration is initiating strategic planning around substance use and mental health which will have impacts for this Commission.

- c. Injury Prevention and Control – Patricia Smith  
MDHHS applied for three new grants between March and May 2020:
  - Zero Suicide Grant (SAMHSA)
  - Comprehensive Suicide Prevention Program (CDC) with focus on adult men.
  - COVID-19 Emergency Suicide Prevention Response (SAMHSA)MDHHS received notification the Youth Suicide Prevention continuation will be funded for next year, and a capacity building grant for the National Suicide Prevention Lifeline with supports for the Suicide Prevention Commission included.

## V. Commission Updates – James Bell

## VI. Subcommittee Updates

- a. Data – Zaneta Adams  
James Bell gave an update for the Data Subcommittee. The group is working on drafting the Preliminary Report. The subcommittee has been scheduled to meet biweekly until the report is completed.
- b. Policy – Jessica DeJohn  
Jessica DeJohn gave an update for the Policy Subcommittee. The group will be meeting monthly to review policies at the local, state, and national level. The group is also working on creating a tracking tool to use for updates during the Commission Meeting.

## VII. Initial Report Planning

- a. Draft Michigan Strategy  
Patricia Smith gave an overview of the draft Michigan Suicide Prevention Strategy. Brian Ahmedani and James Bell facilitated a discussion on the Initial Report to share with the legislature. The Data Subcommittee will be responsible

for drafting the initial outline, highlighting the data sources and special populations. During the July meeting, the Suicide Prevention Commission will be reviewing the first draft of the Initial Report. Revisions will take place between July and August with MDHHS review beginning in early August for a September submission.

**VIII. Other Updates**

The Executive Committee needs to meet to assess their involvement with coordinating data collection efforts with universities and MDHHS.

**IX. Next Steps**

a. Action Item Recap

Determine the date the Suicide Prevention Commission Initial Report must be submitted.

James will schedule an Executive Committee Meeting to review purpose of the group.

James will schedule a discussion with the Data Subcommittee and invite the full Commission to discuss vision.
