II. Call to Order: The meeting was called to order at 1:02 p.m. by Debbie Condino.

III. Approval of agenda and minutes

- **Motion to approve agenda and minutes (Reece, Domeier). Approved.**

IV. Old Business

- Protocol Status – Krisy Kuhl
 - Krisy provided an update. There are 15 that will be released in the next couple weeks. There are three still need to go QATF. The medications are expected to be released by the end of the month.
 - Dr. Domeier asked about MI MEDIC. The state office is meeting on this on 4/5/2023. They will be updated. Dr. Bigsby asked about an app. Emily said they did meet with companies, but the price tag is too high.
 - Bob Miljan brought up issues about the MI MEDIC not being ready when the protocols are ready. Emily Bergquist advised they are planning to be updated in time.
 - Dr. Bigsby asked how many sections haven't been released. Krisy addressed.
 - All sections will be released at the same time. That is when the six months start.

- MCA Assessment Update – Krisy Kuhl
 - Survey goes live 4/4/2023. Later today, an email will go out with the link and explanation for phase one of the survey. This will be returned to MPH, and they will send out phase two. Krisy described the survey, and the information sheet will go out. Phase one will be due May 1st.
 - Accountability was discussed.
- Patient Movement Ad Hoc
 - The first meeting is scheduled for 4/24/2023. Fourteen members were appointed by Dr. Edwards. The members come from a wide variety of backgrounds and from across the state. The meetings will be conducted as an open meeting. Definitions will be worked through. Members are to represent their roles in the system, rather than specific employers.
- Medical Director Requirements
 - Dr. Reece discussed. There has been a lot of work behind the scenes to develop a proposal. The MCEP EMS Committee wanted to have rural MCA input, so Dr. Reece has emailed the proposal to those MCAs and provided a deadline prior to the next MCEP EMS Committee. This is still in process.

V. Any other issues

- The MCA (Systems of Care) Conference was discussed. Emily said this will be a transitional conference. This conference has not been divided into MCA vs. SoC as the subject matter is applicable to both sections. Next conference may need to be 3 days.
- The legislation regarding a state test has been introduced and will be read in next week.
