Postpartum Extension from 60 Days to 12 Months State Plan Amendment Request

The Michigan Department of Health and Human Services (MDHHS) plans to submit a State Plan Amendment (SPA) request to the Centers for Medicare & Medicaid Services (CMS) to extend current postpartum coverage for qualified pregnant women from 60 days to 12 months.

The anticipated effective date for the postpartum extension SPA is April 1, 2022.

In compliance with 42 CFR § 440.345, individuals under 21 years of age receiving Medicaid benefits will continue to have access to services within the full early and periodic screening, diagnosis and treatment (EPSDT) benefit as defined in Section 1905(r) of the Social Security Act.

The estimated gross cost to the State of Michigan for the State Plan Amendment is \$5.1 million gross with 1.4 million from GF/GP annually.

Dear Tribal Chair and Health Director:

**RE:** Postpartum Extension from 60 days to 12 months

This letter, in compliance with Section 1902(a)(73) and Section 2107(e)(1)(C) of the Social Security Act, serves as notice to all Tribal Chairs and Health Directors of the intent by the Michigan Department of Health and Human Services (MDHHS) to submit a State Plan Amendment (SPA) request to the Centers for Medicare & Medicaid Services (CMS).

The purpose of this SPA is to extend the current postpartum coverage for qualified pregnant women from 60 days to 12 months. This change would have a positive impact on Native American beneficiaries, tribal healthy clinics, and urban Indian organization by allowing 12 months of continuous postpartum coverage to qualified pregnant women. The anticipated effective date of this SPA is April 1, 2022.

In an effort to submit this State Plan Amendment to CMS as soon as possible in order to meet an April 1, 2022, implementation date, we are providing an update to L 21-81 indicating that the Tribal Notice period will be shorter than the normal 60 day notice period with responses requested prior to March 1, 2022. There is no public hearing scheduled for this SPA. Input regarding this SPA is encouraged, and comments regarding this notice of intent may be submitted to Lorna Elliott-Egan, MDHHS Liaison to the Michigan tribes. In addition, MDHHS is offering to set up group or individual consultation meetings to discuss this SPA, according to the tribes' preference. Consultation meetings allow tribes the opportunity to address any concerns and voice any suggestions, revisions, or objections to be relayed to the author of the proposal. Aanii all –

A tribal notice was originally issued to Tribal Leaders and Tribal Health Directors on Feb 2, 2022 for Postpartum Extension from 60 days to 12 months. That notice was then reissued on Feb 22, 2022 with some additional language. We felt that because of the quick turn around that was requested from tribes in the updated L 21-81 letter that an additional email from me would help call your attention to the accelerated schedule we have set for the proposed State Plan Amendment (SPA). This policy change will affect qualified pregnant individuals by extending the current 60 days of postpartum coverage to 12 months of postpartum coverage effective April 1, 2022. This change will be accomplished through a SPA and have a positive impact to Native American beneficiaries, tribal health clinics and urban Indian organizations. There is no change to the existing eligibility criteria or covered services. This policy simply changes the duration of postpartum coverage from 60 days to 12 months.

In an effort to get this SPA submitted to CMS as soon as possible to meet the proposed April 1, 2022 implementation date, we are providing an update to the L 21-81 notification you received to indicate that the Tribal Notice period will be shorter than the normal 60 day response period and are requesting that any questions or concerns regarding the proposed SPA language be submitted to MDHHS **not later than March 1, 2022.**
