## REQUESTING A MICHIGAN DIVORCE RECORD

The Michigan Vital Records Office has records of divorces that occurred in Michigan and were **filed** with the state since **1897**. Some records were not filed with the state. Divorce records are not restricted documents in Michigan. Anyone can request that a search be conducted if the application is completed, signed, and submitted with the required fee paid. **NOTE:** The State of Michigan will only have the record of divorce. If you need the actual judgement, contact the county where divorce occurred.

## PROCESSING TIMES FOR MAILED REQUESTS

#### REGULAR SEARCH

Approximately 4 to 6 weeks of in-office processing at MDHHS, plus an additional 1 to 2 weeks at the Secretary of State's Office of the Great Seal. Then sent via regular mail. Completion time may vary, depending on volume of requests received.

### **EXPEDITED "RUSH" SEARCH**

Approximately 2 to 3 weeks of in-office processing at MDHHS, plus an additional 1 to 2 weeks at the Secretary of State's Office of the Great Seal. Then sent via regular mail.
