

## Recognizing Symptoms

Nerve agent symptoms:

### SLUDGEM

Salivation Lacrimation (tears) Urination Defecation/Diarrhea GI Upset (cramps)

Emesis (vomiting)

### DUMBELS

Diarrhea Urination Miosis (pupil constriction) Bradycardia Bronchorrhea Bronchospasm Emesis Lacrimation Salivation Sweating Secretion

# RESOURCES

For EMS, Healthcare, Local Health Jurisdictions and Other Emergency Responders

The MEDDRUN (Michigan Emergency Drug Delivery and Resource Utilization Network) and CHEMPACK programs are designed to supplement local and regional pharmaceutical and medical supplies in the event of a chemical, biological, or other emergency resulting in mass casualties.

MEDDRUN and CHEMPACK are supportive medical assets pre-deployed strategically throughout the state to ensure a rapid delivery by air and/or ground EMS during an emergency.





MEDDRUN caches, called MedPacks, are state resources that contain antibiotics, chemical antidotes, and other pharmacologic countermeasures; critical medical supplies; and personal protection equipment, such as N-95 respirators and gloves.

MEDDRUN can be used to treat:

- exposure to cyanide, nerve agents
- organophosphate pesticides
- toxic industrial chemicals
- biological incident, such as anthrax and plague

FEMPACK

The CHEMPACK is a federal resource, pre-positioned within the State of Michigan that contains nerve agent antidotes and anticonvulsants. The CHEMPACK does not contain medical countermeasures to treat patients with other chemical exposures.

CHEMPACK can be used to treat:

 nerve agents and organophosphate exposures during a large-scale incident

# ACTIVATION

When local resources need to be strengthened during a response, the responding organization can request MEDDRUN and/or CHEMPACK resources by contacting the MEDDRUN CHEMPACK Dispatch Center. The request can be made by the incident commander (or designee), key hospital personnel, EMS, emergency management, and state/local public health officials.

STEP


The responding organization determines there is a need for additional resources.

A lead representative from the responding agency contacts the MEDDRUN/CHEMPACK Communications Agency to request the MEDDRUN and/or CHEMPACK resources.
