SUBJECT: Heart-to-Heart Information Updates

Media coverage of Hurricane Katrina led many of us to wonder about fellow families of children with special needs. *Family Voices* reports a federal count of more than 900,000 children with special needs living in the four affected states. In response, *Family Voices* asks for donations to its *Families Helping Families Relief Fund* at 1-888-835-5669 or www.familyvoices.org.

In Michigan, CSHCS offices in local health departments are able to expedite CSHCS enrollment for evacuees. A person *may* be found eligible without medical reports. Details were e-mailed by CSHCS to local health departments.

The tragedy also is a grim reminder of the importance of emergency plans. An *Emergency Information Form for Children with Special Needs*, in both a pdf and interactive version, is online at http://www.aap.org/advocacy/emergprep.htm. The *American Academy of Pediatrics* and the *American College of Emergency Physicians* jointly created it.♥

PPP Update

"We often hear that our children don't get many birthday party invitations," said Randy Krause, Family Support Network of Michigan (FSN) coordinator. "So, we're having one Big Birthday Party for children with special needs and others in Chippewa County."

Randy is available to help FSN volunteers replicate the idea across the state. FSN is the parent-to-parent support arm of PPP.

"It's easy," she said. "You set a date, place and time, and everyone buys their child's own present (with dollar limits). We coordinated mailing to parents through the local health department and our ISD."

The **Big Birthday Party** in Sault Ste. Marie takes place **Nov. 12.** Advance registration is required. Families may reach Randy on the CSHCS Family Phone Line at 1-800-359-3722. ♥

CSHCS Update

CSHCS members who have private insurance with a mandatory mail-order pharmacy benefit have new rules. Details of the new rules are in an August letter CSHCS sent to members.

In short, CSHCS will pay the co-pay for eligible mailorder drugs. Mail-order pharmacies must bill the CSHCS co-pay to 4D Pharmacy Management Systems, Inc. To resolve a bill or other problem with a CSHCS mailorder co-pay, families may phone 4D toll-free at 1-888-274-2031. Help also is available from the CSHCS office in local health departments. ♥

Youth with special needs have loads of concerns about moving into the adult health care system. Thirty-eight of them from across Michigan shared their views in CSHCS discussion groups in June, July and September. Among issues, they want more information about moving from their parents' to their own insurance, how to talk with doctors, and how health care coverage works.
